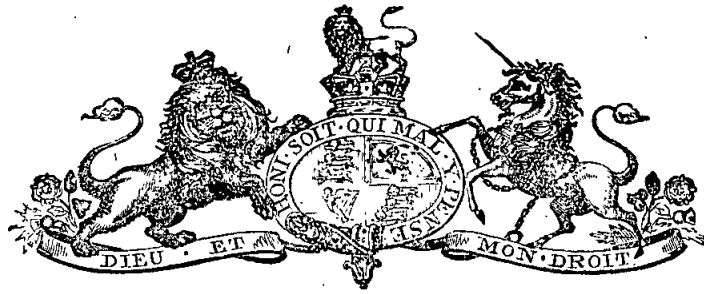

PROCLAMATION

By His Excellency the Honorable Sir Arthur Lyulph Stanley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

IN pursuance of the provisions contained in Part VI. of the Public Service Act 1915 (6 Geo. V. No. 2713), I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays at the places specified, viz.:—

Public Holidays:—

SATURDAY, THE 31ST DAY OF MAY, 1919, throughout the borough of Sale and the shire of Maffra;

FRIDAY, THE 13TH DAY OF JUNE, 1919, throughout the shire of Lillydale;

WEDNESDAY, THE 16TH DAY OF JULY, 1919, throughout the North-Western Riding of the shire of Lillydale.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this fourth day of June, in the year of our Lord One thousand, nine hundred and nineteen, and in the tenth year of the reign of His Majesty King George V.
