By His Excellency the Honorable Sir William Hill Irvine, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

IN pursuance of the provisions contained in Part VII. of the *Public Service Act 1915* (6 Geo. V. No. 2713), I, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation appoint the days and dates hereunder mentioned to be observed as Public Holidays and Public Half-Holidays respectively at the places specified, viz.:—

FRIDAY, THE 23RD DAY OF JULY, 1920; throughout the Korong Vale District, in the shire of Korong;

WEDNESDAY, THE 14TH, AND THURSDAY, THE 15TH DAYS OF JULY, 1920, throughout the city of Bendigo*.

REGULATIONS FOR THE CARE, PROTECTION, AND MANAGEMENT OF THE RESERVE FOR PUBLIC RECREATION IN THE TOWNSHIP OF KANEIRA (NOW KNOWN AS CULGOA).

WE, C. E. Fanning, Wm. Bain, E. J. Hooper, D. R. Currie, Alex. Walsh, James Spry, and W. A. Fanning, the duly appointed Committee of Management of the Reserve for Public Recreation in the township of Kaneira (now known as Culgoa), having framed the following regulations for the care, protection, and management thereof, and for the preservation of good order and decency therein, and also for the collection and receipt of tolls, entrance fees, and other charges for entering therein or thereupon, submit the said regulations to the Board of Land and Works to be made by such Board in pursuance of the powers conferred by section 181 of the *Land Act 1915*.

REGULATIONS.

1. The Reserve shall be open to the public from sunrise to sunset, free of charge, except on such days (not exceeding twelve in any one year), as the Reserve may be set apart for cricket or football matches, fêtes, sports, or holiday amusements, on any of which occasions a sum not exceeding One shilling may be charged and taken for the admission of every adult to the Reserve.
2. No person shall enter or remain in the Reserve who may offend against decency as regards dress, language, or conduct.
3. No person shall damage in any way the trees, shrubs, or flowers in the Reserve. Nor shall fires be lighted therein without the permission, in writing, of the Committee of Management.
4. No person shall climb or jump over the gates or fences in or around the Reserve, or any way damage or injure any of the buildings, gates, fences, or seats in the Reserve, nor leave or deposit any glass, paper, or rubbish, nor throw stones or any missiles of any kind therein.
5. No person shall put in the Reserve any cattle, horses, sheep, or other animals without the permission of the Committee of Management first obtained: Provided always that the moneys received for agistment shall be expended in the maintenance and improvement of the Reserve, and that an account shall be furnished annually to the Board of Land and Works.
6. No person shall bring into the Reserve any dog, unless led by a chain or cord, without the permission of the Committee of Management first obtained.

7. No person shall camp in the Reserve, nor erect any dwelling, nor any booth, or other structure without the permission, in writing, of the Committee of Management first obtained.

8. No person shall take part in any public entertainment of any sort in the Reserve without the permission, in writing, of the Committee of Management first obtained.

9. No person shall spit or expectorate on any structure or erection in the Reserve.

10. No person shall bet publicly in any part of the Reserve, and every person infringing this regulation shall be liable to expulsion from the Reserve.

11. No person shall play, practice, or engage in any game or sport within the Reserve on Sundays.

12. Persons renting or hiring any stands, buildings, or enclosure on the occasion of any sports or holiday amusements may be required to deposit any sum which the Committee of Management may at any time determine not exceeding Ten pounds, by way of guarantee that due care shall be taken of such stands, buildings, and such Committee, in its absolute discretion, may make good any damage, sustained by such stand, building, or enclosure, or anything contained therein, during such occupation or hiring, and deduct the cost of making good such loss or damage from the sum of money deposited by way of guarantee, and all persons so renting or hiring shall abide by these regulations and by any order given by the Committee of Management.

13. No person except labourers and workmen employed in the Reserve shall enter any plots therein which may be enclosed for plantations of young trees or shrubs. Every person offending against these regulations shall, in accordance with the provisions of section 181 of the *Land Act 1915*, for each offence be liable to a penalty of not more than (£5) Five pounds, and every person who knowingly and wilfully offences against any such regulations, and who after he has been warned by any bailiff of Crown lands, or by any member of the police force does not desist from so offending, may be forthwith apprehended by such bailiff or member of the police force and taken before some justice, and shall be liable to a penalty of not more than Ten pounds (£10).
