Factories and Shops Acts.

DETERMINATION OF THE SHOPS BOARD No. 16 (HARDWARE).

Note.—(a) This Determination on the 18th July, 1921, applied to the following parts of Victoria, namely:—The Metropolitan. District as defined in the Factories and Shops Acts; the cities of Ballarat, Bendigo, Geelong, and Warmambool; the town of Sandringham; and the boroughs of Eaglehawk, Geelong West, Newtown and Chiwell, and Sebastopol.

(b) By Order in Council, dated the 28th September, 1920, the power to "determine prices or rates for Storemen, Packers, and Sorters" was taken away from this Board, and conferred exclusively on the Storemen, Packers, and Sorters Board.

IN accordance with the provisions of the Factories and Shops Acts, the Wages Board appointed to "determine the lowest prices or rates which may be paid to any person or persons or classes of persons wheresoever employed in the business of a seller of goods usually sold by ironmongers, including—

(a) furnishing household, plumbers', or builders' ironmongery;
(b) gas fittings, stoves, or tools;
(being a business usually or frequently carried on in a shop)," and whose powers were, by Order in Council, dated 1st June, 1920, extended so that it may "fix the lowest prices or rates which may be paid to any person wheresoever employed in the business of a seller of hardware—wholesale or retail"—has made the following Determination, namely:—

(1) That on the 18th July, 1921, the previous Determination of this Board shall be revoked and replaced by this Determination.

(3) OVERTIME.—Any employee who in any week works for any time in excess of 48 hours shall be paid for such extra time at the of time and a half.

(4) CASUAL LABOUR.—Casual employees (i.e., persons employed during any week for not more than 24 hours) shall be paid at the

(4) CASUAL LABOUR.—Casual employees (i.e., persons employed during any week for not more than 24 hours) shall be paid at the rate of time and a half.

(5) SPECIAL RATES.—Time and a half shall be the rate payable for all work done on Sunday, New Year's Day, 26th January (Foundation Day), Good Friday, Easter Monday, 21st April (Eight Hours Day), 3rd June (King's Birthday), Christmas Day, or Boxing Day; but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall be payable only for work done on the day so substituted.

Definitions.

(6) "Departmental manager" shall mean a person having the control of two or more salesmen, 25 years of age or over notwithstanding he may be under the orders of a general manager.

"Branch manager" shall mean a person for the time being intrusted with the control or superintendence of a branch shop (the proprietor of which is trading under his own or a different name), notwithstanding such manager may be under the orders of a superior who does not devote the whole of his time to the management of the said branch shop.

"Outside salesman" shall mean an employee who regularly solicits or receives orders for goods while absent from the shop where he is employed, whether such goods are kept in stock or have to be procured in order to fulfil such orders.
