Factories and Shops Acts.

DETERMINATION OF WATCHMEN'S BOARD.

Note.—(a) This Determination on the 6th August, 1921, applied to the following parts of Victoria, namely:—The Metropolitan District as defined in the Factories and Shops Acts; the cities of Ballarat, Bendigo, Geelong, and Warrnambool; the town of Sandringham; and the boroughs of Eaglehawk, Geelong West, Newtown and Chilwell, and Sebastopol.

(b) Section 217 of the Factories and Shops Act 1915 provides that "any person employed as a watchman shall be granted one holiday in every week."

IN accordance with the provisions of the Factories and Shops Acts, the Wages Board appointed in lieu of the Nightwatchmen's Board to "determine the lowest prices or rates which may be paid to any person or persons or classes of persons employed in the occupation of a watchman," has made the following Determination, namely:—

(1) That this Determination shall be operative on and after the 6th August, 1921.

One apprentice and one improver to every three or fraction of three workers receiving not less than 96s. 3d. per week of 60 hours.

(3) OVERTIME.—Any time worked in excess of 60 hours shall be paid for at the rate of time and a half.

(4) Casual Labour.—Casual employés, i.e., persons employed during any week for not more than 30 hours, shall be paid at the rate of time and a half.

(5) Special Rates.—Time and a half shall be the special rate for all work done on New Year's Day, 26th January (Foundation Day), Good Friday, Easter Monday, Eight Hours Day (21st April), King's Birthday. Christmas Day, and Boxing Day; but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall only be payable for work done on the day so substituted.
