## PROCLAMATION

By His Excellency the Honorable Sir William Hill Irvine, Knight Commander of the Most Distinguished Order of St.

Michael and St. George; Lieutenant-Governor of the State of Victoria and its Dependencies in the

Commonwealth of Australia, &c., &c., &c.

WHEREAS The Parliament of Victoria stands prorogued until Tuesday, the twenty-ninth day of May, 1923:

Now I, the Lieutenant-Governor of the State of Victoria in the Commonwealth of Australia, do
by this my Proclamation, further prorogue the said Parliament of Victoria until Tuesday, the twenty-sixth day of June,
1923.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this twenty-fifth day of May, in the year of our Lord One thousand nine hundred and twenty-three, and in the fourteenth year of the reign of His Majesty King George V.

THE ROYAL ASSENT TO A RESERVED BILL ENTITLED
"AN ACT TO DECLARE THAT CERTAIN ENACTMENTS OF THE PARLIAMENT OF ENGLAND AND OF
THE PARLIAMENT OF GREAT BRITAIN AND OF
THE PARLIAMENT OF THE UNITED KINGDOM OF
GREAT BRITAIN AND IRELAND IN FORCE AT THE
TIME OF THE PASSING OF THE ACT 9 GEORGE
IV. C. LXXIII. SHALL NOT APPLY IN VICTORIA
AND TO TRANSCRIBE OR CONSOLIDATE OTHER
ENACTMENTS OF SUCH PARLIAMENTS AND FOR
OTHER PURPOSES."

### PROCLAMATION

By His Excellency the Honorable Sir William Hill Irvine, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George; Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

THE Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, in pursuance of provisions contained in An Act for the Government of New South Wales and Van Diemen's Land (5 and 6 Vict. c. 76), also in An Act for the better Government of Her Majesty's Australian Colonies (13 and 14 Vict. c. 59), and in The Constitution Act, and in the Australian States Constitution Act 1907 (7. Edw. VII. c. 7), do by this my Proclamation signify that the Bill. the title whereof is herein set forth, that is to say:—

"An Act to declare that certain Enactments of the Parliament of England and of the Parliament of Great Britain and of the Parliament of the United Kingdom of Great Britain and Ireland in force at the time of the passing of the Act 9 George IV. c. LXXXIII. shall not apply in Victoria and to transcribe or consolidate other Enactments of such Parliaments and for other purposes"

which was reserved for the signification of His Majesty's pleasure thereon, has been laid before His Majesty in Council, and that by an Order in Council made at the Court at Buckingham Palace, and bearing date the twelfth day of March, One thousand nine hundred and twenty-three, a copy whereof is hereto appended, His Majesty has been pleased to assent to the same.

Given under my Hand and the Seal of the State of Victoria, at Melbourne, this twenty-fifth day of May, in the year of our Lord, One thousand nine hundred and twenty-three, and in the fourteenth year of the reign of His Majesty King George V.
