DETERMINATION OF THE FARRIERS BOARD.

Note.-This Determination on the 9th day of October, 1924, applied to the whole of the State of Victoria.

N accordance with the provisions of the Factories and Shops Acts, the Wages Board appointed to "determine the lowest prices or rates which may be paid to any person or persons, or classes of persons, employed in the process, trade, or business of a farrier," has made the following Determination, namely:—

(1) That on the 9th day of October, 1924, the last previous Determination of this Board shall be revoked and replaced by this Determination.

4.30 p.m. on Fridays 6.30 a.m. 6.30 a.m. 6.30 a.m. (4) OVERTIME.—The following rates shall be paid for all work done:— (A) Within the Metropolitan District, as defined in the Factories and Shops Acts, and the City of Sandringham :-(1) Outside the times of beginning and ending work:-(i) On Saturdays-

Double time. Between 8.30 a.m. and 9.30 a.m. Later than 9.30 a.m. or earlier than 6.30 a.m. ..

(ii) On Mondays, Tuesdays, Wednesdays, and Thursdays-Between 5 p.m. and 6 p.m. ... Later than 6 p.m. or earlier than 6.30 a.m. Double time. Treble time.

(iii) On Fridays-Double time. Between 4.30 p.m. and 5.30 p.m.

Later than 5.30 p.m. or earlier than 6.30 a.m.

(2) Within the hours fixed as the times of beginning and ending work in excess of 44 hours in any week

(B) In any other place :-

In excess of 44 hours in any week ...

(5) SPECIAL RATES.—Treble time shall be the special rate for all work done on Sunday, 26th January (Foundation Day), Good Friday, Easter Monday, 21st April (Eight Hours Day), 3rd June (King's Birthday), Christmas Day, Boxing Day, and Now Year's Day, but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall only be payable for work done on the day so substituted.

(6) DAY AND LATEST HOURS FOR PAYMENT OF WAGES.—The day and latest hour when payment of wages is to be made shall be Friday at 4.30 p.m. (7) TIME WAGES.—Any person employed on time wages for less than the number of hours fixed for an ordinary week's work shall for each hour worked up to 22 hours be paid at the ordinary wages rate with an addition of forty-two per centum.

DETERMINATION OF THE GLAZED POTTERY (COUNTRY) BOARD.

Note.—This Determination on 3rd October, 1924, applied to the whole of the State OUTSIDE AND EXCEPTING the following parts of Victoria, namely:—The Metropolitan District as defined in the Factories and Shope Acts; the cities of Ballarat. Bendigo, Geelong, Sandringham and Warrnambool; the towns of Geelong West and Newtown and Chilwell; and the Boroughs of Eagle-bark and Salvastonel. hawk and Sebastopol. ,

IN accordance with the provisions of the Factories and Shops Acts, the Wages Board appointed to "determine the lowest prices or rates which may be paid to any persons employed in the trade of making glazed pipes or glazed pottery (except tiles) and digging the clay used in connexion therewith," has made the following Determination, namely:—

(1) That on the 3rd October, 1924, the last previous Determination of this Board shall be revoked and replaced by this

(3) OVERTIME.—Any employee who works in excess of 48 hours in any week shall be paid for such extra time at the rate of time

and a quarter.

(4) Time Rate.—Any person employed on time wages for less than the number of hours fixed for an ordinary week's work shall for each hour worked up to 24 hours be paid at the ordinary wages rate with an addition of thirty-three per centum.

(5) Special Rates.—Double time shall be the special rate payable to all persons except burners for all work done on the following days, namely:—Sunday, New Year's Day, Good Friday, Easter Monday, Christmas Day, or Boxing Day; but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall only be payable for work done on the

PIECE-WORK.

(6) The Board determines under the provisions of Section 144 of the Factories and Shops Act 1915 that any employer may fix and pay piece-work prices to any person employed in the glazed pipe and salt-glazed ware and in the general pottery sections of the trade, provided that any such employer shall base such piece-work prices on the earnings of an average worker working under like conditions, and such piece-work prices shall be fixed so that an average worker can earn not less than the wages rates that are fixed by the Board for such work.
