Factories and Shops Acts.

DETERMINATION OF THE DENTAL MECHANICS BOARD.

This Determination on the 1st July, 1925, applied to the following parts of Victoria, namely:—The Metropolitan District as defined in the Factories and Shops Acts; the cities of Ballarat, Bendigo, Geelong, Sandringham, and Warrnambool; the towns of Geelong West and Newtown and Chilwell; and the boroughs of Eaglehawk and Sebastopol.

IN accordance with the provisions of the Factories and Shops Acts, the Wages Board which since the 5th November, 1924, has had the power "to determine the lowest prices or rates which may be paid to any persons employed in the trade of—

(a) a Dentist's Mechanic;
(b) making any article to be fitted in the human mouth;
(c) a Dentist's Attendant";

has made the following determination, namely :-

(1) That on the 1st July, 1925, the last previous Determination of this Board shall be revoked and replaced by this Determination.

PROPORTION (IN ANY PLACE.) APPRENTICES. One apprentice to every three or fraction of three workers receiving not less than the minimum wage. An indenture of apprenticeship prescribed was approved on 7th September, 1923. IMPROVERS. One improver to every ten or fraction of ten workers of the same sex receiving not less than the minimum wage.		

(3) Times of Beginning and Ending Work:-

For the following persons shall be :-

(4) That the following rate shall be paid for all work done:-

(a) Outside the hours fixed in Clause (3)
(b) Within the hours fixed in Clause (3) in excess of 42 hours in any week

Time and a half.

(5) CASUAL LABOUR.—Casual employees (i.e., persons employed during any week for not more than 21 hours) shall be paid at the rate of time and a quarter.

OVERTIME.

(6) SPECIAL RATES.—That double time shall be the special rate for all work done on Sunday, and time and a half shall be the rate for all work done on 26th January (Foundation Day), Good Friday, Easter Saturday, Easter Monday, 21st April (Eight Hours Day), King's Birthday, Christmas Day, Boxing Day, New Year's Day; but, if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall only be payable for work done on the day so substituted.
