Factories and Shops Act.

DETERMINATION OF THE BUILDERS' LABOURERS BOARD.

NOTE.—This Determination applied on the 8th October, 1926, to the whole State.

N accordance with the provisions of the Factories and Shops Acts, the Wages Board appointed to "determine the lowest prices or rates which may be paid to any person or persons or classes of persons (other than persons subject to the Determination of the Carpenters Board or the Plumbers Board) employed in the occupation of builders' labourer engaged in the erection, repair, or demolition of buildings," has made the following Determination, viz.:—

(1) That on the 8th October, 1926, the Determination of the Court of Industrial Appeals, dated the 1st day of February, 1919, and previous Determinations, shall be revoked and replaced by this Determination.

- (4) OVERTIME.—That the following rates shall be paid for all work done:-
 - Time and a half for the first two hours and thereafter double time. time. in any week
- (5) ALLOWANCES.—The following allowances shall be paid to persons employed on work away from their employers' place of business
 - (1) The fares, exceeding 3d. per day, necessarily expended in going from and to the employee's residence to and from his work;
 - (2) For work done away from the employer's place of business on any job distant more than 20 miles by the readiest mode of conveyance from the employee's residence—
 - (a) If employee returns to his home on completion of the day's work, 3d. per hour.
 - (b) If work renders it reasonably necessary for the employee to sleep at another place than his usual place of residence— 2s. per day for seven days.

(6) SUNDAYS AND PUBLIC HOLIDAYS.—Double time shall be the special rate payable to any person tor all work done on Sundays, 26th January (Foundation Day), Good Friday, Easter Monday, 21st April (Eight Hours Day), Christmas Day, Boxing Day, New Year's Day; but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rate shall only be payable for work done on the day so substituted.
