Factories and Shops Acts.

DETERMINATION OF THE FARRIERS BOARD.

Note.—This Determination on the 16th June, 1928, applied to the following parts of Victoria, namely:—The Metropolitan district as defined in the Factories and Shops Acts; the cities of Ballarat, Bendigo, Geelong, Sandringham, and Warrnambool; the towns of Geelong West and Newtown and Chilwell; and the boroughs of Eaglehawk and Sebastopol.

IN accordance with the provisions of the Factories and Shops Acts, the Wages Board appointed to "determine the lowest prices or rates which may be paid to any persons, or classes of persons, employed in the process, trade, or business of a farrier," has made the following Determination, namely:---

(1) That on the 16th day of June, 1928, the last provious Determination of this Board shall be revoked and replaced by this Determination.

(3) Times of Beginning and Ending Work within the Metropolitan District, as defined in the Factories and Shops Acts:

Time of Ending. Time of Beginning. 8.30 a.m. on Saturdays 6.30 a.m. 5 p.m. on Mondays, Tuesdays, Wednesdays, and Thursdays
4.30 p.m. on Fridays 6.30 a.m. 6.30 a.m.

(4) OVERTIME.—The following rates shall be paid for all work done:-

(A) Within the Metropolitan District, as defined in the Factories and Shops Acts:—

In excess of 44 hours in any week ...

(1) Outside the times of beginning and ending	work:					
(i) On Saturdays— Between 8.30 s.m. and 11 s.m.			••	••		Double time.
(ii) On Fridays— Between 4.30 p.m. and 5 p.m.		••		••		Double time.
(2) Within the hours fixed as the times of hours in any week	beginning as	nd ending	work in	excess of	44	Double time.
(B) In any other place:—						

- (5) SPECIAL RATES.—Treble time shall be the special rate for all work done on Sunday, 26th January (Foundation Day), Good Friday, Easter Monday, 21st April (Eight Hours Day), 3rd June (King's Birthday), Royal Agricultural Show Day, Christmas Day, Boxing Day, and New Year's Day, but if any other day be by Act of Parliament or Proclamation substituted for any of the abovenamed holidays, the special rate shall only be payable for work done on the day so substituted.
- (6) DAY AND LATEST HOURS FOR PAYMENT OF WAGES.—The day and latest hour when payment of wages is to be made shall be Friday at 4.30 p.m.
- (7) TIME WAGES.—Any person employed on time wages for less than the number of hours fixed for an ordinary week's work shall for each hour worked up to 22 hours be paid at the ordinary wages rate with an addition of forty-two per centum.
