Factories and Shops Act 1928 (No. 3677).

DETERMINATION OF THE FARRIERS (COUNTRY) BOARD.

Note.—This Determination on the 20th day of June, 1931, applied to the whole of the State Ourside and Excepting the following parts of Victoria, namely:—The Metropolitan District as defined in the Factories and Shops Act 1928 (No. 3677) and the Order in Council thereunder, and such portions of the city of Sandringham as are not included in the said District; the cities of Ballarat, Bendigo, Geelong, Geelong West, and Warrnambool; the town of Newtown and Chilwell; and the boroughs of Eaglehawk and Sebastopol.

IN accordance with the provisions of the Factories and Shops Act 1928 (No. 3677), the Wages Board appointed to "determine the lowest prices or rates which may be paid to any persons employed in the trade of a farrier," has made the following Determination, namely:—

(1) That this Determination shall come into force on the 20th day of June, 1931.
