## Health Acts.

**REGULATIONS RELATING TO PLUMBERS AND GASFITTERS.**

*At the Executive Council Chamber, Melbourne, the thirty-first day of March, 1932.*

## PRESENT:

His Excellency the Lieutenant-Governor of Victoria.

Mr. Tunnecliffe

Mr. Lemmon.

**U**NDER the powers conferred by the Health Acts and all other powers enabling him in that behalf, His Excellency the Lieutenant-Governor of the State of Victoria, with the advice of the Executive Council of the said State, doth hereby make the Regulations following (that is to say):—

1. These Regulations may be cited as the Plumbers and Gasfitters Regulations 1932, and shall come into operation on the second day of May, 1932.

2. All Regulations heretofore made relating to matters herein are hereby repealed.

3. In these Regulations unless inconsistent with the context or subject-matter—

“Commission” means the Commission of Public Health constituted under the *Health Act 1928*.

“Gas supply area” means the area within which gas is supplied for public use by any municipal council or by any legally constituted gas company.

“Sewerage authority” means any sewerage authority within the meaning of the *Sewerage Districts Act 1928*, the Melbourne and Metropolitan Board of Works, and the Geelong Waterworks and Sewerage Trust.

“Sewerage district” means—

(a) in the case of a sewerage authority within the meaning of the *Sewerage Districts Act 1928*, the sewerage district of such authority;

(b) in the case of the Melbourne and Metropolitan Board of Works, the “metropolis” as defined by or under section three of the *Melbourne and Metropolitan Board of Works Act 1928*; and

(c) in the case of the Geelong Waterworks and Sewerage Trust, the drainage area of the said trust as constituted pursuant to the provisions of section fifty-six of the *Geelong Waterworks and Sewerage Act 1928*.

“Minister” means the Minister of Public Health and includes any Minister for the time being acting for or on behalf of the Minister.

4. No person unless registered with the Commission shall engage in or undertake any work—

(a) as a plumber in any city town or borough or in any sewerage district; or

(b) as a gasfitter in any city town or borough or in any gas supply area.

5. The following persons shall be entitled to registration:—

(a) All persons who hold a licence or certificate of competency as a plumber and/or gasfitter issued by any sewerage authority or by the Apprenticeship Commission or by the Plumbers Examination Board of Victoria.

(b) All persons recommended by the Advisory Board as being competent to engage in or undertake any work as a plumber and/or gasfitter.

6. (1) Every application for registration shall be in Form A of the Schedule hereto;

(2) the Register shall be kept in Form B of the Schedule hereto; and

(3) the Certificate of Registration shall be in Form C of the Schedule hereto.

7. Every certificate of registration issued after these Regulations are in force shall specify the class or classes of plumbing and/or gasfitting which the person to whom the certificate is issued is deemed to be competent to engage in or undertake.

8. The Minister may appoint an Advisory Board to be called the Plumbers and Gasfitters Advisory Board and such Board shall be constituted as follows:—

- (a) Two members nominated by the Master Plumbers Association ;
- (b) two members nominated by the Plumbers and Gasfitters Union ;
- (c) two members representing Sewerage Authorities ;
- (d) one member representing the Gas Companies Association of Victoria ; and
- (e) one member representing the Public Health Department.

9. The functions of the Advisory Board shall be—

- (a) to advise the Commission generally on all matters relating to plumbing and gasfitting ;
- (b) to recommend the registration of persons as being competent to engage in or undertake any work as a plumber and/or gasfitter or any specified kind of work in relation to plumbing or gasfitting ;
- (c) to ascertain by inquiry investigation examination or other appropriate means whether any applicant for registration is competent to engage in or undertake any work as a plumber and/or gasfitter.

## MINT REGULATIONS.

**H**IS Excellency the Lieutenant-Governor, with the advice of the Executive Council, has approved the subjoined Regulations for the receipt and coinage of gold at the Melbourne Branch of the Royal Mint, and has ordered that, on and from the 25th April next, the same shall supersede the Regulations made on the 20th September, 1904.

Gold can be deposited at the Mint, in small or large parcels, subject to the following charges, allowances, and conditions:—

## CHARGES.

1. For a deposit containing 1,000 ounces gross or over, Three halfpence per ounce.
2. For a deposit containing 500 ounces gross or over, and less than 1,000 ounces gross, Twopence per ounce.
3. Less than 500 ounces gross, Threepence per ounce, provided that—

The minimum charge for any one deposit shall be Seven shillings and sixpence.

The above charges will be made on the gross weight before melting.

4. For deposits containing old jewellery or manufactured gold—

- (a) 500 ounces gross or over, Fivepence per ounce.
- (b) Less than 500 ounces, Sevenpence per ounce.

Sixteen shillings shall be the minimum charge for any one deposit.

If a deposit other than old jewellery or manufactured gold contains more than 2 per cent. of base metal, an extra charge, to be fixed by the Deputy Master, will be made for its extraction.

Provided that of these charges One penny per ounce standard shall be considered to be an assay and coinage charge, and that the minimum weight of gold not requiring refining which will be received for assay and coinage will be 250,000 ounces.

## ALLOWANCE.

Any silver in a deposit in excess of eight per cent. of the weight of the deposit after melting will be allowed for at a rate per ounce fine, to be fixed periodically by the Deputy Master.

Provided that this shall not apply to deposits containing old jewellery or manufactured gold, and that for these no silver assay need be made.

## MODE OF PAYMENT.

Deposits weighing in the aggregate 1,000 ounces or over will be paid for, if desired (in even thousands), in coin and the balance by cheque; or in fine gold bars and the balance by cheque. All other deposits will be paid for by cheque. Gold deposits payable wholly by cheque will be due for payment fourteen days after the date of lodgment, and all other deposits on a date to be fixed by the Deputy Master.

N.B.—These arrangements respecting payment will be carried out as far as possible, but the Deputy Master cannot be held responsible for their absolute performance, and shall have power to postpone the date of payment.

Note.—Gold and silver bullion can be obtained at the Mint, to a limited extent, at such price as the Deputy Master may think proper to accept, but in no case shall the price for gold be below £3 17s. 10½d. the ounce standard.
