Victorian Dairy Products Act 1933. CHEESE QUOTA.

I, JOHN ALLAN, Minister for Agriculture in the State of Victoria, hereby determine that manufacturers of dairy products may sell, in the course of their intra-state trade or commerce in Victoria during the period for which this quota is in force, dated from the first day of October, 1934, an amount of dairy products not exceeding, in the case of cheese, 37 per cent. of the cheese manufactured by them during the said period.
