## Marketing of Primary Products Act 1935.

### NOTICE TO PERSONS HOLDING STOCKS OF ONIONS.

IN pursuance of the powers in that behalf conferred on me by section 33 of the *Marketing of Primary Products Act 1935* (No. 4337), I, Edmond John Hogan, Minister of Agriculture in the State of Victoria, do by this notice require all producers of onions in Victoria holding or having in their control on the twenty-second day of April, 1936, any onions, and all other persons in Victoria holding or having in their control on the said date more than one (1) ton of onions, to furnish within ten days from the date of publication of this notice in the *Government Gazette*, to the Secretary of the Onion Marketing Board, 140 Queen-street, Melbourne, a return setting forth the quantity of onions held by or under the control of any of them on the twenty-second day of April, 1936.

Any producer of onions who has entered into any contract for the sale or delivery of any portion of the onions held by him or under his control is also required to furnish within ten days of the publication of this notice, to the Secretary of the Onion Marketing Board, at 140 Queen-street, Melbourne, the following information in respect of each such contract:—

- The person or company with whom such contract has been made.
- The quantity of onions which is the subject of the contract.
- The date on which the contract was made.
- The date and place of delivery specified in the contract.

Any person who fails to comply fully and sufficiently with any of the requirements of this notice, or wilfully furnishes any false or misleading return, shall be guilty of an offence against the *Marketing of Primary Products Act*.
