Wheat Products Prices Act 1938 (No. 4595).

FIXING THE MINIMUM AND MAXIMUM PRICES OF WHEATEN FLOUR AND THE MAXIMUM PRICE OF BREAD.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by section 14 of the *Wheat Products Prices Act 1938* (No. 4595) it is provided that the Governor in Council may from time to time on the recommendation of the Wheat Products Prices Committee by Proclamation fix—

- (a) the minimum price at which any of the substances included in the interpretation of flour may be sold by the manufacturer thereof; and
- (b) the maximum price at which any of the substances included in the interpretation of flour or in the interpretation of wheat products may be sold.

Now therefore I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and on the recommendation of the Wheat Products Prices Committee, do by this my Proclamation hereby fix:—

1. (a) The minimum price at which ordinary wheaten flour may be sold by the manufacturer thereof shall be Eleven pounds (£11) per ton of two thousand pounds on the basis of sales in one hundred and fifty pound bags delivered on buyer's premises at Melbourne.
- (b) The maximum price at which ordinary wheaten flour may be sold shall be Twelve pounds nine shillings and four pence (£12 9s. 4d.) per ton of two thousand pounds on the basis of sales in one hundred and fifty pound bags delivered on buyer's premises at Melbourne.
2. (a) The maximum price for bread delivered to the buyer in the municipalities of Collingwood, Richmond, Fitzroy, Northcote, Preston, Heidelberg, Brunswick, Coburg, Essendon, Melbourne, Hawthorn, Kew, Camberwell and Box Hill at Ten pence half-penny (10½d.) per 4-lb. loaf.

- (b) The maximum price for bread delivered to the buyer in the municipalities of St. Kilda, Prahran, Malvern, Oakleigh, Port Melbourne, South Melbourne, Footscray, Williamstown and that section of Caulfield north of Glenhuntly-road at Eleven pence (11d.) per 4-lb. loaf.
- (c) The maximum price for bread delivered to the buyer in the municipalities of Brighton, Sandringham, Moorabbin, Mordialloc, Chelsea, Dandenong and that section of Caulfield south of Glenhuntly-road at Eleven pence half-penny (11½d.) per 4-lb. loaf.
- (d) The maximum price for bread sold in shops in the municipalities of Collingwood, Richmond, Fitzroy, Northcote, Preston, Heidelberg, Brunswick, Coburg, Essendon and Melbourne at Ten pence (10d.) per 4-lb. loaf.
- (e) The maximum price for bread sold in shops in the municipalities of Hawthorn, Kew, Camberwell, Box Hill, St. Kilda, Prahran, Malvern, Oakleigh, Footscray, Williamstown and that section of Caulfield north of Glenhuntly-road at Ten pence half-penny (10½d.) per 4-lb. loaf.
- (f) The maximum price for bread sold in shops in the municipalities of Port Melbourne, South Melbourne, Brighton, Sandringham, Moorabbin, Mordialloc, Chelsea, Dandenong and that section of Caulfield south of Glenhuntly-road at Eleven pence (11d.) per 4-lb. loaf.

And I do further declare that this Proclamation shall come into force at half-past Twelve o'clock a.m. on Monday the nineteenth day of December 1938.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this fifteenth day of December, in the year of our Lord One thousand nine hundred and thirty-eight and in the third year of the reign of His Majesty King George VI.
