## PUBLIC HIGHWAY .-- SHIRE OF YEA.

### PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the Local Government Act 1928 (No. 3720), section 518, it is amongst other things enacted that it shall be lawful for the Governor in Council at any time, and from time to time, upon the request of the council of any municipality, by notice in the Government Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street, road, highway, thoroughfare, bridge, square, court, alley, or right-of-way to be a public highway, and that such land shall thereupon and thenceforth from the date of such Proclamation become and be absolutely dedicated to the public as a public highway within the meaning of any law then or thereafter in force: And whereas the Council of the Shire of Yea has requested that the land hereinafter mentioned, which has been acquired for road purposes by the said Council within the said shire, be so declared to be a public highway: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this Proclamation declare the land acquired for road purposes hereinafter described, and situated within the Shire of Yea aforesaid, to be a public highway within the meaning of the said Act, viz.:—

### PUBLIC HIGHWAY .- SHIRE OF YEA.

All that piece of land in the Parish of Murrindindi, County of Anglesca, Shire of Yea: Commencing at a point on the western boundary of allotment 9, of section B, of the said parish, 381 links from the south-west corner thereof; thence by a line bearing south 73 deg. 25 min. east 279 links; thence by a line bearing south 6 deg. 33 min. west 261 links to the southern boundary of the said allotment; thence by a line bearing west along part of the said southern boundary 63.2 links; thence by a line bearing north 27 deg. 15 min. west 381 links along the western boundary of the said allotment to the commencing point.


