PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WY HEREAS by the Land Act 1928 it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the Government Gazette, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I.. Division 1, section 5, of the said Land Act 1928, but that the area of lands which may be sold by auction (Class 6) shall not be increased except as in certain cases in the said Act provided: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the Land Act 1928 aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 1, 2, 3, 6, and 7 respectively of the classes mentioned in section 5 of the Land Act 1928 aforesaid to the extent set forth in the subjoined Schedules (that is to say):—

Wheat Products Prices Act 1938 (No. 4595). VARYING PROCLAMATION FIXING THE MAXIMUM PRICE OF BREAD.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

IN pursuance of the powers in that behalf conferred by the Wheat Products Prices Act 1938 (No. 4595), I. the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and on the recommendation of the Wheat Products Prices Committee, do hereby vary the Proclamation made on the twenty-second day of December, 1938, fixing the maximum price at which a four (4) pound loaf of bread may be sold, delivered to the buyer within the localities mentioned in the said Proclamation as follows:—

In place of the following:-

"City of Mildura and the Shire of Mildura—One shilling and one penny halfpenny (1s. 1½d.),"

there shall be substituted the following:-

"City of Mildura-One shilling and one halfpenny (1s. $0\frac{1}{2}d$.).

Shire of Mildura - One shilling and one penny (1s. 1d.)."

And I do further declare that this Proclamation shall come into force at half-past Twelve o'clock a.m. on Thursday, the thirtieth day of July, 1942.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia,

I THE Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of provisions contained in section 17 of the Local Government Act 1928 (No. 3720), and acting on a petition signed by twenty-five (25) ratepayers resident in a portion of the said Shire of Winchelsea, do hereby proclaim as a township, under the name and title of the Township of Lorne, the portion of the said shire as described in the said petition, comprised within the boundaries herein set forth and described, viz.:--

BOUNDARIES OF THE TOWNSHIP OF LORNE.

Boundaries of the Township of Lorne.

Township of Lorne, County of Polwarth, Parish of Lorne: Commencing from a point on the shore of Bass Strait, following the right bank of the Stony Creek in a northwesterly direction to a point in extension of the eastern boundary of allotment 20; thence by a line bearing south 0 deg. 3 min. east to the northern end of the eastern boundary of allotment 20, section 5; thence along the eastern boundary south 0 deg. 3 min. west 20 chains 78 links; thence south 89 deg. 57 min. west 42 chains 35 links; thence across a road 2 chains wide to the northern end of the eastern boundary of allotment 21; thence along such eastern boundary south 24 chains 10 links; thence by a line from such eastern boundary produced due south to a point on the right bank

of the Erskine River; thence by that river upwards to the road forming the east boundary of allotment 24 of section 5; thence by that road bearing south and south-easterly to a point on the right bank of Fishers Creek; thence easterly to southern end of road on boundary of allotment 22 of section 5; thence by a line south to Fishers Creek again; and thence by that creek downwards to the shore of Bass Strait; and thence by the shore line northerly to point of commencement, and being the land coloured red and yellow on the parish plan attached to Correspondence No. L.G.41/817, deposited in the Public Works Department, Melbourne.

PUBLIC HIGHWAY.-TOWN OF NEWTOWN AND CHILWELL.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the Local Government Act 1928 (No. 3720), section 518, it is amongst other things enacted that it shall be lawful for the Governor in Council at any time, and from time to time, upon the request of the council of any municipality, by notice in the Government Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street, road, highway, thoroughfare, bridge, square, court, alley, or right-of-way to be a public highway, and that such land shall thereupon and thenceforth from the date of such Proclamation become and be absolutely dedicated to the public as a public highway within the meaning of any law then or thereafter in force: And whereas the Council of the Town of Newtown and Chilwell has requested that the land hereinafter mentioned, which has been used as a street by the said council within the said city, be so declared to be a public highway: Now therefore 1, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this Proclamation declare the land used as a street hereinafter described, and situated within the Town of Newtown and Chilwell aforesaid, to be a public highway within the meaning of the said Act, viz.:—

PUBLIC HIGHWAY .- TOWN OF NEWTOWN AND CHILWELL. Brunswick-street.

All that piece of land containing 1 rood 24 perches, being part of Crown allotment 3, section 7. Parish of Moorpanyal, County of Grant, and bounded as follows:—By a line commencing at a point on the northern boundary of Crown allotment 3, section 7, north 89 deg. 53 min. west 120 feet (approximately) from the north-eastern corner of the said allotment, and bearing south 0 deg. 1 min. west 631 ft. 1 in. to its intersection with the northern boundary of Retreatroad; thence north 89 deg. 54 min. west along this boundary for a distance of 26 ft. 4 in.; thence north 0 deg. 13 min. west 631 ft. 1 in: thence by portion of the northern boundary of Crown allotment 3, section 7, bearing south 89 deg. 53 min. east for a distance of 28 ft. 11 in. to the commencing point.

HIS Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, and upon the recommendation of the Public Service Board, has, by Orders made on the 3rd day of August, 1942, exempted the officers specified hereunder from the provisions of sections 90 and 91 of the *Public Service Act* 1928 (No. 3757):—

DEPARTMENT OF AGRICULTURE.

RAILWAYS CLASSIFICATION BOARD.

AWARD No. 67 OF 20TH JULY, 1942.

Relating to Variations of Provisions of Award No. 8, and Rates of Pay of Certain Grades.

THE Railways Classification Board, in pursuance of the nowars in that baladi conformed by the provision of the conformed by the conformed

powers in that behalf conferred by the provisions of the Railways Act 1928, hereby determines and awards as follows (that is to sav):

1. That Award No. 8 be varied as set out hereunder:-

DIVISION 2-ORDINARY HOURS OF DUTY.

By inserting the following new clause:-

" (4) Subject to Division 20, no officer or employee during the course of any shift shall be booked off duty for more than half an hour, including time for a meal, between the hours of 10 p.m. and 6 a.m., unless otherwise agreed upon between the Commissioners and the officer or employee concerned."

DIVISION 9-SUNDAY DUTY.

By deleting from clause 1 the words "one-third" and substituting therefor the words "one-half".

DIVISION 10 .-- HOLIDAY DUTY.

"Any officer or employee, including a casual employee working at a daily rate of pay at the time the holiday occurs, who has had the equivalent of one month's service during the preceding six months, and who is required to work on any of the following public holidays, viz:—

New Year's Day. Australia Day. Labour Day, Good Friday Easter Monday, Anzac Day, King's Birthday, Christmas Day, and Boxing Day,

or any day substituted for any of these days by agreement between the Commissioners and the employee concerned, shall be granted one day's leave of absence with pay in respect thereof.

'Pay for one day' has the following meaning:-

- (i) Where to make up the prescribed ordinary hours of duty it is the custom under normal conditions to work a shift of regular length on any day-payment for the number of hours usually worked on such day.

REGULATIONS AMENDING THE OFFENSIVE TRADES REGULATIONS 1939.

NDER the powers conferred by the Health Acts, and all other powers enabling him in that behalf, His Excellency the Governor of the State of Victoria, with the advice of the Executive Council of the said State, doth hereby make the Regulations following (that is to say):—

- 1. These Regulations may be cited as the Amending Offensive Trades Regulations 1942, shall come into force on publication in the Government Gazette, and shall apply and have operation throughout the State of Victoria.
- 2. Part V. of the Offensive Trades Regulations 1939 is hereby repealed and the following substituted therefor:—

PART V.

MARINE STORES IN WHICH IS RECEIVED OR STORED ANY THING OR MATERIAL WHICH IS OR IS LIKELY TO BECOME OFFENSIVE.

RAG-PICKING OR RAG-SORTING.
FLOCK SHODDY OR MUNGO FACTORIES.

- 49. Interpretation-
 - (a) "unused" when referring to rags or clippings or waste material means rags or clippings or waste material which have been obtained from materials which have not been used for the purpose for which they were manufactured or for any other purpose and which have not themselves been used for any purpose;
 - (b) "rags" includes any article of clothing or wearing apparel bed clothes or bed linen which has been used.

Special room required for storage of rage, &c. 50. Every person who carries on the trade of rag-picking or rag-sorting or flock shoddy or mungo making or marine store dealing shall cause all rags or clippings or other articles or materials whatsoever that are received on his premises and which are or are likely to become offensive to be placed immediately in a separate room set apart and used exclusively for such purpose (not being part of any house or other structure used for habitation) and shall cause such rags clippings or other articles or materials to be so stored as to prevent emission of dust or offensive effluvia to the general atmosphere.

Reception of rags from garbage, &c... prohibited.

- 51. No person who carries on the trade of rag-picking or rag-sorting or flock shoddy or mungo making or marine store dealing shall receive store or deliver rags which have been collected from refuse or garbage or from any receptacle or vehicle used for the storage or collection of refuse or garbage, or from any garbage tip.
- 52. Every person who carries on the trade of rag-picking or rag-sorting in addition to the trade of flock shoddy or mungo making shall cause the two classes of trades to be carried on in separate buildings or if carried on in the same building shall cause the portions of the building in which the two classes of trades are carried on to be completely separated from one another by a solid wall having no opening therein.
- 52A. No person who carries on the trade of flock shoddy or mungo making shall cause permit or suffer any rags which are not clean to be brought into or stored or used in any building or portion of a building in which any part of his trade is carried on.

- 52B. (1) Rags shall be deemed not to be clean if-
 - (a) They have not been cleansed by boiling in water for 30 minutes, or by carbonizing; and
 - (b) they contain more than four parts by weight of free and saline ammonia expressed as ammonia (NH₃) or more than 30 parts by weight of chlorine in 100,000 parts by weight of the dry
- (2) The provisions of clause (1) of this Regulation shall not apply to materials which are solely unused rags or clippings or waste material obtained direct from the factory manufacturing or making up such material.
- 53. Every person who carries on the trade of rag-picking or rag-sorting Rags, &c., shall cause all rags and clippings that have been duly washed and cleansed and cleansed to be kept thereafter and until such time as the same shall be taken from to be isolated from unclean from unclean material is excluded.

54. Every person who carries on the trade of rag-picking rag-sorting or Enclosing and flock shoddy or mungo making shall cause the premises wherein any of his ventilation of premises. trade processes are carried on to be properly enclosed and to be properly and sufficiently ventilated in every part.

55. (1) Every person who carries on the trade of rag-picking and Control rag-sorting shall when so required by an authorized officer cause all rag-removal of rag-sorting industrial sorting benches and fixed scythes or similar fixed or other rag-cutting indusappliances in use on his premises to be provided with apparatus for the effectual control of dust arising from rags and with a current of air which wherever possible shall be directed downwards for removing the said dust as nearly as practicable at its origin and in a direction away from all

- (2) Every person who carries on the trade of rag-picking or rag-sorting shall provide for the use of each person employed by him who handles rags which are not clean a sound pair of rubber gloves and either an apron of leather or washable material or washable overalls and shall change each washable apron or suit of overalls for a clean one at least weekly.
- (3) Every person who carries on the trade of flock shoddy or mungo making shall in addition cause every rag-tearing rag-teasing rag-cutting or rag-dusting machine or appliance in use on his premises to be so enclosed in suitable casing so connected by ducts or other appliances communicating with a fan in motion that dust arising from the said operations of tearing teasing cutting or dusting rags shall be effectually controlled collected and removed as nearly as practicable at its origin and in a direction away from all workmen and shall cause such dust to be so disposed of as not to be a nuisance or dangerous to health or offensive.
- 56. Every person who carries on the trade of marine store dealing shall storage and store all bones that are or are likely to become offensive in suitable metal of bones vessels or receptacles furnished with closely fitting covers kept closed and shall cause the same to be removed from the premises at least weekly or more frequently if and as may be required by the Commission or the

REGULATIONS.

N pursuance of the powers conferred by the Dried Fruits Act 1938, His Excellency the Governor of Victoria, by and with the advice of the Executive Council thereof, doth hereby make the following Regulations (that is to say):-

- 1. These Regulations shall be read and construed as one with the Dried Fruits Regulations made on the 10th April, 1940, and shall come into operation upon publication thereof in the Government Gazette.
- 2. The said Regulations, made on the 10th April, 1940, are hereby amended as follows:-
 - (a) Regulation 3 is amended by inserting after the definition of "Dried fruits" therein appearing the following definition :---
 - "'Dried Ohanez grapes' means dried Ohanez grapes produced solely from Ohanez grapes";
 - (b) Form 1 of the forms contained in the First Schedule is amended by inserting immediately below the expression "Lexias" the expression "Dried Ohanez grapes'
 - (c) Form 11 of the forms contained in the First Schedule is amended by inserting after the column headed "Lexias" wherever the same appears, a column containing on the first line the expression "Ohanez grapes" and, on the second line, the expression "tons" or the expression "T.c.q." (as the case may require);
 - (d) Forms 12 and 13 of the forms contained in the First Schedule are amended by inserting after the expression "Lexias —containing" (where such occurs therein) the expression "Dried Ohanez grapes . . . boxes containing";
