### NATIONAL SECURITY (EMERGENCY POWERS) ACTS.

### REGULATIONS RELATING TO THE DISTRIBUTION OF MILK BY METROPOLITAN MILK DISTRIBUTORS.

IN pursuance of the powers conferred by the National Security (Emergency Powers) Act 1939 His Excellency the Governor of the State of Victoria by and with the advice of the Executive Council thereof doth make the following regulations, that is to say:-

- 1. These Regulations may be cited as the National Security (Milk Distribution) Regulations.
- 2. In these Regulations, unless inconsistent with the context or subject matter-
  - " Minister" means the Minister of Agriculture.
  - "Milk Board" means the Milk Board constituted under the Milk Board Acts.
  - "Semi-wholesale" in reference to the sale or distribution of milk relates to such a sale or distribution to any person on any day in a quantity exceeding 2 gallons.
  - "Retail" in reference to the sale or distribution of milk relates to such a sale or distribution to any person on any day in a quantity not exceeding 2 gallons.
  - "Superintendent of Dairying" means the Superintendent of Dairying of the Department of Agriculture.

3. No metropolitan milk distributor as defined by the Milk Board Acts or any person on his behalf shall without the written authority of the Milk Board previously obtained distribute milk in semi-wholesale quantities outside the municipal district within which the dairy of such milk distributor is located.

The provisions of this regulation shall not apply to milk distributed to any institutions within the meaning of the Hospitals and Charities Acts, or to any places used for purposes of defence.

- 4. If after investigation of any complaint made by a consumer as to the quality of milk distributed or as to the service rendered by any metropolitan milk distributor the Milk Board (if the complaint relates to service) or the Superintendent of Dairying (if the complaint relates to quality) considers that the complaint is justified, the Superintendent of Dairying may with the approval of the Minister revoke the licence of such distributor or suspend it for such period as the Superintendent determines.
- 5. The charge for milk supplied to persons having milk delivered to them regularly in retail quantities by any metropolitan milk distributor shall be computed on a weekly basis by multiplying the total quartage delivered during such week by the price per quart.

And the Honorable Albert Arthur Dunstan, His Majesty's Premier for the State of Victoria, shall give the necessary directions herein accordingly.
