## PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c.

WHEREAS by the Fire Brigades Act 1928, it is amongst other things enacted that, whenever the Metropolitan Fire Brigades Board or the Country Fire Brigades Board certifies that it is necessary or desirable that any specified portion of the metropolitan fire district or of any country fire district (as the case may be) be excised therefrom, the Governor in Council may by Proclamation in the Government Gazette declare that such portion shall be excised accordingly, and that thereupon such specified portion shall for the purposes of the said Act no longer be included in or be part of such metropolitan or country fire district: And whereas the Country Fire Brigades Board has certified that it is necessary and desirable that the portion of the Eastern Fire District set forth hereunder be excised from such fire district: Now therefore I. the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the provisions of section 5 (2) of the Fire Brigades Act 1928, do hereby declare that the portion of the said Eastern Fire District set forth hereunder shall be excised from such fire district, viz.—

The Garfield Urban District as defined for the purposes of the Water Act 1928, in the Government Gazette of the 16th July, 1930, at page 1903.

EXEMPTION REGARDING DEER IN VICTORIA (EXCEPTING ON SNAKE ISLAND AND IN THE SHIRE OF GRENVILLE).

#### PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia. &c., &c., &c

I THE Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the provisions of the Game Acts and all other powers me enabling in that behalf, do by this Proclamation repeal the Proclamation made the eighteenth day of November, 1919, and published in the Government Gazette of the twenty-sixth day of November, 1919, respecting deer in Victoria and direct that during the whole year in the whole of the State of Victoria, except on Snake Island in Corner Inlet and in the Shire of Grenville, sections 6 and 8 of the Game Act 1928 shall not be in operation as regards deer.
