# AREAS OF LANDS COMPRISED IN CERTAIN CLASSES DIMINISHED OR INCREASED.

# PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the Land Act 1928, it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the Government Gazette, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I., Division 1, section 5, of the said Land Act 1928, but that the area of lands which may be sold by auction (Class 6) shall not be increased except as in certain cases in the said Act provided: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the Land Act 1928 aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 2, 3, 6 and 7 of the classes mentioned in section 5 of the Land Act 1928 aforesaid to the extent set forth in the subjoined Schedule (that is to say):—

WHEREAS by section 22 of the Dog Act 1928, it is provided that the owner and the person (if any) for the time being in charge of any greyhound (other than a greyhound being raced, coursed, exercised, or trained upon land which the owner of the greyhound has obtained a right or permission to use for that purpose) which is not on the premises of the owner of the greyhound or which is not muzzled in a manner sufficient to prevent the greyhound causing injury by biting and also under the effective control of some person by means of a chain, cord, or leash, shall be liable to a penalty of not less than Three pounds and not more than Twenty pounds, and it is further provided the said section shall apply to cities, towns, and boroughs and to such shires or parts of shires as are specified for the purposes of the aforesaid section on the recommendation of the Council of the Shire by proclamation of the Governor in Council published in the proclamation of the Governor in Council published in the Government Gazette:

And whereas the Council of the Shire of South Barwon has recommended that the part of the said shire described hereunder be specified for the purposes of the above-mentioned section: Now, therefore, I, the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, do by this Proclamation specify the part of the Shire of South Barwon described hereunder as part of a shire within which section 22 of the Dog Act 1928 shall apply, that is to

DIVISION 20 OF PART V. OF THE CONSTITUTION ACT AMENDMENT ACT 1928 MADE APPLICABLE TO ELECTIONS OF COUNCILLORS FOR MUNICIPALITIES UNDER THE PROVISIONS OF SECTION 148 OF THE LOCAL GOVERNMENT ACT 1928.

HIS Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, and pursuant to the petition of the Council of the City of Mildura, doth, by this Order, under the provisions of section 148 of the Local Government Act 1928, direct that the provisions of Division 20 of Part V. of The Constitution Act Amendment Act 1928 applicable and severally hereinafter set out with alterations therein, such alterations being deemed necessary for the purpose of carrying into effect such provisions, shall apply to the election of councillors for the said municipality, and doth hereby, in pursuance of the powers so conferred on him by the said section 148, prescribe the forms in the schedule hereto, which forms or forms to the like effect shall be used for the purpose of carrying into effect such provisions as so applied by this Order:— HIS Excellency the Governor of the State of Victoria, by and

1. Every person whose name is inscribed upon the voters' roll shall record the number of votes set opposite his name on such roll at every election for a councillor for which he is entitled to vote.

The returning officer, at the close of the poll at every election, shall-

- (a) from every roll used at the election, and from the counterfoils of all postal ballot-papers received before the close of the poll at the election, indicate by a distinguishing mark on a fair copy of the roll used at the election (which copy is hereinafter referred to as the "marked roll") the names of the persons who have not recorded their votes at the election for which he is the returning officer;

  (b) certify the marked roll by statutory declaration
- (b) certify the marked roll by statutory declaration under his hand in accordance with Form A. of the schedule hereto; and
- (c) forthwith forward such marked roll to the clerk of the municipality.
- 3. (1) Within three months after the close of the poll at every election the clerk of the municipality-
  - (a) shall send by post to each person whose name indicated as aforesaid appears on any such marked roll, at the address therein mentioned, a notice in accordance with Form B. of the schedule hereto, notifying him that he has failed to record his vote or votes (as the case may be) as required by these provisions at the election specified therein, and requiring him to state the true reason why he failed so to vote; and
  - (b) before sending such notice, shall insert therein-
    - (i) the full name of the person as appearing on the roll, and his address as therein mentioned, his number on the roll; and
    - (ii) a date (not being less than twenty-one days after the date of the posting of the notice) before or on which the form at the foot of the notice duly filled up and signed by the person is to be in the hands of the clerk of the municipality.
- 4. (1) Every person to whom such a notice has been sent shall-
  - (a) fill up the Form C. at the foot of the notice by stating in it the true reason why he failed so to record his vote or votes (as the case may be);

- (b) sign the form; and(c) post or deliver the same so as to reach the clerk of the municipality not later than the date inserted in the notice.
- (2) If the person is unable, by reason of absence from his residence or physical incapacity, to fill up, sign, and post or deliver the form within the time allowed pursuant to these provisions---

A By-law of the City of Bendigo, made under the provisions of the Local Government Acts, and numbered 63, for the Control and Management of the Camping Area situated within the reserve known as Weeroona Park, in the City of Bendigo.

IN pursuance of the powers conferred by the Local Government Acts, the Mayor, Councillors, and Citizens of the City of Bendigo order as follows:—

- 1. That such portion of the reserve known as Weeroona Park, situated at the northern end of such reserve, and indicated by posts and notices, be set apart as an area for
- 2. The fee to be charged by the Council for the use of the camping ground shall be One shilling per day.
- 3. No person shall camp on any portion of the reserve except that which is specially set apart for the purpose, and then only after obtaining a permit subject to the payment of the aforesaid fee, and upon such other conditions as the Council may determine.
- 4. No person shall camp in the camping area for a longer period than fourteen days, and shall not again camp in such area until the expiration of fourteen days from the termination of the period for which a permit was obtained.
- 5. No person shall enter or remain in the camping area who may offend against decency as regards dress, language, or
- 6. The Council may provide and build such fireplaces on the camping area as it may think necessary. Any person lighting or using a fire, or causing or permitting fires to be used in the camping area, save in such fireplaces, except by special leave or direction of the Council, shall be guilty of an offence against this By-law.
- 7. No person shall deposit, or cause to be deposited, waste paper, bottles, or any other litter on any part of the camping area, except in the receptacles provided for that purpose.

  8. Persons camping on the area as defined by the Council for the purpose may be required to deposit any sum which the Council may at any time determine, not exceeding Three pounds, by way of guarantee that no damage shall be done, and that the camping area and surrounding area will be left free from refuse or rubbish of any kind. The Council, in its absolute discretion, may make good any damage caused, and have any clearing up done that may be required, and the cost so incurred may be deducted from the sum of money deposited by way of guarantee.

  9. In addition to the provisions herein contained, every person using the camping area shall comply with the provision of all By-laws relating to Weeroona Park.
- 10. Every person who shall by any act or default be guilty of any breach of this By-law shall be liable to a penalty not exceeding Five pounds (£5).

Such notice shall specify such time as the Council may consider reasonable in the circumstances to permit of such removal- being effected from the land specified therein, but shall not be less than seven days nor more than fourteen days from the date of service, and shall be given to the occupier if any person be rated in the rate book of the municipality as occupier, or to the owner if no person be so rated as occupier.

4. Such notice may be served upon the owner or occupier personally, or by pre-paid registered letter post, addressed to the recipient at his or her address appearing in the Municipal Rate Book.

the recipient at his or her address appearing in the Municipal Rate Book.

5. The occupier or (as the case may be) the owner of the land specified in such notice shall, within the time specified in such notice, remove or cause to be removed such undergrowth,

weeds, or grass from the land so specified.

6. Every person guilty of any breach of the provisions of this By-law shall be liable for every such offence to a penalty not exceeding Twenty pounds.

7. If after the expiration of the time specified in the said

notice the undergrowth, weeds, or grass referred to therein have not been removed in accordance with the provisions thereof, the Council may remove the same and recover the cost thereof from the owner or occupier.

8. This By-law shall come into force immediately after publication in the Government Gazette of Victoria.
