REVOCATION OF ORDER IN COUNCIL EXEMPTING LAND FROM OCCUPATION FOR MINING PURPOSES, ETC.

GEELONG WATERWORKS AND SEWERAGE TRUST.

BY-LAW No. 77.

A By-law for Making and Levying the Rates for the Year commencing on the first day of July, 1946.

THE Geelong Waterworks and Sewerage Trust (hereinafter called "the Trust"), in pursuance of and in exercise of the powers and authorities conferred on such Trust by the Geelong Waterworks and Sewerage Act 1928, and of any other powers and authorities in any wise enabling the said Trust in that behalf, doth hereby make the By-law for the area supplied with water by the Geelong Water Supply Works, or any extension of such works.

- 1. The following rates are hereby made, and shall be levied upon the occupiers or owners of lands and tenements liable to be rated within the said area and supplied with water for domestic purposes:-
 - (a) On any tenement (other than land on which there is no building) the annual valuation whereof does not exceed £17—Twenty shillings per annum.
 - (b) On any such tenement the annual valuation whereof exceeds £17—One shilling and two pence in the pound of the amount of the annual valuation.
 - (c) On any land (on which there is no building) the annual valuation whereof does not exceed £4—Five shillings per annum.
 - (d) On any such land (on which there is no building) the annual valuation whereof exceeds £4—One shilling and two pence in the pound of the amount of the annual valuation.
- 2. Such rates are made and shall be levied for the year beginning with the first day of July, 1946, and ending with the thirtieth day of June, 1947, and shall be payable in two equal instalments on the nineteenth day of October, 1946, and the first day of January, 1947.
- 3. Such persons as the Trust may from time to time appoint for that purpose shall be and are hereby authorized to demand, receive, collect, sue for, and recover the said rates.
- 4. For making and levying such rates within the said area, the valuation for the time being of all lands and tenements for the municipal rate of the municipality in the municipal district of which such lands and tenements are situate shall be deemed and taken to be the valuation of such lands and tenements respectively; but if any such lands and tenements are not included in a valuation in force for the municipality in whose district they are situate, or if there is no such valuation, the net annual value thereof may for all the purposes for such rate be determined in accordance with the provisions of the Local Government Acts by the council of such municipality, on the written application of the Trust, as provided for in such case by the Water Acts.

INTERIM DEVELOPMENT ORDER.

WHEREAS, by virtue of the powers conferred by the Town and Country Planning Act 1944 and every other power enabling them in that behalf, the preparation of a planning scheme, in accordance with the said Act, has been commenced by the Council of the Town of Hamilton (hereinafter referred to as the "Responsible Authority"), which hereby makes the following Interim Development Order:—

- 1. The development of all land referred to in the Schedule. and the erection, construction, and carrying out of any build-ings, roads, or other works on any of the said land is hereby prohibited.
- 2. Any person may apply to the Responsible Authority for permission to develop, subdivide, or otherwise use any land, or erect or construct any buildings, roads, or other works, during the operation of this Order.
- 3. Any application for permission to develop, subdivide, or otherwise use any land, or erect or construct any building roads, or other works, may be granted by the Responsible Authority, subject to such conditions as are specified in the permit, or may be refused.
- 4. Any owner of any land who, after service of a copy of this Order, contravenes any of the provisions contained herein. shall, when directed by notice, in writing, remove, pull down, take up, or alter any building, road, or other works, and, if any owner fails to do so within the time specified by the notice, the Responsible Authority may carry out all or any of such works, and recover all expenses incurred, after due notice has been given to the owner, lessee, and/or occupier, in accordance with the provisions of section 12, sub-section 3, of the Act.
- 5. None of the provisions of this Order shall prohibit the continuance of the use of any land or buildings for the purpose for which it was used immediately before the coming into operation of this Order.





REGULATIONS RELATIVE TO THE DEFENCE OF DESTITUTE PERSONS CHARGED WITH CAPITAL CRIMES, AND OF ABORIGINALS CHARGED WITH INDICTABLE OFFENCES.

- 1. When any person charged with an offence punishable by death, or any aboriginal accused of an indictable offence, requires legal assistance for his defence, he shall, seven days before the first day of the gaol delivery, Circuit Court, or Court of General Sessions at which he is to take his trial, or so soon as he shall know that he is to be tried for such offence, apply to the Sheriff for such assistance, and shall show to the satisfaction of such Sheriff that he is without sufficient means where with the complex level assistance. wherewith to employ legal assistance.
- wherewith to employ legal assistance.

 2. Upon the Sheriff being convinced of the truth of the allegations contained in such application, and having ascertained from the Crown Solicitor or the Clerk of the Peace, as the case may be, that the applicant is to be tried on a capital charge, or in the case of an aboriginal, that he is to be brought to trial, he shall communicate to the legal practitioner nominated by the applicant to act as his counsel the desire of the applicant to be defended by him, together with the amount of fees to be allowed, and forward notice of the same to the Attorney-General. The solicitor to be assigned in the case of every such application shall be the Public Solicitor. In the event of the accused being unaware of any suitable counsel, or failing to nominate one, the Public Solicitor shall follow the usual practice and assign counsel to him. the usual practice and assign counsel to him.

- 3. The Public Solicitor shall not withdraw from the defence unless requested to do so in writing by the applicant.
- 4. If the applicant desires to change his counsel he shall inform the Sheriff. in writing, as soon as possible, and shall nominate another, or request that the Public Solicitor assign another counsel for his defence.
- 5. The fees shall not (except in special cases, to be approved of by the Attorney-General) exceed the sum of £7 7s.
- 6. The above sums are exclusive of the expenses of any o. The above sums are exclusive of the expenses of any witnesses deemed by the Public Solicitor to have been material and necessary (which expenses shall be paid at the same rate as those of Crown witnesses). Provided, however, that where the evidence of experts is required (as in defences of insanity, &c.) the approval of the Attorney-General must first be obtained for the payment of any necessary fees.
- 7. Counsel nominated by the applicant, or assigned by the Public Socilitor, shall, after the trial, present his claim to the Sheriff. The Public Solicitor shall forward to the Attorney-General the application for legal aid, with a report on the trial and any recommendation as to increased fees as may be thought necessary.
- 8. Only those persons who comply with these Regulations shall be entitled to receive aid from the sum voted by Parliament.
- 9. The purport of these Regulations shall, as soon as possible after the commitment for trial of any prisoner to whom they apply, be communicated by every gaoler to such prisoner.

 (2) Order that a Wages Board, consisting of six members and a chairman, three of such members being appointed as representatives of employees, be constituted and appointed to determine the lowest rates which may be paid to any person or persons or classes of persons. excluding smiths (iron, brass, or copper), electrical fitters, electrical mechanics, machinist (1st and 2nd class), toolmakers, tradesmen. engineers, welders (1st and 2nd class), and patternmakers employed in the process, trade, or business of manufacturing or preparing files or rasps of any description for use as tools of trade.

Also that such Wages Board may, in any regulation, determination, order, instrument, or legal proceeding be described for all purposes as the Filemakers Board, and the area or locality within which the determination of such Wages Board shall be operative shall be the whole of the State of Victoria.
