## PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by an Act of the Parliament of the State of V WHEREAS by an Act of the Parliament of the State of Victoria passed in the tenth year in the reign of His Majesty King George VI. initialed the Soldier Scattlement Act 1945 (No. 5107) it is amongst other things enacted by Section 2 thereof that Parts II., III., IV., and V. of the said Act shall come into operation on a day to fixed by Proclamation of the Governor in Council published in the Government Gazette: Now therefore, I. the Lieutenant-Governor of the State of Victoria in the Commonwealth of Australia by and with the advice of the Executive Council of the said State do by this my Proclamation fix the twelfth day of February, 1946, as the day upon which the said Parts II.. III., IV., and V. of the Soldier Settlement Act 1945 shall come into operation. operation.

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this twelfth day of February in the year of our Lord One thousand nine hundred and forty-six, and in the tenth year of the reign of His Majesty King George VI.

# SOLDIER SETTLEMENT COMMISSION.—APPOINTMENT OF MEMBERS.

IN pursuance of the powers in that behalf conferred by the Soldier Settlement Act 1945 (No. 5107), the Acts Interpretation Act 1928, and all other powers thereto enabling.
