LEVEE AT PARLIAMENT HOUSE, MELBOURNE.

IN honour of the birthday of His Majesty King George VI., His Excellency the Governor, Major General Sir Winston Dugan, G.C.M.G., C.B., D.S.O., will hold a Levee at Parliament House. Spring-street, Melbourne, from 11.30 a.m. to 12.30 p.m. on Thursday, the 12th June, 1947.

On the occasion of the celebration of the King's birthday, His Excellency is anxious to receive as many citizens as possible.

In accordance with the custom followed at levees held by His Majesty the King, there will be no precedence in the order of presentation, but it is requested that members of services and all public bodies group themselves together for presentation as far as possible.

It is requested that those entitled to wear uniform or official dress do so, but His Excellency will be pleased to receive those not entitled to wear uniform or official dress in their ordinary morning or business dress.

Private entree cards will admit recipients to the south door of the Spring-street entrance at Parliament House at 11.30 a.m. All other citizens will enter by the north door of the Spring-street entrance before 12.30 p.m.

It is particularly desired that gentlemen attending the Levee should provide themselves with a card on which should be printed or typed in capitals, or written in block letters, their styles of address for presentation, in order to facilitate announcement to His Excellency.

PROCLAMATION

WHEREAS by an Act of the Parliament of the State of Victoria passed in the eleventh year of the reign of His Majesty King George VI. initiuled the Adult Education Act 1946 (No. 5181) it is amongst other things enacted by section 1 thereof that the said Act (save as otherwise expressly provided) shall come into operation on a day to be appointed by Proclamation of the Governor in Council published in the Government Gazette: Now therefore, I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation appoint the twenty-third day of May, 1947, as the day upon which the said Adult Education Act 1946 shall come into operation.

AREAS OF LANDS COMPRISED IN CERTAIN CLASSES DIMINISHED OR INCREASED.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

HEREAS by the Land Act 1928 it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the Government Gazette, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part-L. Division 1, section 5, of the said Land Act 1928, but that the area of lands which may be sold by auction (Class 6) shall not be increased except as in certain cases in the said Act provided: Now therefore 1, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the Land Act 1928 aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 3, 6 and 7 respectively of the classes mentioned in section 5 of the Land Act 1928 aforesaid to the extent set forth in the subjoined Schedule (that is to say):—

REGULATIONS FOR THE CARE, PROTECTION, AND MANAGEMENT OF THE "ARARAT TATYOON-ROAD RESERVE."

WHEREAS by section 181 of the Land Act 1928, as re-enacted by section 9 of the Land Act 1941, power is given to the Board of Land and Works to make Regulations in respect of the care, protection, and management of any Crown land which has been reserved under the Land Acts for any public purpose whatsoever, and which has not been conveyed to or vested in trustees, and for the further purposes as enacted: Now therefore the Board of the days with the converted for the section of the s Land and Works, in pursuance of the powers conferred as aforesaid, doth hereby make the following Regulations in respect of the land temporarily reserved by Order in Council of the 3rd December, 1946, as a site for Recreation purposes in the Parish of Ararat, and known as the "Ararat

Tatyoon-road Reserve," hereinafter referred to as the "Reserve," such reservation having been placed under the control of a Committee of Management, hereinafter referred to as the "Committee."

REGULATIONS.

- 1. The Reserve shall be open to the public from sunrise to sunset free of charge, except on such days, not exceeding seventy-five (75) in any one year, as the Reserve may be set apart for cricket or football, fêtes, sports, holiday amusements, or other recreation purposes, on any of which occasions a sum not exceeding Three shillings may be charged and taken for the admission of every adult to the
- 2. No person shall enter or remain in the Reserve who may offend against decency as regards dress, language, or conduct.
- 3. No person shall damage in any way the trees, shrubs, or flowers in the Reserve, nor shall fires be lighted therein.
- 4. No person shall climb or jump over the gates or fences in or around the Reserve, stick bills thereon, or cut names on, or in any way damage or injure any of the buildings, gates, fences, trees, or seats in the Reserve, nor leave or deposit any class paper or publish per roll or throw stopes deposit any glass, paper, or rubbish, nor roll or throw stones or any missiles of any kind therein.
- $5.\ \mbox{No}$ person shall bring into the Reserve any dog, unless controlled by a chain or cord, without the permission, in writing, of the Committee first obtained.
- 6. No person shall camp in the Reserve nor erect therein any building or any booth for the purpose of offering for sale any article without the permission, in writing, of the Committee first obtained.
- 7. No person shall take part in any public entertainment of any sort in the Reserve without the permission, in writing, of the Committee first obtained.
- 8. No person shall spit or expectorate on the paths or any of the structures or erections in the Reserve.
- 9. No person shall bet publicly in any part of the Reserve, and every person infringing this Regulation shall be liable to expulsion from the enclosures and Reserve.
- 10. No person shall play, practise, or engage in any game or sport within the Reserve on Sundays without the permission, in writing, of the Committee first obtained.
- 11. Persons renting or hiring any stand, building, erec 11. Persons renting or hiring any stand, building, erection, or enclosure on the occasions of any fêtes, sports, or holiday amusements, may be required to deposit any sum which the Committee may at the time determine, not exceeding Ten pounds, by way of guarantee that due care shall be taken of such stand, building, erection, or enclosure, and such Committee in its absolute discretion may make good any damage or injury sustained by such stand, building, erection, or enclosure, or anything contained therein, during such occupancy or hiring, and deduct the cost of making good such damage, injury, or loss from the sum of money deposited by way of guarantee, and all persons so renting or hiring shall abide by these Regulations, and by any order given by the Committee.
- 12. No person, except a labourer or workman employed in the Reserve, shall enter any plots therein which may be enclosed for plantations of young trees or shrubs.
- 13. No person shall ride a bicycle in the Reserve without the permission of the Committee.
- 14. No person shall engage in cricket, football, tennis, lacrosse, golf, baseball, or any other like game, nor shall any band perform in the Reserve, without the permission, in writing, of the Committee.
- 15. No person shall hawk or offer for sale in the Reserve any goods or articles of any description without the permission, in writing, of the Committee.
- 16. No person shall cross or trespass on the playing ground during any cricket or football match, or sports, show, &c., or during practice at football or cricket, when any such crossing or trespassing would be injurious to or cause undue interference with the progress of the aforesaid sports, football, or cricket, &c.
- 17. Persons renting or hiring the Reserve for any purpose whatsoever, and who make any charge to the public for admission, shall pay to the Committee such a fee as the Committee may consider reasonable and consistent with the Regulations, but the maximum fee shall not exceed the sum of Ten guineas per day.
- 18. No person shall remove or displace any board, plate, or table, or any support, fastening, or fitting used or constructed, or adapted to be used, for the exhibition of any Regulation or notice, and fixed or set up by the Committee in the Reserve.

- 19. No person shall be in the Reserve in a state of intoxication or behave in a disorderly manner, or create or take part in any disturbance therein, or obstruct any servant of the Committee, or interfere with any games or sports therein, or use insulting words or gestures, or otherwise misbehave.
- 20. The Committee may set apart any portion of the Reserve for the purpose of any lawful game or sports, and from time to time grant to any club or association of clubs, on such terms and conditions as the Committee may deem to be consistent with these Regulations, the use of the grounds so set apart.
- 21. No person shall, in the Reserve, wilfully obstruct, disturb, or annoy any other person in the proper use of the Reserve, or on any part thereof, or wilfully obstruct or interrupt any servant of the Committee in the proper execution of his duty or work.

Every person who contravenes or fails to comply with Every person who contravenes or fails to comply with these Regulations shall, in accordance with the provisions of section 181 of the Land Act 1928, as re-enacted by section 9 of the Land Act 1941, for each offence be liable to a penalty of not more than Five pounds, and every person who contravenes or fails to comply with any such Regulation, and who, after he has been warned by any balliff of Crown lands or by any member of the Police Force, does not desist therefrom, may be forthwith apprehended by such bailiff or member of the Police Force and taken before some Justice to be dealt with according to law, and shall some Justice to be dealt with according to law, and shall be liable to a penalty of not more than Ten pounds.

EMERGENCY POWERS UNDER THE GAS REGULATION ACT 1933 (No. 4142).

WHEREAS by section 33 of the Gas Regulation Act 1933 WHEREAS by section 33 of the Gas Regulation Act 1933 it is amongst other things enacted that whenever it appears to the Governor in Council that from any cause the available supply of gas is or is likely to become less than is sufficient for the reasonable requirements of the community, the Governor in Council may from time to time exercise all or any of the powers conferred on him by or under the said provision and may from time to time by Proclamation declare that on and after the date No. 255.-5132/47.

of the publication of such Proclamation in the Government Gazette or a later date specified therein the provisions of section 33 of the said Act shall have effect:

And whereas there exists in Victoria an acute shortage of coal for the making of gas:

And whereas as a consequence of such cause it appears to the Governor in Council that the available supply of gas is less than is sufficient for the reasonable requirements of the community:

Now therefore I, the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, and in pursuance of the powers conferred by section 33 of the said Act, do by this my Proclamation declare that on and after the date of the publication of this my Proclamation in the Government Gazette, the provisions of section 33 of the Gas Regulation Act 1933 shall have effect.

GAS REGULATION ACT 1933.

At the Executive Council Chamber, Melbourne, the twenty-second day of May, 1947.

PRESENT:

His Excellency the Governor of Victoria. Mr. McKenzie Mr. Coleman.

REGULATIONS.

WHEREAS by a Proclamation dated the twenty-second day of May, 1947, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, declared that on and after the date of the publication in the Government Gazette of such Proclamation the provisions of society 22 of the Care Reservices. the provisions of section 33 of the Gas Regulation Act 1933

should have effect: And whereas the said Proclamation was published in the Government Gazette of the twenty-second day of May, 1947: Now therefore His Excellency the Governor of the said State, by and with the advice of the Executive Council thereof, and in pursuance of the powers conferred by section 33 of the said Act, doth hereby make the following Regulations (that is to say):—

- 1. These Regulations may be cited as the "Gas Regulation (Emergency Powers) Regulations (No. 44)," and shall apply to and have operation throughout the areas supplied with gas by The Metropolitan Gas Company, The Colonial Gas Association Limited (as to its Box Hill, Footscray, Frankston, and Oakleigh works). The Brighton Gas Company Limited, and the Mordialloc City Council Gas Works.
 - 2. In these Regulations
 - "Gas" means gas supplied by a Gas Undertaker, pursuant to the provisions of the Gas Regulation Act
 - "Gas Undertaker" shall have the same meaning as "Undertaker" as defined by the Gas Regulation
- 3. On and after the publication of these Regulations, no person shall use gas during the period commencing at Seven o'clock in the afternoon of Friday, the 23rd May, 1947, and ending at Twelve o'clock midnight of Friday, 30th May, 1947, except between the hours hereinafter repetition. specified:
 - (a) In the case of Saturday, the 24th May, 1947, and Sunday, the 25th May, 1947-
 - (i) 7 a.m. and 8 a.m.
 - (ii) 11 a.m. and 1.30 p.m.

- (b) In the case of Monday, the 26th May, 1947, Tuesday, the 27th May, 1947, Wednesday, the 28th May, 1947, Thursday, the 29th May, 1947, and Friday, the 30th May, 1947—

 - (i) 6.30 a.m. and 8 a.m.(ii) 12 o'clock noon and 1 p.m.
 - (iii) 5.30 p.m. and 7 p.m.

(iii) 5.30 p.m. and 7 p.m.

4. The restrictions contained in Regulation 3 shall not apply to persons using gas in connexion with the conduct of hospitals, medical services, or institutions rendering relief to the aged or infirm, or to persons using gas for pilot lights or by-pass flames on automatic appliances.

5. It shall be lawful for any inspector or other person upon producing an authority issued to him by a Gas Undertaker referred to in Regulation 1 hereof to enter any premises to which gas is supplied by such Gas Undertaker for the purpose of determining whether the provisions of these Regulations are being observed.

6. No person shall obstruct any such inspector or other person in the course of his duties.

7. A Gas Undertaker shall not; except during the hours referred to in Regulation 3 hereof, be required to supply gas in any main or in any pipe, of the pressure prescribed by the Gas Regulation Act 1933.

8. Any person who offends against these Regulations shall be liable to a penalty of not more than Fifty pounds (£50), and in the case of a continuing offence a further penalty of not more than Five pounds (£5) for each day on which any offence is continued after conviction or order of any court.

And the Honorable William Slater, His Majesty's Chief Secretary for the State of Victoria, shall give the necessary directions herein accordingly.
