*Land Act 1928.*

AREAS OF LANDS COMPRISED IN CERTAIN CLASSES DIMINISHED OR INCREASED.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia,  
&c., &c., &c.

WHEREAS by the *Land Act 1928* it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the *Government Gazette*, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I., Division 1, section 5, of the said *Land Act 1928*, but that the area of lands which may be sold by auction (Class 6) shall not be increased except as in certain cases in the said Act provided: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the *Land Act 1928* aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 2 and 6 respectively of the classes mentioned in section 5 of the *Land Act 1928* aforesaid to the extent set forth in the subjoined Schedule (that is to say):—

PUBLIC HIGHWAY.—CITY OF SANDRINGHAM.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the *Local Government Act 1946* (No. 5203), section 518, it is amongst other things enacted that it shall be lawful for the Governor in Council at any time, and from time to time, upon the request of the council of any municipality, by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street, road, highway, thoroughfare, bridge, square, court, alley, or right-of-way to be a public highway, and that such land shall thereupon and thenceforth from the date of such Proclamation become and be absolutely dedicated to the public as a public highway within the meaning of any law then or thereafter in force: And whereas the Council of the City of Sandringham has requested that the land hereinafter mentioned, which has been used as a street by the said Council within the said city, be so declared to be a public highway: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this Proclamation declare the land used as a street hereinafter described, and situated within the City of Sandringham aforesaid, to be a public highway within the meaning of the said Act, viz.:—

CITY OF SANDRINGHAM.—PUBLIC HIGHWAY.

*Alfred-street, Black Rock*.—All that piece of land, being part of Crown portion 34, Parish of Moorabbin, County of Bourke, commencing at a point on the east building line of Bluff-road, being 357 feet north from the north building line of Cheltenham-road, bounded by a line 50 feet in length bearing 0 deg. 0 min.; thence by a line 495 feet in length bearing 90 deg. 0 min.; thence by a line 50 feet in length bearing 180 deg. 0 min.; thence by a line 495 feet in length bearing 270 deg. 0 min. to the commencing point.

Country Fire Authority Acts.  
SUMMER PERIOD IN RESPECT OF SPECIFIED PARTS  
OF THE COUNTRY AREA OF VICTORIA.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by sub-section (ii) of section 4 of the *Country Fire Authority Act 1944*, it is enacted that the Governor in Council, after consultation by the Chief Secretary of Victoria with the Minister of Forests, may from time to time by Proclamation published in the *Government Gazette* proclaim any period as the summer period in respect of the country area of Victoria, or any specified part or parts thereof and, without affecting the generality of the foregoing, may proclaim different summer periods in respect of different parts of the said country area: And whereas the said Chief Secretary and the said Minister have consulted accordingly: Now therefore I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the powers conferred by the *Country Fire Authority Act 1944*, do by this my Proclamation proclaim the period commencing on the twenty-fourth day of December, 1947, and ending on the twenty-ninth day of February next following to be the summer period in respect of the parts hereinafter specified of the country area of Victoria, that is to say:—

The First Fire Control Region, comprising the municipal districts of the City of Ballarat and the Borough of Sebastopol, and those portions of the municipal districts of the Shires of Ballarat and Buninyong within the aforesaid fire control region.

The Fourth Fire Control Region, comprising the municipal districts of the Borough of Portland, and the Shires of Glenelg, Portland, and Wannon.

The Fifth Fire Control Region, comprising the municipal districts of the City of Warrnambool, the Town of Hamilton, the Boroughs of Koroit and Port Fairy, and the Shires of Belfast, Dundas, Minhamite, Mortlake, Mount Rouse, and Warrnambool.

The Sixth Fire Control Region, comprising the municipal districts of the Borough of Colac, and the Shires of Colac, Hampden, Heytesbury, and Otway.

The Eighth Fire Control Region, comprising the municipal districts of the Borough of Wonthaggi, and the Shires of Bass, Berwick, Cranbourne, Flinders, Frankston and Hastings, Mornington and Phillip Island; also French Island.

The Ninth Fire Control Region, comprising the municipal districts of the Shires of Buln Buln, Korumburra, Mirboo, Narracan, Warragul, and Woolayl.

The Tenth Fire Control Region, comprising the municipal districts of the Town of Sale, and the Shires of Alberton, Avon, Maffra, Morwell, Rosedale, Traralgon, and South Gippsland.

The Twelfth Fire Control Region, comprising the municipal districts of the Shires of Alexandra, Mansfield, and Yea.

The Thirteenth Fire Control Region, comprising the municipal districts of the Shires of Fern Tree Gully, Healesville, and Upper Yarra, and those portions of the municipal districts of the Shires of Eltham and Lillydale which lie outside the Metropolitan Fire District.

The Fourteenth Fire Control Region, comprising the municipal districts of the City of Chelsea, and the Shires of Bacchus Marsh, Broadford, Bulla, Dandenong, Gisborne, Kilmore, Melton, Newham and Woodend, and Romsey, and those portions of the municipal districts of the Cities of Heidelberg and Moorabbin, and of the Shires of Braybrook, Broadmeadows, Doncaster and Templestowe, Kellor, Mulgrave, Werribee, and Whittlesea which lie outside the Metropolitan Fire District.

The Fifteenth Fire Control Region, comprising the municipal districts of the Boroughs of Clunes, Daylesford and Maryborough, and of the Shires of Ballan, Bungaree, Creswick, Glenlyon, Grenville, Kyneton, Newstead and Mt. Alexander, Talbot, and Tullaroop, and those portions of the municipal districts of the Shires of Ballarat and Buninyong which lie outside the First Fire Control Region.

Those portions of the Sixteenth Fire Control Region comprised by the municipal districts of the Town of Ararat, and the Shires of Ararat, Lexton, and Ripon.

Those portions of the Seventeenth Fire Control Region comprised by the municipal districts of the Shires of Arapiles and Kowree.

Those portions of the Twenty-second Fire Control Region comprised by the municipal districts of the Shires of Euroa, Goulburn, McIvor, Pyalong, Seymour, and Violet Town.

And those portions of the Twenty-fourth Fire Control Region comprised by the municipal districts of the Shires of Beechworth, Bright, Towong, Upper Murray, and Yackandandah.

## INTERIM DEVELOPMENT ORDER.

WHEREAS by virtue of the powers conferred by the *Town and Country Planning Act 1944*, and every other power enabling them in that behalf, the preparation of a planning scheme in accordance with the said Act has been commenced by the Council of the City of Chelsea (hereinafter referred to as the "responsible authority"), which hereby makes the following Interim Development Order.

1. The development of all land referred to in the Schedule, and the erection, construction, and carrying out of any buildings, roads, or other works on any of the said land is hereby prohibited.

2. Any person may apply to the responsible authority for permission to develop, subdivide, or otherwise use any land, or erect or construct any buildings, roads, or other works, during the operation of this Order.

3. Any application for permission to develop, subdivide, or otherwise use any land, or erect or construct any building, roads, or other works, may be granted by the responsible authority, subject to such conditions as are specified in the permit, or may be refused.

4. Any owner of any land who, after the service of a copy of this Order, contravenes any of the provisions contained therein shall, when directed by notice in writing, remove, pull down, take up, or alter any building, road, or other works, and, if the owner fails to do so within the time specified by the notice, the responsible authority may carry out all or any of such works, and recover all expenses incurred, after due notice has been given to the owner, lessee, and/or occupier in accordance with the provisions of section 12, sub-section 3, of the Act.

5. None of the provisions of this Order shall prohibit the continuance of the use of any land or buildings for the purpose for which it was used immediately before the coming into operation of this Order.

6. This Order shall remain in operation until the approval of the planning scheme in accordance with the *Town and Country Planning Act 1944*, or until this Interim Development Order is revoked by the Governor in Council.

7. Schedule of Land Affected.—All that piece or parcel of land commencing at the north-west corner of Crown allotment 12A, Parish of Lyndhurst; thence along the Mordialloc Creek to the intersection of the drain running along the east boundaries of Crown allotment 135 to 101 in the said parish; thence to the south-east corner of Crown allotment 91; thence westerly by the Eel Race-road to the Frankston-road; thence to the south-east corner of Crown allotment 1A; thence south-westerly by the southern boundary of that allotment and a straight line to Port Phillip Bay; thence along Port Phillip Bay to the point of commencement.

#### HOLIDAYS IN CERTAIN TRADES.

UNDER the powers in that behalf conferred by the Factories and Shops Acts, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, and—

1. On the recommendation of a Wages Board, described as the Shops Board No. 15 (Grocers), doth hereby make the following Regulation, that is to say:—

(a) That the ninth day of February, 1948, shall, in the Metropolitan District, as defined in the Factories and Shops Acts and the Orders in Council made thereunder, be fixed as a holiday for persons employed in grocers' shops, and in shops in which tea is sold.

(b) That the fourteenth day of January, 1948, shall, within the Geelong District, as defined in the Factories and Shops Acts, be fixed as a holiday for persons employed in grocers' shops, and in shops in which tea is sold.

(c) That the ninth day of February, 1948, shall, within the City of Ballarat and the Borough of Sebastopol, be fixed as a holiday for persons employed in grocers' shops, and in shops in which tea is sold.

2. On the recommendation of a Wages Board, described as the Animal Manure Board, doth hereby make the following Regulation, that is to say:—

The twenty-first day of January, 1948, shall, within the whole of the State of Victoria, be fixed as a holiday for persons employed subject to the Determination of the Animal Manure Board.

- (d) motor cycle side-car bodies, or any part or parts thereof, such as the hoods or cushions;
- (e) aircraft.

#### TRAVELLING EXPENSES OF MEMBERS OF THE SOIL CONSERVATION BOARD.

IN accordance with the provisions of the Soil Conservation Acts and the *Acts Interpretation Act 1928*, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, doth by this Order hereby make the following Regulation (that is to say):—

Clause 1 (a) of the Regulations made on the 21st day of October, 1941, is hereby revoked, and the following clause substituted in its stead:—

1. (a) Every member, including the Chairman, of the Soil Conservation Board, shall, when travelling in the performance of his official duties, be entitled to receive the following travelling expenses, exclusive of any charges for any conveyance paid by him when so travelling:—

During his absence from Melbourne, outside the metropolitan area, every member, including the Chairman, of the Soil Conservation Board, but not including the member representing pastoral interests, shall be entitled to an allowance of One pound for each full day and a proportionate amount for a part of a day.

During his absence from his place of residence, the member representing pastoral interests shall be entitled to an allowance of One pound for each full day and a proportionate amount for a part of a day.

During his absence in another State, every member, including the chairman, of the Soil Conservation Board, shall be entitled to an allowance of Thirty shillings for each full day and a proportionate amount for a part of a day.

"Metropolitan area" for the purposes of this Order in Council means the area within a distance of fifteen miles from the Post Office, Elizabeth-street, Melbourne.

The member representing pastoral interests, when travelling from his place of residence to the nearest available railway station for the purpose of proceeding to Melbourne on official business or when travelling from such railway station to his place of residence when returning from Melbourne from official business shall be entitled to an allowance of Five shillings.

## ALTERNATIVE METHOD OF CHARGING FOR ELECTRICITY UNDER THE SHIRE OF SWAN HILL ELECTRIC LIGHTING ORDER No. 197, 1927.

WHEREAS on the 13th day of June, 1927, the Council of the municipality of the President, Councillors, and Ratepayers of the Shire of Swan Hill (hereinafter called "the undertakers") was granted an Order under the *Electric Light and Power Act 1915*, cited as The Shire of Swan Hill Electric Lighting Order, No. 197, 1927 (hereinafter called "the said Order") to supply electricity within portion of the Shire of Swan Hill: And whereas the undertakers have made application that the Governor in Council approve of the method of charging under the said Order as set out hereunder, and have also made application to have the Fourth Schedule to the said Order amended so as to include the price determined by the Governor in Council as the price that may be charged for electricity supplied by the said method of charging, and to make provision for the charging of a minimum monthly charge: Now therefore His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, pursuant to the provisions of section 13 of the *Electric Light and Power Act 1928*, and to the powers in that behalf reserved in clause 30 of the said Order, doth hereby approve of the undertakers charging for electricity supplied by them to any consumer for normal residential use for lighting, cooking, heating, or power, by a fixed periodical or service charge, whether any or no electricity is consumed during the period for which it is payable, and a charge according to the amount of electricity supplied, and determine that the price that may be charged by the undertakers for electricity supplied by the foregoing method shall not exceed the rates set out in the said Fourth Schedule calculated as therein provided, and amend the said Fourth Schedule to include the rates so determined, and to provide that the undertakers may charge any consumer a minimum monthly charge irrespective of the amount of electricity consumed, or the purpose for which such supply is given, by substituting the following sections 1, 2, 3, and 4, for sections 1 and 2 of the said Fourth Schedule, that is to say:—

## Section 1.

Where the undertakers charge any consumer by the electrical quantity supplied to him, they shall be entitled to charge him at the following rates:—

- For energy supplied for lighting purposes—1s. 3d. per unit.
- For energy supplied for purposes other than lighting—6d. per unit.

**Section 2.**

Where the undertakers charge any consumer by the electrical quantity contained in the supply given to him, they shall be entitled to charge him according to the rates set forth in section 1 of this Schedule, the amount of energy supplied to him being taken to be the product of such electrical quantity and the declared pressure at the consumer's terminals; that is to say, such a constant pressure at those terminals as may be declared by the undertakers under any regulations made under the Act.

**Section 3.**

Notwithstanding anything contained in this Order the undertakers may charge any consumer a minimum charge of 7s. 6d. per month irrespective of the amount of energy consumed, or the purpose for which such supply is given, and exclusive of meter rent.

**Section 4.**

Where the undertakers charge any consumer by a fixed periodical or service charge, and a further charge according to the amount of energy supplied, they shall be entitled to charge him at the following rates:—

*For energy supplied for normal residential use for lighting, cooking, heating, or power—*

A service charge of 1s. 6d. per month for every assessable\* room which does not exceed 350 square feet in floor area, plus 1s. 6d. per month for every 350 square feet of floor area or odd fraction thereof of every assessable room in such premises whose floor area exceeds 350 square feet (but the service charge in respect of any one room shall not exceed 3s. per month) and, in addition, for any amount of energy supplied, 4d. per unit; but (subject to the minimum monthly charge provided for in section 3 of this Schedule) the amount chargeable to any consumer under this method shall not be higher than a sum calculated at the rate of 1s. 3d. per unit used in any month.

\* An assessable room is any room (whether lighted by electricity or not and other than those exempted below) used or erected for use as a dining room, kitchen, bedroom, dressing room, sun room, ballroom, lounge, servery, library, billiard room, sleepout, laboratory, dispensary, gymnasium, or the like, or any enclosed verandah or vestibule used for such purpose. The following are normally exempt in assessing service charges:—Passages, pantries, lobbies, bathrooms, lavatories, cellars, entrance halls, porches, garages, private workshops, sculleries, and wash-houses where not combined with kitchens, verandahs, and vestibules unless such verandahs when enclosed or vestibules are used for the purposes stated above.

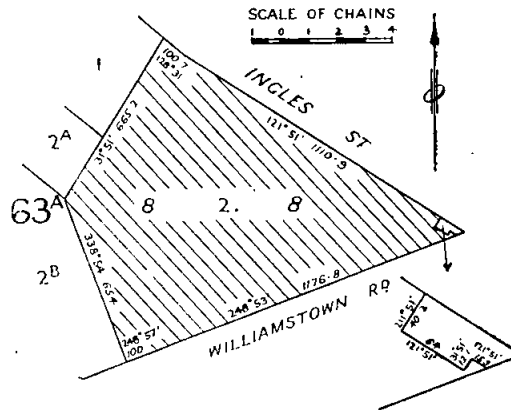

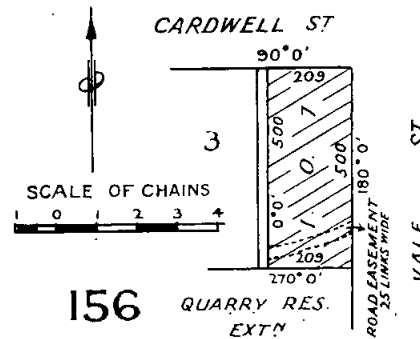

REGULATIONS AMENDING THE CLEANLINESS (FOOD) REGULATIONS.

UNDER the powers conferred by the Health Acts and all other powers enabling him in that behalf, His Excellency the Governor of the State of Victoria, with the advice of the Executive Council of the said State, doth hereby make the Regulations following (that is to say):—

1. These Regulations may be cited as the Amending Cleanliness (Food) Regulations 1947, and shall come into operation on publication in the *Government Gazette*.

2. The Cleanliness (Food) Regulations 1942 are hereby repealed.

3. Regulation 13 of the Cleanliness (Food) Regulations 1931 is hereby amended by adding at the end thereof the following sub-regulation:—

"(2) This Regulation shall not be deemed to prohibit the use for holding, carrying, or storing wheat, oats, maize, or other grain of any bag by reason only of its having been used previously to hold superphosphate or sulphate of ammonia, or both, provided that all traces of such fertilizer have been removed from such bag by washing, and that such bag is otherwise clean."

And the Honorable Albert Arthur Dunstan, His Majesty's Minister of Health for the State of Victoria, shall give the necessary directions herein accordingly.

### CITY OF PRAHRAN.

#### BY-LAW No. 205.

A By-law of the City of Prahran, made under the provisions of the Local Government Acts, and numbered 205, for—

- (a) regulating the Market place and the buildings, stalls, pens, and standings therein and for preventing nuisances or obstructions therein or in the immediate approaches thereto;
- (b) fixing the days and the hours during each day on which the Market shall be held;
- (c) preventing the sale or exposure for sale of unwholesome provisions in the Market;
- (d) regulating the use of the weighing machines provided by the Council; and
- (e) repealing all By-laws and regulations inconsistent therewith.

**I**N pursuance of the powers conferred by the Local Government Acts and of every other power it thereunto enabling, the Mayor, Councillors, and Citizens of the City of Prahran order as follows:—

#### *Repeal.*

1. From and after the commencement of this By-law, By-law No. 130, passed by the Council on the 31st day of January, 1911, confirmed on the 27th day of February, 1911, and gazetted on the 8th day of March, 1911, is hereby repealed.

*Operation of By-law.*

2. This By-law shall apply to and have operation throughout the whole of the Market known as the "Prahran Municipal Market" within the Municipal District of the City of Prahran, being parts of Crown portion 36 in the Parish of Prahran, County of Bourke, and being the lands described in the Schedule to this By-law.

*Times for Holding Market.*

3. The parts of the Market being the lands described in Part One of the said Schedule shall (subject to the provisions of clause 33 of this By-law) be open for the retail sale only, and delivery therein to the public of marketable commodities, goods, wares, and merchandise at the following times:—

On the Tuesday of each week from Eight o'clock ante meridiā to Five o'clock post meridiā.

On the Friday of each week from Eight o'clock ante meridiā to Six o'clock post meridiā; and

On the Saturday of each week from Eight o'clock ante meridiā to One o'clock post meridiā

provided that should any Tuesday be a Public Holiday then the last-mentioned lands shall be open on the succeeding Wednesday, and should any Friday be a Public Holiday then the last-mentioned lands shall be open on the preceding Thursday.

The hour of closing of the Market shall be announced by the ringing of a bell.

*Trading Within Market Hours.*

4. Subject to the provisions of clause 33 of this By-law, no person shall either personally or by his servant or agent sell or offer or deliver in the Market any marketable commodity before the opening or after the closing of the Market or before or after the time appointed by law for the sale of such marketable commodity. No persons other than officers or employees of the Council shall be or remain in the Market on Mondays and Thursdays after six o'clock post meridiā on those days or on any Wednesday, not being a day succeeding a Public Holiday, except for the purpose of delivering meat or poultry thereto and for no other purpose, or after the expiration of one hour after the time for closing the Market on any day it is open for the purpose of trading as aforesaid but shall vacate the same with their vehicles and commodities.

*Duties of Market Superintendent.*

5. The duties of the Market Superintendent shall be generally to see that the provisions of this By-law are duly observed in and with respect to the Market, and further to take charge of the proper weights, scales, and measures for the time being, for weighing commodities sold in the market kept by the Council, and to use the same.

*Letting of Stalls, and Cleanliness Thereof.*

6. (1) The Market buildings, stalls, pens, standings, shops, enclosures, and spaces shall be appropriated to the sale of marketable commodities, garden, farm and dairy produce, goods, wares, and merchandise, and the same shall be let to occupiers for such days or periods, and on such conditions as the Council may from time to time direct.

(2) Every such occupier shall at all times keep his market building, stall, pen, standing, shop, enclosure, or space thoroughly cleansed, free from rubbish, garbage, or other waste material, and in an orderly condition to the satisfaction of the Market Superintendent.

*Rents, &c.*

7. The occupiers of every building, stall, pen, standing, shop, enclosure, and space in the Market shall pay therefor always in advance to the Officer of the Council duly authorized by the Council in that behalf, such stallages, rents, tolls, or dues as may be appointed by the Council, for such periods as the Council may from time to time resolve to let them.

*Use of Stalls, &c.*

8. Vendors of marketable commodities, goods, wares, and merchandise shall take up and occupy such buildings, stalls, pens, standings, shops, enclosures, or spaces in the Market as the Market Superintendent shall allot to them, and such buildings, stalls, pens, standings, shops, enclosures, or spaces shall be used for the purpose of retail trade only.

*Unauthorized Occupancy.*

9. No person other than the approved occupier of any building, stall, pen, standing, shop, enclosure, or space in the market shall take up or occupy the same without the

approval of the Market Superintendent first obtained and any person who takes up or occupies any building, stall, pen, standing, shop, enclosure, or space without the approval aforesaid shall, when requested so to do by the Market Superintendent forthwith cease to occupy the same and remove all his goods and chattels from the Market.

*Sub-letting, &c., Prohibited.*

10. No occupier of any building, stall, pen, standing, shop, enclosure, or space in the Market shall sell, sublet, assign, transfer, or otherwise dispose of the same, or any part thereof, or the goodwill (if any) of the business carried on thereat, or purport or attempt so to do.

*Weighing Food.*

11. Vendors of any goods offered for sale by them in the Market shall if so required by any purchaser or prospective purchaser thereof, or the Market Superintendent, or any other Officer of the Council forthwith, weigh or measure the same.

*Animals and Vehicles in Market.*

12. No person shall place or leave any horse or other animal, or any vehicle, in any part of the Market except with the express authority of the Market Superintendent first obtained, and in the manner and for the period of time allowed by him.

*Obstruction of Footways, &c.*

13. No person shall obstruct or place or leave any vehicle, produce, article, or thing whatsoever so as to obstruct any roadway, footway, or gutter in the Market, or any of the immediate approaches thereto, or neglect or refuse to remove any such vehicle, produce, article, or thing upon being required so to do by the Market Superintendent or other officer or employee of the Council, and upon such person failing to remove such obstruction to the Market Superintendent's satisfaction, the Market Superintendent may cause the same to be removed at the expense of the person causing such obstruction as aforesaid.

*Nails, &c., Not to be Fixed.*

14. No person shall place any nail, screw, hook, or peg in any part of the wood, stone, brick, or ironwork of any stall, pen, standing, shop, enclosure or space, or make any alteration therein without the prior approval or contrary to the directions of the Market Superintendent, or neglect or refuse to remove any such nail, screw, hook, or peg, or reinstate any such stall, pen, standing, shop, enclosure, or space (as the case may require) upon being required so to do by the Market Superintendent, and upon such person failing to carry out the requirement of the Market Superintendent to his satisfaction he may cause the same to be removed or reinstated (as the case may be) at the expense of the person so failing to comply, as aforesaid.

*Posters, Signs, &c.*

15. No person shall write, paint, stencil, draw upon or post, nail or otherwise fasten or exhibit any poster, sign, placard, handbill or notice of any kind within or on any part of the Market premises without the prior approval or contrary to the directions of the Market Superintendent, or neglect or refuse to remove the same upon being required so to do by the Market Superintendent.

*Sweeping of Rubbish, &c.*

16. No person shall place, throw, sweep, hose, or deposit, or cause to be placed, thrown, swept, hosed, or deposited any refuse, dirt, or rubbish of any kind into or upon any of the roads, footways, or gutters of the Market.

*Removal of Fat, &c.*

17. No holder of any building, stall, pen, standing, shop, enclosure, or space in the Market shall neglect or refuse to remove therefrom any refuse, fat, offal, or other matter when required so to do by the Market Superintendent.

*Assemblages.*

18. No assemblage of persons shall be held in the Market for other than Market purposes, unless with the previous approval of the Market Superintendent first obtained, and no person without such approval first obtained shall in the Market cause or induce the assemblage of any crowd or congregation of persons for other than the selling or buying of any commodities, goods, or wares in accordance with this By-law.

*Obstruction of Officers.*

19. No person shall obstruct, hinder, or resist the Market Superintendent or any officer or employee of the Council in the discharge of his duty in the Market or incite any person so to do.



*Entrances and Exits.*

20. The entrances to and exits from the Market for vehicles shall be as may from time to time be appointed by the Market Superintendent, and shall be denoted by the words "Way In" and "Way Out," but notwithstanding the same any person may be required to enter or leave the Market by such road or route as shall be pointed out to him by the Market Superintendent.

Subject to the provisions of Clauses 35 and 36 of this By-law, no person after the hour of 9.30 o'clock ante meridian on any day on which the Market is open shall drive, propel, or otherwise bring any vehicle into any part of the Market.

*Poultry.*

21. No person shall bring into or take out of the Market or offer or expose for sale therein any live poultry with the legs or wings of such poultry tied.

*Unwholesome Food.*

22. No person shall expose, sell, or offer for sale in the Market any unwholesome food or provisions, or attempt so to do under any pretence whatsoever.

*Unauthorized Sales.*

23. No person shall solicit or offer for sale any commodity in the Market without having first paid stallages, rents, tolls, or dues.

*Unauthorized Entry.*

24. No person other than the occupier of a stall, pen, standing, shop, enclosure, or space in the Market, or his employees, assistants, or invitees, or the Market Superintendent or other Officer or employee of the Council shall enter upon any portion of the same in the rear of the counter, bench, or stand thereof.

*Secondhand Clothing.*

25. No person shall sell, expose, or offer for sale in the Market, or bring into the Market for sale, delivery, barter, or exchange any unclean or verminous clothing, or any secondhand clothing unless the same shall have been previously thoroughly cleansed or disinfected.

*Soliciting Custom.*

26. No person occupying any stall, pen, standing, shop, enclosure, or space in the Market, or employed or engaged in connexion therewith shall solicit custom in the front of any other stall, pen, standing, shop, enclosure, or space.

*Conduct in Market.*

27. No person shall play at cards or other games, or bet or gamble in the Market, or loiter or trespass in the Market, or climb or attempt to climb on any roof, gate, stall, standing, shop, or enclosure, or space, or other portion of the Market premises, or wilfully or carelessly deface, break, injure, damage, or destroy, or improperly interfere with any portion thereof or any fixtures or fittings therein, or make any loud noise, outcry, disturbance, or sound in the Market, or play any musical or noisy instrument, or sing or harangue, and no person shall wash fruit, vegetables, or other articles therein by means of running water, nor light a fire other than in the places set aside for such purposes.

*Intoxicated Persons, &c.*

28. No person shall go into or appeal or remain in the Market in a drunken or disorderly state, or bring any intoxicating liquor therein, or incite any riot or disturbance, or curse or swear or use any gross indecent abusive or offensive language, or behave in an unseemly, improper, indecent, or offensive manner therein.

*Spitting Prohibited.*

29. No person shall spit or expectorate in the Market.

*Handbills, &c.*

30. No person shall give out, distribute, exhibit, or scatter any handbills, placards, notices, advertisements, books, pamphlets, or papers in the Market, or take up collections of money or goods therein without the approval of the Market Superintendent first obtained.

*Driving in Market.*

31. No person shall ride or drive any horse or any motor or other vehicle through or over any part of the Market except at a walking pace and then only over such parts thereof as are reserved for that purpose.

*Bicycles, Scooters, &c.*

32. No person shall bring into the Market or ride, use, or propel therein any bicycle, skates, scooter, sledge box on wheels, or other similar contrivance:

*Commercial-road and Market-street Shops.*

33. Any person occupying any shop, store, or other premises in the Market fronting and having direct access to Commercial-road or Market-street may open and keep open such shop, store, or other premises during such hours as are permitted by the *Factories and Shops Act 1928*, or any amendment thereof for the time being in force, for the class of business carried on therein, and no such person shall permit any member of the public to enter the Market through his shop or store before the opening or after the closing of the Market.

*Killing Places.*

34. (1) The parts of the Market being the lands described in Part 2 of the said Schedule (whereon are erected the buildings and other improvements known as "the Poultry Killing Shed") shall be open at the following times:—

On the Saturday of each week, from 7 o'clock ante meridian to noon.

On all other days except Sundays, Wednesdays, and Public Holidays, from 7 o'clock ante meridian to 5 o'clock post meridian.

Provided that should any Tuesday be a Public Holiday then the Poultry Killing Sheds shall be open on the succeeding Wednesday from 7 o'clock ante meridian to 5 o'clock post meridian.

(2) The Killing Places shall be used for the killing, cleaning, and dressing of poultry for retail sale only in the Market, and for no other purpose.

*Market Stables.*

35. The parts of the Market being the lands described in Part 3 of the said Schedule (whereon are erected the buildings and other improvements known as the "Market Stables") shall be open at the following times:—

On the Tuesday and Friday of each week, from 6 o'clock ante meridian to 6 o'clock post meridian.

On the Thursday of each week, from 8 o'clock ante meridian to 5 o'clock post meridian.

On the Saturday of each week, from 6 o'clock ante meridian to 1 o'clock post meridian.

Provided that should any Tuesday be a Public Holiday then the Market Stables shall be open on the succeeding Wednesday from 6 o'clock ante meridian to 6 o'clock post meridian, and should any Friday be a Public Holiday then the Market Stables shall be open on the preceding Thursday from 6 o'clock ante meridian to 6 o'clock post meridian.

*Market Parking Area.*

36. (1) The parts of the Market being the lands described in Part 4 of the said Schedule (known as the "Market Parking Area") shall be open for the free parking of motor vehicles by persons patronizing the Market and for that purpose only.

(2) No person may park a motor vehicle therein for a period longer than one hour (whether consecutive or not) on any day and then only when there is a vacant position.

*Obedience to Lawful Directions.*

*Enforcement of By-law.*

40. Every person who shall be guilty of an offence against any of the provisions of this By-law shall be liable for each first offence to a penalty not exceeding Ten pounds and for every subsequent offence to a penalty not exceeding Twenty pounds. In the event of any offence being continued after a conviction or order imposed or made on or against such person by any Court, such person shall be liable to a further penalty of Five pounds for each day such offence is continued.

*Interpretation.*

41. In this By-law, unless inconsistent with the context or subject matter "Market Superintendent" includes any Officer of the Council for the time being authorized to act in his stead.
