DETERMINATION OF A WAGES BOARD ADJUSTED PURSUANT TO SECTION 21 OF THE FACTORIES AND SHOPS ACT 1934 (No. 4275).

I, Raymond Henry Beers, Secretary for Labour, in pursuance of the powers conferred by the Factories and Shops Acts, hereby make and issue the following adjusted Determination of the Wages Board referred to hereunder showing adjusted rates and prices to operate from the beginning of the first pay period to commence in February, 1948.

A Zone Manager shall, in addition to his ordinary wage, be entitled to the following allowance for each additional theatre, theatrette, or concert hall supervised:—

Schedule "A".

£1 per week with a maximum of £4 per week.

Schedule "B".

15s. per week with a maximum of £3 per week.

Schedule "C".

10s, per week with a maximum of £2 per week.

Schedule "D",

7s. 6d. per week with a maximum of £1 10s. per week.

Schedule "E".

5s. per week with a maximum of £1 per week.

(b) Casual Rates,

- (i) Casual employees in Schedules "A", "B", or "C" shall be paid one-sixth of the appropriate weekly rate for each performance.
- (ii) Casual employees in Schedules "D" or "E" shall be paid one-seventh of the appropriate weekly rate for each performance.
 - (iii) For the purpose of this sub-clause a casual means an employee other than one engaged by the week.

Clauses, other than clause 2, of the said Determination shall remain in force.
