Land Act 1928.

AREA OF LAND COMPRISED IN CERTAIN CLASS DIMINISHED OR INCREASED.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.,

WHEREAS by the *Land Act 1928* it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the *Government Gazette*, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I., Division 1, section 5, of the said *Land Act 1928*, but that the area of lands which may be sold by auction (Class 6) shall not be increased except as in certain cases in the said Act provided: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the *Land Act 1928* aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 2 and 7 of the classes mentioned in section 5 of the *Land Act 1928* aforesaid to the extent set forth in the subjoined Schedule (that is to say):—

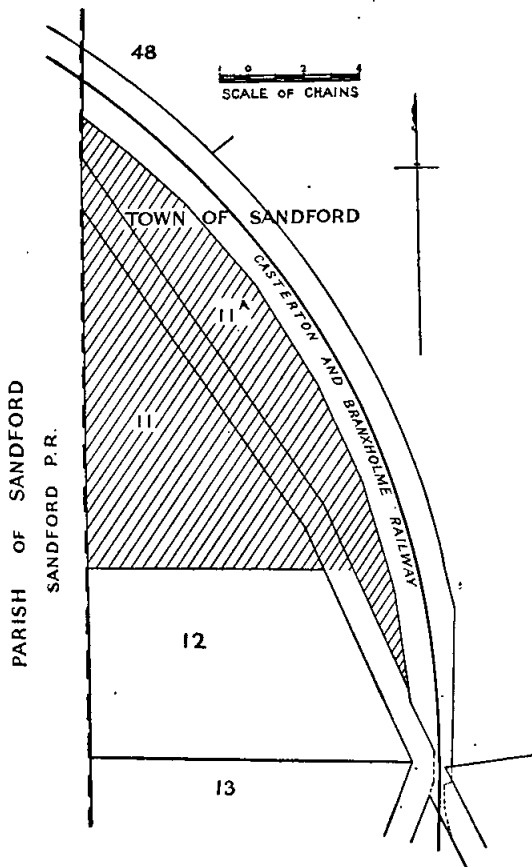

ADDITIONS TO A WEIGHTS AND MEASURES UNION.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS the Cities of Richmond, Hawthorn, Camberwell, Kew, Box Hill, and Nunawading, and the Borough of Ringwood, do constitute a union for the purposes of the *Weights and Measures Act 1928*: And whereas the Councils of all the aforesaid municipalities have requested that the Shires of Doncaster and Templestowe, Healesville, Lillydale, and Upper Yarra be added to such union: Now therefore I, the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, do by this my Proclamation declare that, as from the first day of July, 1948, the Shires of Doncaster and Templestowe, Healesville, Lillydale, and Upper Yarra shall be added to and form part of such union, and do fix as follows the proportion in which the expenses devolving upon such union under the said Act shall be borne by the several municipalities as from the said first day of July, 1948, that is to say:—

And, further, I do hereby fix as two the number of managers each Council in the said union shall elect.

WERRIBEE SHIRE COUNCIL WATER SUPPLY DISTRICT.

RATING BY-LAW FOR THE YEAR ENDING 30TH SEPTEMBER, 1948.

THE Werribee Shire Council, in pursuance and exercise of the powers conferred by the Water Acts, doth hereby make a rate for the supply of water for domestic purposes of Sixteen pence in the pound of the annual municipal valuation of lands and tenements liable to be rated within the Werribee Water Supply District.

Provided that in no case shall the amount of rate payable per annum in respect of any tenement (other than land on which there is no building) be less than Forty shillings, and in respect of any land on which there is no building less than Ten shillings.

Such rates are made and shall be levied upon the occupiers or owners of the said lands and tenements for the year ending on the 30th day of September, 1948, and shall be payable on the 15th day of May, 1948, at the office of the said local governing body, Shire Hall, Werribee.

The maximum quantity of water to be supplied in any one year without further charge to any property rated by the Council is hereby fixed at the quantity which, at a charge of Sixteen pence per 1,000 gallons, would produce an amount equal to the amount of the rate levied on such property for the said year.

The charge for water supplied by measure to any property rated by the Council in excess of such maximum quantity, computed as in the last preceding clause, is hereby fixed at Twenty-one pence per 1,000 gallons.

The charge for water supplied by measure to any property not rated by the Council is hereby fixed at Twenty-one pence per 1,000 gallons, and the minimum quantity of water to be charged for in cases where water is so supplied is hereby fixed at 30,000 gallons.

The charge for water supplied by measure shall be payable, on demand, at the office of the Council.

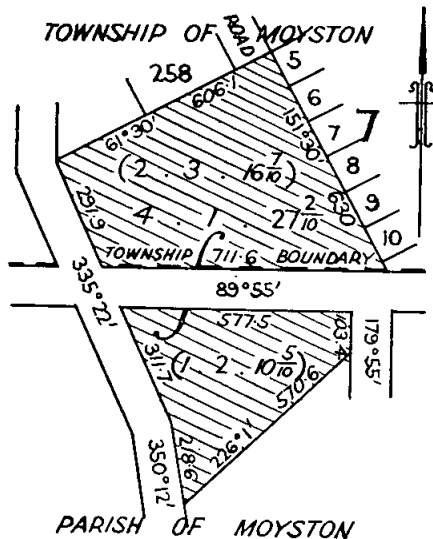

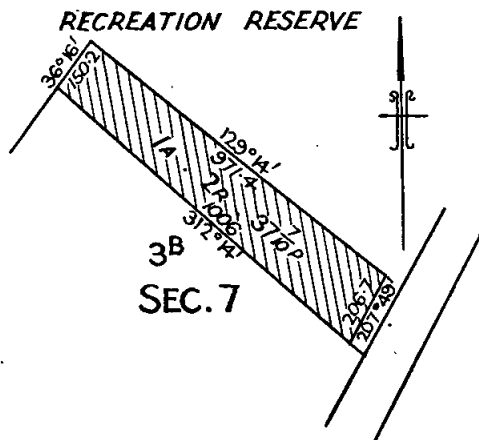

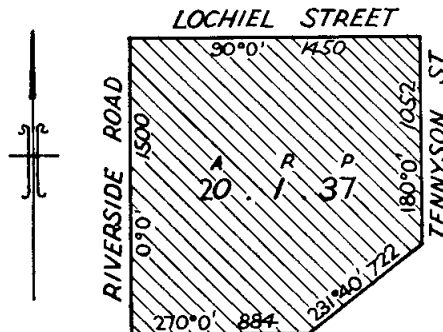

8. Where permission to fence has been granted, the outgoing tenant has the option to remove any existing fencing owned by him within one month, or he may arrange with the incoming tenant to pay for it in accordance with the provisions of section 124, Land Act 1928.

A By-law of the Shire of Alberton, made under the provisions of section 197 (1) (xxxi) (d) of the *Local Government Act 1946*, and numbered 41, for authorizing the placing on roads in situations approved by the municipal engineer (subject in the case of State highways, main roads, and tourists' roads, to the further approval of the Country Roads Board) of stands or platforms for milk and cream cans, and prescribing the nature and size and regulating the use of such stands and platforms.

IN pursuance of the powers conferred by the *Local Government Act 1946* and every other power it thereunto enabling the President, Councillors, and Ratepayers of the Shire of Alberton order as follows:—

1. In this By-law, unless the context otherwise requires:—

"Council" means the Council of the Shire of Alberton.

"Engineer" means the officer appointed by the Council to carry out the duties of shire engineer.

"Stands or platforms" includes any existing stand or platform on any road.

"Formation" means that portion of the road prepared for the use of traffic and includes the pavement of the road.

2. The Council may authorize the owner or occupier of any property, who is engaged in dairy farming and the production of milk or cream, to erect a stand or platform on any road to facilitate the collection of such milk or cream.

No person other than an owner or occupier so authorized shall erect or commence to erect any such stand or platform.

3. Every such owner or occupier, prior to the erection of any such stand or platform, shall make written application to the Council for permission so to do, and shall not erect or commence to erect any such stand or platform without the written consent of the Council, and where the stand or platform is to be erected on any State highway, main road, or tourist road without the further written consent of the Country Roads Board.

4. Every such owner or occupier in his application to the Council for permission to erect a stand or platform shall state—

(a) his full name, address, and occupation,

(b) the materials proposed to be used,

(c) the dimensions and height of the proposed stand or platform from the ground,

(d) the distance of the proposed stand or platform from the centre of the trafficable portion of the road,

(e) the Crown allotment number of his property and the nature of his interest therein,

and his application shall be accompanied by a sketch plan showing the location of the proposed stand or platform with regard to the formation and road boundaries, and the direction and course of travel to be made in collecting milk or cream therefrom.

5. Every such owner or occupier who is granted permission to erect a stand or platform shall—

(a) erect the same of sound materials approved by the Engineer and in a workmanlike manner;

(b) keep the same in good and substantial repair;

(c) erect the same in such position approved by the Engineer as will ensure that when cream or milk is being collected therefrom the collecting vehicle will not obstruct other traffic using the road;

(d) construct and maintain at his own expense such gravel or other tracks from the edges of the trafficable portion of the road to the stand or platform as the Engineer may order;

(e) forthwith remove any stand or platform when ordered so to do by the Council.

6. Every owner or occupier in respect of whose property any stand or platform has been erected prior to the coming into operation of this by-law and without the permission of the Council shall, within three months from the commencement hereof, supply the Council with details of the location and construction thereof.

7. On the refusal, failure, or neglect of any owner or occupier to remove or repair, as the case may be, any stand or platform erected, whether before or after the coming into operation of this By-law, for use in respect of property owned or occupied by him after fourteen days notice in writing from the Council it shall be lawful for the Council by its workmen or agents to remove such stand or platform and to dispose of the materials thereof as it deems fit and to reimburse itself from the proceeds of such disposal for all expenses incurred by it in such removal and disposal.

8. Any wilful contravention of the foregoing provisions by act or omission shall be an offence against this By-law, and every person who is guilty of such offence shall be liable on conviction to a penalty not exceeding Ten pounds.

9. This By-law shall apply to and have operation throughout the whole of the municipal district of the Shire of Alberton.

SHIRE OF ALBERTON.

BY-LAW No. 40.

A By-law of the Shire of Alberton, made under the provisions of section 197 of the *Local Government Act 1946*, and numbered 40, for appointing in streets and roads standing places for motor cars and providing for openings through any such standing places; for prohibiting the leaving (whether unattended or not) of motor cars or other vehicles in any street or road or part thereof specified in the By-law, and for regulating traffic.

IN pursuance of the powers conferred by the *Local Government Act 1946* and every other power it thereunto enabling the President, Councillors, and Ratepayers of the Shire of Alberton order as follows:—

1. In this By-law and the Schedules thereto, unless the context otherwise requires:—

"Council" means the Council of the Shire of Alberton.

"Driver" includes any person in charge of a motor car or other vehicle.

"Park" means to leave standing (whether unattended or not) any motor car or other vehicle or a bicycle.

"Limit of Parking" where parking lines are painted on a street or road means within the adjacent lines indicating the space in which a motor car may be parked.

"Motor Car" means a motor car, within the meaning of section 3 of the *Motor Car Act 1928*, not being a vehicle of any class for which stands may be fixed or appointed by the Council of any municipality under the powers conferred by any enactment other than sub-section 1 (22) of section 197 of the *Local Government Act 1946*.

"Parking Area" means any standing place for motor cars appointed by the Council under any By-law.

"Parking Lines" means the lines painted on streets or roads to indicate the position to be taken up by a motor car and to define the limit of space within which a motor car shall be parked.

2. This By-law shall apply to and have operation throughout that portion of the municipal district within the Township of Yarram, which is set out in the Schedules hereto.

PART 1.—MOTOR CARS.

3. The streets, roads, and parts of streets and roads set out in the Schedules hereto hereinafter called "the parking areas" shall be and are hereby appointed standing places for motor cars.

4. The method of parking in the several parking areas shall be as set out in column 2 of the Schedules hereto opposite the parking area described in column 1 of each of the said Schedules, and no person shall use or employ any other method of parking therein.

5. Every driver of a motor car shall in any parking area conform to the following requirements:—

- (a) Comply with directions given by the Council's parking attendant in charge if an attendant is present, or
- (b) if no such attendant is present shall take up his position in the order of his arrival thereat and in such manner as will enable him to take up or leave such position without disturbance to a motor car already parked, and in such a manner as not to cause obstruction to a motor car parking or moving from the place occupied by it.

6. A driver of a motor car shall not cause, allow, or permit—

- (a) a motor car to be parked or left standing in such manner as to extend beyond the painted lines marking the limit of parking in any parking area;
- (b) a trailer attached to a motor car to be parked in any area in which angle parking only is permitted;
- (c) a motor car having a greater overall length than 20 feet to be parked in any area in which angle parking only is permitted;
- (d) a motor car, with or without a trailer attached, to be parked in that part of the south side of Yarram-street between Commercial-road and Nicol-street, which part is reserved for the parking of motor omnibuses;
- (e) a motor car to be parked within 6 feet of any line running across Commercial-road, indicating and marked as indicating a pedestrian crossing;
- (f) a motor car to be parked in any position which will obstruct ingress to and egress from any parking area;
- (g) a motor car to be parked elsewhere in a street than in a parking area appointed under this By-law;
- (h) a motor car to be parked in any position prohibited as set out in Regulation 26 of the Road Traffic (Country) Regulations 1944. (Copy of clause 26 is set out at the foot of this By-law for the information of persons consulting this By-law).

7. The Council may by Resolution from time to time—

- (a) discontinue for such period as it thinks fit any standing place for motor cars appointed under any By-law; and
- (b) may appoint or employ officers and attendants for any standing places so appointed and remove any such officer or attendant.

8. No person not being an officer or employee of the Council or otherwise shall destroy, remove, or in any other manner interfere with any notice (including any standard or other erection supporting any such notice) which has been fixed or placed by the said Council upon any street, roadway, or building or other public place or upon any verandah or other building for the purposes of or in connexion with this By-law.

9. No person not being an officer or employee of or otherwise authorized by the Council shall paint or affix any notice or sign relating to the parking of cars or other vehicles or to the regulating of traffic on any street or footway.

PART 2.—BICYCLES.

10. No person shall cause or allow or permit a bicycle to be parked in that portion of the Township of Yarram set out in the First Schedule hereto—

- (a) so that such bicycle leans against any window or the front portion of any building, or
- (b) elsewhere on the roadway than in a rack provided by the Council and marked "Bicycles."

PART 3.—PENALTY.

11. Any wilful contravention of the foregoing provisions by act or omission shall be an offence against this By-law, and every person who is guilty of such offence shall be liable upon conviction to a penalty not exceeding Ten pounds.

Clause 26 of Road Traffic (Country) Regulations 1944.

The driver of a vehicle (other than a tram-car) shall not permit such vehicle to remain stationary in any of the following places:—

- (i) Within 30 feet of an intersection.
- (ii) Within 30 feet of a place on a tram route indicated by either of the notices "Cars Stop Here" or "Hall Cars Here," and on the side thereof which is the nearer to approaching vehicular traffic.
- (iii) Between a safety zone and the adjacent footway or within 20 feet of points on the kerb immediately opposite the ends of a safety zone.
- (iv) Within 15 feet of a fire hydrant or a postal pillar box or a petrol pump erected on the kerb of any street.
- (v) In front of a right-of-way, passage, or private drive;
- (vi) Alongside or opposite any street, excavation, or obstruction when traffic would be thereby obstructed:

Provided that this Regulation shall not apply to a fire brigade vehicle standing at or near a fire hydrant or to a postal vehicle standing at or near a postal pillar box or to a motor car whilst being supplied with petrol from a petrol pump erected on the kerb of any street or to a horse or horse-drawn vehicle which is standing at or near a trough or other fixed receptacle for the purpose of watering such horse or to a bicycle standing in a bicycle rack erected by the Council of any municipality. Penalty, £10.
