MILK BOARD ACTS.

At the Executive Council Chamber, Melbourne, the twenty-seventh day of July, 1948.

PRESENT:

IN pursuance of the powers conferred by the Milk Board Acts and all other powers enabling him in that behalf, the Lieutenant-Governor, as Deputy for His Excellency the Governor of Victoria, with the advice of the Executive Council thereof, doth hereby approve the following Determination of Milk Prices by the Milk Board, such determination to take effect from the first day of August, 1948:—

DETERMINATION.

1. The minimum prices which shall be paid to owners of dairy farms, owners of Milk Depots and (in the case of sales other than sales by retail) to dairymen, for milk for sale or distribution in the metropolis shall be as follow:—
