Prices Regulation Act 1948. PRICES REGULATION ORDER No. 26.

AERATED WATERS-MANUFACTURED OR BOTTLED BY BOON SPA PTY. LTD., VICTORIA.

N pursuance of the powers conferred upon me by the *Prices Regulations Act* 1948, I, Michael Maurice Gloster, Acting Prices Decontrol Commissioner, hereby make the following Order:-

Citation.

1. This Order may be cited as Prices Regulation Order No. 26.

Definitions.

- 2. In this Order, unless the contrary intention appears-
- "6-oz. bottle" means a bottle containing 6 oz. or more but less than 12 oz.
- "12-oz. bottle" means a bottle containing 12 oz. or more but less than 24 oz.
 "24-oz. bottle" means a bottle containing 24 oz. or more but
- less than 40 oz.
- "40-oz. bottle or syphon" means a bottle containing not less than 40 oz.
- "Oz." means a fluid ounce or ounces as the case may be.
- "Aerated waters" means the varieties of aerated waters, mineral waters and fruit drinks specified in the First Schedule to this Order.
 "Fruit drink" means any drink made from fruit juice cordial,
- extract or syrup with the addition of water, soda water or other aerated water and with or without the addition of any other ingredient.

Maximum Prices-Sales other than by Retail.

- 3. I fix and declare the maximum price at which the aerated waters specified in the First Schedule to this Order may be sold other than by retail to be-
 - (a) where delivery is made to the purchaser's premises, the price (inclusive of sales tax) specified in the second, third, fourth and fifth columns of that Schedule, as the case requires:
 - (b) where delivery is not made to the purchaser's premises, the price (inclusive of sales tax) specified in the sixth, seventh, eighth and ninth columns of that Schedule, as the case requires.

Maximum Prices-Retail.

4. Notwithstanding the provisions of Prices Regulation Order No. 9, I fix and declare the maximum price (inclusive of sales tax) at which aerated waters specified in the Second Schedule to this Order may be sold by retail by Boon Spa Pty. Ltd. of Melbourne in the State of Victoria (including any deposit refundable on the bottle) to be the price specified therein, plus the amount of such deposit.

Discounts.

5. Where on the 16th day of September, 1948, the said Boon Spa Pty. Ltd. customarily allowed any discount in relation to sales other than by retail to any person or class of persons for payment of the purchase price within a certain time, the maximum price fixed by the foregoing provisions of this Order, or by Notice in Writing thereunder, in respect of sales to such person or class of persons upon payment of such purchase price within such time shall be subject to a deduction of a discount at the same rate as that so customarily allowed as aforesaid.

Dockets or Invoices.

- 6. Every person who, whether as a principal or as an agent or as a servant, sells, other than by retail, aerated waters manufactured by Boon Spa Pty. Ltd. shall deliver with such goods the original copy of a docket or an invoice prepared in duplicate containing the following particulars:—
 - (a) his name and place of business or where he is an agent
 or servant, the name and place of business of his
 principal or master (as the case requires);
 - (b) the name and address of the purchaser of such aerated waters;
 - (c) the date of sale of such aerated waters;
 - (d) the description of such aerated waters;
 - (e) the quantity of each size and of each variety of aerated waters sold;
 - (f) the price or rate charged for each size and variety of aerated waters sold;
 - (g) the total price of such aerated waters;
 - (h) the amount of any deposit charged for bottles and other containers in which the aerated waters are sold, such amount to be stated separately from the price of the goods sold as specified on such docket or invoice,

and such person shall retain and preserve the duplicate of the said docket or invoice for the period of two years from the date of the making thereof.

Fixation of Maximum Prices by Notice.

7. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which aerated waters specified in a Notice in pursuance of this paragraph may be sold by any person to whom such Notice is given to be such price as is fixed by the Commissioner by Notice in writing to that person.

BOTTLED AERATED WATERS AND MINERAL WATERS MANUFACTURERS—MELBOURNE METROPOLITAN AREA.

N pursuance of the powers conferred upon me by the Prices Regulation Act 1948, I, Michael Maurice Gloster, Acting Prices Decontrol Commissioner for the State of Victoria, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 27.

Application.

2. This Order shall apply to persons manufacturing aerated waters and mineral waters in the Melbourne Metropolitan Area, but nothing in this Order shall affect the operation of Prices Regulation Order No. 26.

Definitions.

- 3. In this Order, unless the contrary intention appears-
- "Melbourne Metropolitan Area" means all that area comprised within a radius of 20 miles from the General Post Office, Melbourne.
- "Oz." means fluid ounce or ounces as the case may be.
- "Fruit drink" means any drink made from fruit juice cordial, extract, or syrup with the addition of water, soda water, or other aerated water and with or without the addition of any other ingredient.

Interpretation.

4. The maximum prices fixed by the provisions of this Order include free delivery to the purchaser's store, where such store is situated within the Melbourne Metropolitan Area.

BOTTLED AERATED WATERS, MINERAL WATERS, AND AERATED FRUIT DRINKS.

5. If ix and declare the maximum price at which aerated waters, mineral waters or fruit drinks of the description set out in the second column of the Schedule to this Order and manufactured by the persons set out in the first column of such Schedule may be sold to retailers in the Melbourne Metropolitan Area to be the prices specified in the third column of such Schedule.

Variation of Maximum Prices by Notice.

6. Notwithstanding anything contained in the foregoing provisions of this Order, I declare the maximum price at which any aerated waters, mineral waters, or fruit drinks specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

Aerated Waters, Mineral Waters, Milk Drinks, Fruit Drinks— Retail—North Central Area.

N pursuance of the powers conferred upon me by the *Prices Regulation Act* 1948, I, Michael Maurice Gloster, Acting Prices Decontrol Commissioner for the State of Victoria, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 28.

Application.

2. This Order shall not apply to any sales by a licensed victualler.

Definitions.

3. In this Order, unless the contrary intention appears-

"North Central Area" means all that area of Victoria comprised in the City of Bendigo, the Boroughs of-

"Town of manufacture" means-

(a) where the goods are produced in Victoria, the actual town of manufacture, or

(b) where the goods are produced outside Victoria, the town in Victoria nearest to the place of manufacture.

"Fruit drink" means any drink made from fruit juice, cordial, extract or syrup with the addition of water, soda water or other aerated water and with or without the addition of any other ingredient.

"Pure fruit drink" means any drink made from fruit juice with the addition of water, soda water or other aerated water and

with or without the addition of any other ingredient. "Ice cream soda" means any drink made from fruit juice, cordial, extract or syrup with the addition of aerated water and one serve of ice cream.

"Milk drink" means any drink of which milk is the sole or principal ingredient.
"Oz." means fluid ounce or ounces as the case may be.

BOTTLED AERATED WATERS, AERATED FRUIT DRINKS, AND MINERAL WATERS.

Sales by the Bottle.

- 4. I fix and declare the maximum price at which the description of bottled goods manufactured by the persons set out in the first column of the First Schedule to this Order and described in the third column thereto may be sold in the North Central Area to be-
 - (a) in all that area comprised within a radius of 10 miles from the principal post office of the town of manufacture stated in the second column of the said Schedule, the price set out in the fourth column of such Schedule;
 - (b) in all that area comprised within a radius of 25 miles from the principal post office of the town of manufacture stated in the second column of the said Schedule, but outside a radius of 10 miles of the said post office, the price set out in the fifth column of such Schedule;
- (c) in all areas outside a radius of 25 miles from the principal post office of the town of manufacture stated in the second column of the said Schedule, the price set out in 7. 7 the sixth column of such Schedule.

Sales Other Than by the Bottle.

- 5. I fix and declare the maximum price at which any of the items specified in the Second Schedule to this Order may be sold other than by the bottle to be—
 - (a) where delivery is accepted at the counter, bar, or selfservice table on the premises of the vendor the price set out in the second column of the said Schedule.
 - (b) where the items specified are served at tables or in foyer bars situated within a theatre or public hall the price set out in the third column of the said Schedule.

Variation of Maximum Prices by Notice.

6. Notwithstanding anything contained in the foregoing provisions of this Order, I declare the maximum price at which any aerated waters, mineral waters, fruit drinks or milk drinks specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

Exhibition of Price List.

7. Every person who sells or has for sale by retail any goods, the maximum price of which is fixed by or under the provisions of this Order shall exhibit in a prominent position in his place of business or, if he has more than one place of business, in each of his places of business, in the form of a price list and in such a manner as to be easily legible to persons contemplating making any purchase or conducting any business at his place or places of business, particulars of the maximum prices fixed by or under the provisions of this Order for the sale by him of those goods, such notice to show separately the deposit charge (if any) for any container included in the selling price so exhibited.

 - (a) in all that area comprised within a radius of ten miles from the principal post office of the town of manufacture stated in the second column of the said Schedule, the price set out in the fourth column of such Schedule;

- (b) in all that area comprised within a radius of twenty-five miles from the principal post office of the town of manufacture stated in the second column of the said Schedule, but outside a radius of ten miles of the said post office, the price set out in the fifth column of such Schedule; and

Prices Regulation Act 1948. PRICES REGULATION ORDER No. 30.

AERATED WATERS, MINERAL WATERS, MILK DRINKS, FRUIT DRINKS— RETAIL—WIMMERA-MALLEE AREA.

N pursuance of the powers conferred upon me by the *Prices Regulation Act* 1948, I, Michael Maurice Gloster, Acting Prices Decontrol Commissioner for the State of Victoria, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 30.

Application.

2. This Order shall not apply to any sales by a licensed victualler.

Definitions.

- 3. In this Order, unless the contrary intention appears-

- "Town of manufacture" means-
 - (a) where the goods are produced in Victoria, the actual town or manufacture, or
 - (b) where the goods are produced outside Victoria, the town in Victoria nearest to the place of manufacture.
- "Fruit drink" means any drink made from fruit juice, cordial, extract or syrup with the addition of water, soda water or other aerated water and with or without the addition of any other ingredient.
- "Pure fruit drink" means any drink made from fruit juice with the addition of water, soda water or other aerated water and with or without the addition of any other ingredient.
- "Ice cream soda" means any drink made from fruit juice, cordial, extract or syrup with the addition of aerated water and one serve of ice cream.
- "Milk drink" means any drink of which milk is the sole or principal ingredient.
- "Oz." means fluid ounce or ounces as the case may be.

BOTTLED AERATED WATERS, AERATED FRUIT DRINKS AND MINERAL WATERS.

Sales by the Bottle.

- 4. If ix and declare the maximum price at which the description of bottled goods manufactured by the persons set out in the first column of the First Schedule to this Order and described in the third column thereto may be sold in the Wimmera-Mallee Area to be-
 - (a) in all that area comprised within a radius of 10 miles from the principal post office of the town of manufacture stated in the second column of the said Schedule, the price set out in the fourth column of such Schedule;
 - (b) in all that area comprised within a radius of 25 miles from the principal post office of the town of manufacture stated in the second column of the said Schedule, but outside a radius of 10 miles of the said post office, the price set out in the fifth column of such Schedule; and
 - (c) in all areas outside a radius of 25 miles from the principal post office of the town of manufacture stated in the second column of the said Schedule, the price set out in the sixth column of such Schedule.

Sales Other Than by the Bottle.

- 5. I fix and declare the maximum price at which any of the items specified in the Second Schedule to this Order may be sold other than by the bottle to be-
 - (a) where delivery is accepted at the counter, bar or selfservice table on the premises of the vendor the price set out in the second column of the said Schedule; or
 - (b) where the items specified are served at tables or in foyer bars situated within a theatre or public hall the price set out in the third column of the said Schedule.

Variation of Maximum Prices by Notice.

6. Notwithstanding anything contained in the foregoing provisions of this Order, I declare the maximum price at which any aerated waters, aerated fruit drinks, mineral waters, fruit drinks or milk drinks specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

Exhibition of Price List.

7. Every person who sells or has for sale by retail any goods, the maximum price of which is fixed by or under the provisions of this Order, shall exhibit in a prominent position in his place of business or, if he has more than one place of business, in each of his places of business, in the form of a price list and in such a manner as to be easily legible to persons contemplating making any purchase or conducting any business at his place or places of business, particulars of the maximum prices fixed by or under the provisions of this Order for the sale by him of those goods, such notice to show separately the deposit charge (if any) for any container included in the selling price so exhibited.
