AREAS OF LANDS COMPRISED IN CERTAIN CLASSES DIMINISHED OR INCREASED.

PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the Land Act 1928 it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the Government Gazette, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I., Division I, section 5, of the said Land Act 1928, but that the area of lands which may be sold by auction (Class 6) shall not be increased except as in certain cases in the said Act provided: Now therefore I, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the Land Act 1928 aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes I, 2, 3, 4, 6 and 7 of the classes mentioned in section 5 of the Land Act 1928 aforesaid to the extent set forth in the subjoined Schedule (that is to say):—



6. No person shall bring into the Reserve any dog, unless controlled by a chain or cord, without the permission, in writing, of the Committee of Management first obtained.

7. No person shall take part in any public entertainment of any sort in the Reserve, without the permission, in writing, of the Committee of Management first obtained.

8. No person shall camp in the Reserve, or erect therein

any building or any booth or other structure for the purpose of offering for sale any article, without the permission, in writing, of the Committee of Management first obtained.

9. No person shall spit or expectorate on the paths or on any structure or erection in the Reserve.

The Park shall be open to the public free of charge except on such days (not exceeding sixteen in any one year) as the Park may be set apart for entertainment, fêtes, sports, or holiday amusements, on any of which occasions a sum not exceeding Two shillings and six pence may be charged and taken for admission of every adult to the Park. 2. No person shall enter or remain in the Park who may offend against decency as regards dress, language, or

conduct.

the permission, in writing, of the Committee of Management, and then only in the place set apart for the purpose.

4. No person shall climb or jump over the fences or gates, stick bills thereon, or cut names, letters, or figures on the fences, trees, seats, or buildings in the Park, nor roll or throw stones or any missiles of any kind therein, nor remove any sand or soil from the Park.

5. No person shall bring into the Park any horses, cattle, sheep, goats, pigs, or other animals, or any poultry, without the permission, in writing, of the Committee of Management first obtained.

6. No person shall bring into the Park any dog unless.

6. No person shall bring into the Park any dog, unless controlled by a chain or cord, without the permission, in writing, of the Committee of Management first obtained.

- 7. No person shall camp in the Park, nor erect therein any building, nor any booth or other structure for the nurnose of offering for sale any article, without the permission, in writing, of the Committee of Management first obtained
- 8. No person shall take part in any public entertainment of any sort in the Park without the permission. in writing, of the Committee of Management first obtained.

No person shall spit or expectorate on the paths, or on any structure or erection in the Park.
 No person shall bet publicly in any part of the Park, and every person infringing this Regulation shall be liable

12. Instrumental music is prohibited in the Park on Sundays between the hours of Three o'clock and Four o'clock in the afternoon, also between the hours of Seven
