Land Act 1928.

AREAS OF LANDS COMPRISED IN CERTAIN CLASSES DIMINISHED OR INCREASED.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the *Land Act 1928* it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the *Government Gazette*, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I., Division 1, section 5, of the said *Land Act 1928*, but that the area of lands which may be sold by auction (Class 6) shall not be increased except as in certain cases in the said Act provided: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of sections 94 and 117 of the *Land Act 1928* aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 2, 3, 6 and 7 respectively of the classes mentioned in section 5 of the *Land Act 1928* aforesaid to the extent set forth in the subjoined Schedule (that is to say):—

PROCLAMATION

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

BY virtue of the powers conferred by the Health Acts, I, the Governor of the State of Victoria, in the Commonwealth of Australia, on the recommendation of the Commission of Public Health and by and with the advice of the Executive Council of the said State, do by this my Proclamation vary the Proclamation constituting the Corangamite Meat Area made on the eighteenth day of March, 1947, and published in the *Government Gazette* dated the twenty-sixth of March, 1947, at page 1907, as amended by any Proclamation, by deleting therefrom the expression:—

"This Proclamation shall take effect on the first day of March, 1950"—

and substituting therefor the expression—

"This Proclamation shall take effect on the first day of September, 1950."

PUBLIC HIGHWAY.—CITY OF NUNAWADING.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the *Local Government Act 1946* (No. 5203), section 518, it is amongst other things enacted that it shall be lawful for the Governor in Council at any time, and from time to time, upon the request of the council of any municipality, by notice in the *Government*

Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street, road, highway, thoroughfare, bridge, square, court, alley, or right-of-way to be a public highway, and that such land shall thereupon and thenceforth from the date of such Proclamation become and be absolutely dedicated to the public as a public highway within the meaning of any law then or thereafter in force: And whereas the Council of the City of Nunawading has requested that the land hereinafter mentioned, which has been used as a street within the said city, be so declared to be a public highway: Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this Proclamation declare the land used as a street hereinafter described, and situated within the City of Nunawading aforesaid, to be a public highway within the meaning of the said Act, viz.:—

PUBLIC HIGHWAY.—CITY OF NUNAWADING.

Charlotte-street.

All that piece of land, being part of Crown portion 96, Parish of Nunawading, County of Bourke, known as *Charlotte-street*, being part of the land described in certificate of title, volume 5244, folio 1048695, bounded by lines commencing at a point on the south building line of Canterbury-road at the north-west corner of lot 1 on lodged plan 10609; thence by a line bearing 224 deg. 6 min. for a distance of 11 ft. 2 in.; thence by a line bearing 178 deg. 13 min. for a distance of 668 ft. 9 in.; thence by a line bearing 270 deg. for a distance of 50 feet; thence by a line bearing 358 deg. 13 min. for a distance of 676 ft. 9 in.; thence by a line bearing 90 deg. along the south building line of Canterbury-road for a distance of 58 feet to the point of commencement.

The charge for water supplied by measure to any property rated by the Trust in excess of such maximum quantity, computed as in the last preceding clause, is hereby fixed at Nine pence per 1,000 gallons.

The charge for water supplied by measure shall be payable, on demand, at the office of the Trust.

The charge for the supply for watering gardens on un-metered premises shall be One pound per tenement.

For water supplied from standpipe or hydrant the charge for every 1,000 gallons, or portion of same, to be at the rate of Two shillings and six pence per 1,000 gallons, with a minimum of Six pence for any one tank or load.

Notwithstanding the payment of any charge by any owner or occupier, the Trust reserves the right to cut off the supply of water from any premises if such owner or occupier shall wilfully or negligently allow water to run to waste, or who uses it in an unauthorized manner.

When the water is cut off from any premises the owner or occupier must pay the sum of One pound to be re-connected to the main.

Water must not be used for gardens between the hours of 8 o'clock p.m. and 6 o'clock a.m.

Such person or persons as the Commissioners of the said Trust may from time to time appoint for the purposes, are hereby authorized to collect and recover the said rates and charges.

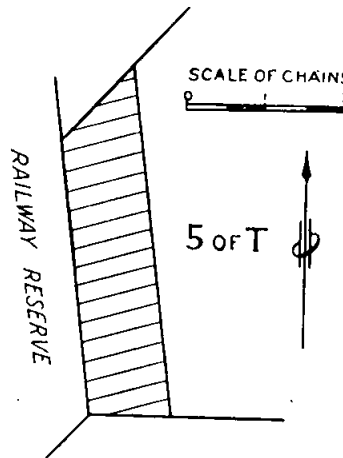

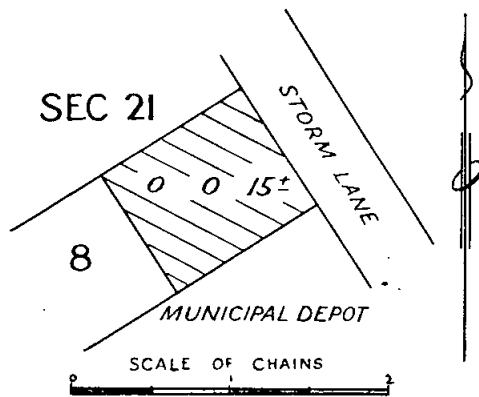

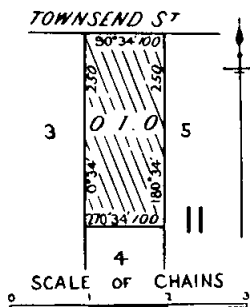

CAMPERDOWN SEWERAGE AUTHORITY.

SEWERAGE DISTRICT PROCLAIMED AND AUTHORITY CONSTITUTED.

(2) Any person applying for such consent shall—

- (a) make application in writing to the Council;
- (b) state in the application the full name and address of the applicant and the name of the club or organization on whose behalf the application is made;
- (c) state the nature of the sport or game, the date and hours between which it is proposed to be played, and the number of players;
- (d) state the particular reserve on which it is desired to play;
- (e) make a separate application for every day on which consent is required;
- (f) supply such additional information as the Council requires.

(3) The Council may—

- (a) grant the application with or without such conditions as it thinks fit; or
- (b) refuse the application.

2. Any person receiving the written permission of the Council to use any reserve for any organized competitive game or sport aforesaid shall be responsible for any wilful damage which may be done to the reserve or appurtenances during the period of the permissive occupancy granted by the permit.

3. No person shall make any charge for admission into any reserve or make any collection therein.

4. No person shall practise or engage in the game of golf in any reserve.

5. No person shall engage in any unlawful game or games in any reserve or bet or conduct any wagering transaction therein.

6. No person shall enter any reserve in a state of intoxication or take any intoxicating liquor therein.

7. This By-law shall have operation throughout the whole of the municipal district of the City of Moorabbin.

On an average, ten words make a line.

Every signature must likewise be counted as a line.

The final words of a paragraph, though only portion of a line, must be counted as one line.

VARIATION OF SUMMER PERIOD IN RESPECT OF SPECIFIED
PARTS OF THE COUNTRY AREA OF VICTORIA.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by sub-section two of section four of the *Country Fire Authority Act 1944*, it is enacted that the Governor in Council, after consultation by the Chief Secretary of Victoria with the Minister of Forests, may from time to time by Proclamation published in the *Government Gazette* proclaim any period as the summer period in respect of the country area of Victoria, or any specified part or parts thereof and, without affecting the generality of the foregoing, may proclaim different summer periods in respect of different parts of the said country area:

And whereas by the said sub-section, it is further enacted that any Proclamation so published shall remain in force until revoked, amended, or varied by a subsequent Proclamation so published:

And whereas by Proclamations issued on the sixth day of December, 1949; the fifteenth day of December, 1949; and the nineteenth day of December, 1949, and published in the *Government Gazette* of the seventh day of December, 1949; the fifteenth day of December, 1949; and the twenty-first day of December, 1949, respectively, different summer periods expiring on the thirty-first day of March, 1950, were proclaimed in respect of different parts of the country area of Victoria, including the parts of the said country area specified in the Schedule hereto:

And whereas it is deemed expedient that the aforesaid Proclamations should be varied in the manner hereinafter described:

And whereas the Chief Secretary and the Minister of Forests have consulted accordingly:

Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the powers conferred by the Country Fire Authority Acts, do by this my Proclamation vary the aforesaid Proclamations by proclaiming that the summer period in respect of the parts of the country area of Victoria which are specified in the Schedule hereto shall end on the fifteenth day of March, 1950.

SCHEDULE.

- The First Fire Control Region comprising the municipal districts of the City of Ballarat, the Borough of Sebastopol, and those portions of the municipal districts of the Shires of Ballarat and Buninyong within the aforesaid Fire Control Region;
- The Second Fire Control Region comprising the municipal districts of the City of Bendigo, the Borough of Eaglehawk, and those portions of the municipal districts of the Shires of Marong and Strathfieldsaye within the aforesaid Fire Control Region;
- The Third Fire Control Region comprising the municipal districts of the Cities of Geelong, Geelong West, and Newtown and Chilwell, and those portions of the municipal districts of the Shires of Corio and South Barwon within the aforesaid Fire Control Region;
- The Sixth Fire Control Region comprising the municipal districts of the Town of Colac and the Shires of Otway, Colac, Heytesbury, and Hampden;
- The Seventh Fire Control Region comprising the municipal districts of the Borough of Queenscliffe, the Shires of Leigh, Bannockburn, Winchelsea, Barrabool and Bellarine and those portions of the municipal districts of the Shires of Corio and South Barwon within the aforesaid Fire Control Region;
- The Eighth Fire Control Region comprising the municipal districts of the Borough of Wonthaggi, and the Shires of Bass, Berwick, Cranbourne, Frankston and Hastings, Mornington, Flinders and Phillip Island, and French Island;
- The Ninth Fire Control Region comprising the municipal districts of the Shires of Buln Buln, Narracan, Warragul, Mirboo, Woorayl and Korumburra;

- The Fifteenth Fire Control Region comprising the municipal districts of the Boroughs of Clunes, Maryborough and Daylesford, the Shires of Tullaroop, Newstead, Talbot, Glenlyon, Bungaree, Ballan, Grenville, Kyneton, and Creswick, and those portions of the municipal districts of the Shires of Ballarat and Buninyong within the aforesaid Fire Control Region;
- The Sixteenth Fire Control Region comprising the municipal districts of the Town of Ararat, the Borough of Stawell, and the Shires of Ararat, Avoca, Lexton, Ripon and Stawell;
- Those parts of the Nineteenth Fire Control Region comprising the municipal districts of the Boroughs of Inglewood and St. Arnaud, and the Shires of Bet Bet, Kara Kara and Korong;
- Those portions of the Twenty-first Fire Control Region comprised by the municipal districts of the Town of Castlemaine, the Shires of East Loddon, Huntly, Maldon, and Metcalfe and those portions of the Shires of Marong and Strathfieldsaye within the aforesaid Fire Control Region;
- The Twenty-second Fire Control Region comprising the municipal districts of the City of Shepparton, the Borough of Echuca, and the Shires of Deakin, Euroa, Goulburn, McIvor, Numurkah, Pyalong, Rodney, Seymour, Shepparton, Tungamah, Violet Town and Waranga;
- The Twenty-third Fire Control Region comprising the municipal districts of the Boroughs of Benalla and Wangaratta and the Shires of Benalla, Oxley, Rutherglen, Wangaratta and Yarrowonga;
- and the Twenty-fourth Fire Control Region comprising the municipal districts of the Shires of Beechworth, Bright, Chiltern, Towong, Upper Murray, Wodonga and Yackandandah.
