Prices Regulation Acts.

PRICES REGULATION ORDER No. 191.

Woollen Clothing, Bathing Costumes, Piecegoods, Elastic and Threads.

IN pursuance of the powers conferred upon me by the Prices Regulation Acts, I, John Francis Waldron, Prices Decontrol Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 191.

Definitions.

- 2. In this Order, unless the contrary intention appears-
 - "Specified goods" means goods of the following kinds and descriptions:—
 - (a) Bathing costumes and trunks, ladies' woollen underwear, clothing garments and apparel of all kinds and descriptions manufactured partly or wholly from wool or from material containing wool;
 - (b) Fabrics of all kinds whether knitted, lockstitched or woven, including waterproofed or rubberized fabrics and including piecegoods of all types and descriptions;
 - (c) Elastic;
 - (d) Threads and twists of cotton, artificial silk or silk, except when used for the purpose of hand crocheting, hand knitting or hand embroidery.
 - "Prevailing price" means, in relation to the sale of specified goods by any person, the price at which that person sold goods on the 20th day of October, 1950, upon substantially the same terms and conditions, or if no sale of specified goods was made by that person upon that date on substantially the same terms and conditions, then the last preceding date upon which a sale was made by that person upon substantially the same terms and conditions.
 - "Manufacturer" means any person who, by his own labour or that of his employees, or by handing out the work to any other person, manufactures or causes to be manufactured any specified goods.

- "Wholesale merchant" means a person who purchases specified goods from—
 - (a) a source outside the Commonwealth of Australia; or
 - (b) a person in the Commonwealth of Australia, being the manufacturer of such goods,

and sells those goods by wholesale.

"Retail trader" means a person who purchases any specified goods in a manufactured state and resells or offers for sale such goods by retail.

Maximum Price—Sale by Manufacturer.

- 3. I fix and declare the maximum price at which any specified goods may be sold by a manufacturer to be—
 - (a) where the specified goods are ready-made clothing of a description covered by Prices Regulation Order No. 90, the maximum price determined in accordance with the provisions of that Order; and
 - (b) where the specified goods are not of a type to which subparagraph (a) hereof refers, the prevailing price.

Maximum Price-Sale by Wholesale.

- 4. I fix and declare the maximum price at which any specified goods may be sold by a wholesale merchant to be—
 - (a) where such specified goods are ready-made clothing of a description covered by Prices Regulation Order No. 90, the maximum price determined in accordance with the provisions of that Order;
 - (b) where such specified goods are piecegoods or drapery of a description covered by Prices Regulation Order No. 112, the maximum price determined in accordance with the provisions of that Order; and
 - (c) where such specified goods are not of a type to which sub-paragraphs (a) and (b) hereof refer, the prevailing price.

Maximum Price-Sale by Retail.

- 5. If ix and declare the maximum price at which any specified goods may be sold by a retail trader to be—
 - (a) where the specified goods are goods of a type referred to in the First Schedule of Prices Regulation Order No. 169, the maximum price fixed in accordance with the provisions of that Order; and
 - (b) where the specified goods are not of a type to which sub-paragraph (a) hereof refers, the prevailing price.

Fixation of Maximum Price by Notice.

6. Notwithstanding anything contained in the foregoing provisions of this Order, I declare the maximum price at which any specified goods may be sold by any person to whom a notice in pursuance of this clause is given to be such price as is fixed by the Prices Decontrol Commissioner by notice in writing to that person.

PRICES REGULATION ORDER No. 192.

SUNDRY GOODS AND SERVICES.

N pursuance of the powers conferred upon me by the Prices Regulation Acts, I, John Francis Waldron, Prices Decontrol Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 192.

Application.

2. This Order shall apply to the goods and services specified in the Schedule hereto.

Definitions.

3. "Prevailing price or rate" means, in relation to the sale of specified goods or the supply of a specified service by any person, the price or rate at which that person sold goods or supplied the service

on the 20th day of October, 1950, upon substantially the same terms and conditions, or if no sale of specified goods or supply of specified service was made by that person on that date, on substantially the same terms and conditions, then the last preceding date upon which a sale or service was supplied by that person upon substantially the same terms and conditions.

" Specified goods or service" means the goods or service specified in the Schedule hereto. $\,$

Maximum Price or Rate.

 $4.\$ I hereby fix and declare the maximum price or rate at which any specified goods or service may be sold or supplied to be the prevailing price or rate.

Maximum Prices and Rates for Goods or Services not Previously Sold or Supplied.

5. I fix and declare the maximum price or rate, as the case may be, at which any person may sell any specified goods or supply any specified service which are not substantially identical with any goods or service which he sold or supplied on or prior to the 20th day of October, 1950, to be the cost of the goods or the service to that person: Provided that on application by any person the maximum price or rate at which those goods may be sold or that service may be supplied by that person shall be such price or rate as is fixed by notice by the Prices Decontrol Commissioner in writing to that person.

Fixation of Maximum Price or Rate by Notice.

6. Notwithstanding anything contained in the foregoing provisions of this Order, I declare the maximum price or rate at which any specified goods or specified service may be sold or supplied by any person to whom a notice in pursuance of this clause is given to be such price or rate, as the case may be, as is fixed by the Prices Decontrol Commissioner by notice in writing to that person.
