Prices Regulation Acts.

PRICES REGULATION ORDER No. 206.

PETROLEUM AND SHALE PRODUCTS—MOTOR SPIRIT.

IN pursuance of the powers conferred upon me by the Prices Regulation Acts, I, John Francis Waldron, Prices Decontrol Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 206.

Revocation.

2. Prices Regulation Order No. 127 is hereby revoked.

Definitions.

3. In this Order, unless the contrary intention appears:—

“Motor Spirit” means a liquid petroleum or shale product normally marketed for use as fuel in internal combustion engines with spark ignition, excluding power kerosene, but including such motor spirit blended with distillate from coal products or with alcohol;

“Metropolitan Area” means all that area comprised within a radius of 20 miles from the General Post Office, Melbourne.

Maximum Price.

4. I fix and declare the maximum price at which motor spirit may be sold by retail to be:—

- (a) in the Metropolitan Area—Three shillings and one penny per gallon;
- (b) outside the Metropolitan Area—the sum of the purchase price paid or payable to the wholesale seller plus Three pence three farthings per gallon. Provided that where the maximum price so calculated results in a price not exactly divisible by one half penny, the maximum price may be determined at the nearest upward halfpenny.

Fixation of Maximum Prices by Notice.

5. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which motor spirit specified in a notice given in pursuance of this clause may be sold by any person to whom such notice is given to be such price as is fixed by the Prices Decontrol Commissioner by notice in writing to that person.

Prices Regulation Acts.

PRICES REGULATION ORDER No. 207.

TOBACCO, CIGARETTES AND CIGARETTE PAPERS.

IN pursuance of the powers conferred upon me by the Prices Regulation Acts, I, Thomas Gerard Gleeson, Acting Prices Decentral Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 207.

Revocation.

2. Prices Regulation Order No. 38 is hereby revoked.

Definition and Interpretation.

3. In this Order, unless the contrary intention appears:—
 - (a) "Area No. 1" means all that area of Victoria comprised within a radius of 50 miles from the General Post Office, Melbourne;
 - (b) "Area No. 2" means all that area of Victoria not included in Area No. 1.

Maximum Prices—Tobacco, Cigarettes and Cigarette Papers.

4. I fix and declare the maximum price at which any kind or brand of tobacco, cigarettes or cigarette papers specified in the Schedule to this Order may be sold by retail to be:—

- (a) In Area No. 1, the prices specified in that Schedule; and
- (b) In Area No. 2, the prices specified in that Schedule, provided that in respect of packs of tobacco containing 2 ounces or more, an amount of one halfpenny may be added to the said price.

Maximum Prices—Tobacco and Cigarettes not Specified in the Schedule.

5. I fix and declare the maximum price at which any kind or brand of tobacco and cigarettes not specified in the Schedule to this Order may be sold by retail in Victoria to be:—

- (a) In respect of tobacco—1s. 1d. per oz.;
- (b) In respect of cigarettes— $\frac{1}{2}$ d. each.

Exhibition of Price List.

6. Every person who sells or has for sale by retail in Victoria any kind or brand of tobacco, cigarettes or cigarette papers, the maximum retail selling price of which is fixed under the Prices Regulation Acts, shall exhibit in a prominent position in his place of business, or, if he has more than one place of business, in each of his places of business, a notice or notices setting forth the maximum retail prices fixed by this Order for the sale by him by retail of such tobacco, cigarettes or cigarette papers. Such notice or notices shall be exhibited in such a place or places in the traders' place of business and be prepared in such a manner as to be easily legible to persons contemplating making any purchase or conducting any business at the trader's place of business.

Fixation of Maximum Prices by Notice.

7. Notwithstanding the foregoing provisions of this Order, I declare the maximum prices at which any tobacco, cigarettes or cigarette papers specified in a notice given in pursuance of this paragraph may be sold by retail in Victoria by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

Prices Regulation Acts.

PRICES REGULATION ORDER No. 208.

POTATOES.

IN pursuance of the powers conferred upon me by the Prices Regulation Acts, I, John Francis Waldron, Prices Decontrol Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 208.

Definitions.

2. In this Order, unless the contrary intention appears—
 - “Metropolitan Area” means all that area comprised within a radius of 20 miles from the General Post Office, Melbourne;
 - “Primary Wholesaler” in relation to the sale of potatoes, means a person who purchases potatoes for the purpose of re-sale to another wholesaler whose normal business is to sell potatoes by wholesale;
 - “Secondary Wholesaler” in relation to the sale of potatoes, means a person who purchases potatoes from a primary wholesaler for the purpose of re-sale;
 - “Ton” means a long ton of 2,240 lb. or a quantity of fifteen bags of potatoes each containing not less than 149 lb. weight;
 - “By Wholesale” means and refers to a sale of potatoes in lots of one bag or more;
 - “Lb.” means pound avoirdupois or pounds avoirdupois as the case requires;
 - “Point of delivery” means in relation to the sale of potatoes, the place at which liability for payment of transport charges in conveying such potatoes to his place of business passed to the seller from the person from whom he purchased them.

Sales by Primary Wholesaler.

3. (1) I fix and declare the maximum price at which potatoes may be sold by primary wholesalers to secondary wholesalers to be £24 per ton delivered free at Cowper Street Railway Siding.
- (2) Nothing in either clause 4 or clause 5 of this Order shall apply to sales by primary wholesalers to secondary wholesalers.

Sales by Wholesale—Metropolitan Area.

4. I fix and declare the maximum price at which potatoes may be sold by wholesale in the metropolitan area to be—
 - (i) where the seller delivers the potatoes to the purchaser at the seller's store or at the Victoria Market—£25 12s. 6d. per ton;
 - (ii) where the seller delivers the potatoes into the buyer's shop—£26 5s. per ton.

Sales by Wholesale Outside Metropolitan Area.

5. I fix and declare the maximum price at which potatoes may be sold by wholesale other than in the metropolitan area to be—
 - (a) where such potatoes have been purchased in the metropolitan area, the sum of the following:—
 - (i) purchase price paid or payable or an amount calculated at the rate of £24 per ton, whichever is the lesser;
 - (ii) cost of rail transport from Cowper-street Railway Siding to the railway station or siding nearest the purchaser's premises or place of business;
 - (iii) a margin—
 - (A) where the seller delivers the potatoes to the purchaser at the seller's store or at the railway station or siding nearest the seller's premises or place of business, of £1 12s. 6d. per ton; or
 - (B) where the seller delivers the potatoes into the buyer's shop, of £2 5s. per ton;

(b) where such potatoes have been purchased outside the metropolitan area, the sum of the following:—

(i) an amount calculated at a rate of £24 per ton less the usual cost of transporting such potatoes by rail from the railway station or siding nearest the purchaser's premises to Cowper-street Railway Siding, plus the usual cost of transporting such potatoes by rail from the railway station or siding nearest the seller's premises to the railway station or siding nearest the purchaser's premises or place of business;

(ii) a margin—

(A) where the seller delivers the potatoes to the purchaser at the seller's store or at the railway station or siding nearest the seller's premises or place of business of £1 12s. 6d. per ton; or

(B) where the seller delivers the potatoes into the buyer's shop of £2 5s. per ton.

Maximum Prices—Sales by Retail.

6. (1) I fix and declare the maximum price at which potatoes may be sold by retail in the metropolitan area to be Four pence per lb.

(2) I fix and declare the maximum price at which potatoes may be sold by retail outside the metropolitan area to be the price fixed in the foregoing provisions of this Order for such sale in the metropolitan area, plus the charges properly incurred in transporting such potatoes from the point of delivery to the retailer to such retailer's shop or place of business, but in no case shall such maximum price exceed Four pence halfpenny per lb.

Exhibition of Price Tickets.

7. (1) Every person who sells or has for sale by retail potatoes, the maximum price of which is fixed by or under the provisions of this Order shall attach to or display with those potatoes a ticket or label setting forth his selling price thereof.

(2) Any ticket or label required by sub-clause (1) of this clause to be attached to or displayed with any potatoes shall be in such a form as to be easily legible to any person inspecting or viewing those potatoes and so as to be properly associated with such potatoes.

Delivery of Invoices

8. Any person who sells by wholesale potatoes shall deliver with such potatoes an invoice or docket containing the following particulars:—

- (i) name and address of seller;
- (ii) name and address of purchaser;
- (iii) date of sale;
- (iv) the point of delivery to the purchaser, the weight of the potatoes sold, number of bags and price per unit of such potatoes; and
- (v) total price of such potatoes.

Records.

9. Any person who sells any potatoes shall keep and preserve any invoice or docket received by him in relation to such potatoes and shall keep a record in respect of the purchase of such potatoes showing—

- (i) the name and address of supplier;
- (ii) the date of the invoice or docket received by him in relation to such potatoes;
- (iii) the quantity purchased and the price thereof;
- (iv) the point of delivery; and
- (v) transport costs properly attributable to the transport of such potatoes from the point of delivery to his place of business.

Fixation of Maximum Prices by Notice.

10. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any potatoes specified in a notice given in pursuance of this clause may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

PRICES REGULATION ORDER NO. 210.

FOOTWEAR IMPORTED INTO AUSTRALIA BY PETER McDERMOTT OR
McDERMOTT EXPORT COMPANY.

IN pursuance of the powers conferred upon me by the Prices Regulation Acts, I, John Francis Waldron, Prices Decontrol Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Regulation Order No. 210.

Application.

2. This Order shall take effect notwithstanding anything contained in Prices Regulation Order No. 176, and nothing in that Order contained shall apply to goods to which this Order applies.

Definitions.

3. “Allowance for Freight” means, in relation to the sale of any footwear, the actual cost incurred by the retail trader and properly attributed to the conveying of the goods from the point of delivery to his place of business, and which is clearly recorded in his books of account or records, provided that the amount per pair of footwear shall not be in excess of the appropriate amount specified in the Second Schedule to this Order according to the relation between the point of delivery to the retail trader of those goods and the situation of the retail trader’s place of business;

“Importer” means Peter McDermott of 422 Collins-street, Melbourne, or McDermott Export Company of 422 Collins-street, Melbourne, or McDermott Export Company of Kuala Lumpur, Malaya;

“Metropolitan Area” means all that area in Victoria comprised within a radius of 50 miles from the General Post Office at Melbourne;

“Point of Delivery” means, in relation to the sale of any specified goods, the place at which liability for the payment of transport charges in conveying such goods to his place of business passed to the retail trader from the person from whom the retail trader purchased such goods;

“Specified Goods” means any footwear imported into Australia by the importer.

Maximum Retail Prices.

4. (1) I fix and declare the maximum price at which any specified goods may be sold by retail by any person to be the sum of—

- (i) the net purchase price paid or payable therefor;
- (ii) the percentage margin of such cost as specified in the First Schedule to this Order; and
- (iii) allowance for freight (if any).

- (2) Where any maximum price calculated in accordance with the foregoing provisions of this Order—

- (a) does not exceed 10s. and is not an exact number of pence—such price shall be computed to the nearest upward penny;
- (b) exceeds 10s. and is not an exact multiple of threepence—such price shall be computed to the nearest upward threepence.

Fixation of Maximum Prices by Notice.

5. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which footwear specified in a notice given in pursuance of this clause may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

PRICES REGULATION ORDER No. 211.

ICE—MELBOURNE METROPOLITAN AREA.

I N pursuance of the powers conferred upon me by the Prices Regulation Acts, I, John Francis Waldron, Prices Decontrol Commissioner, hereby make the following Order :—

Citation.

1. This Order may be cited as Prices Regulation Order No. 211.

Definitions.

2. In this Order, unless the contrary intention appears—
- (a) an "eighth block" means a block of ice weighing 11 lb. or more but less than 22 lb. ;
- (b) a "quarter block" means a block of ice weighing 22 lb. or more but less than 47 lb. ;
- (c) a "half block" means a block of ice weighing 47 lb. or more but less than 70 lb. ;
- (d) a "three quarter block" means a block of ice weighing 70 lb. or more but less than 100 lb. ;
- (e) a "large block" means a block of ice weighing not less than 100 lb. ;
- "Melbourne Metropolitan Area" means all that area comprised within a radius of twenty miles from the General Post Office, Melbourne.

3. I fix and declare the maximum price at which ice may be sold by wholesale in the Melbourne Metropolitan Area to be 43s. 4d. (forty-three shillings and four pence) per ton of 20 (twenty) large blocks.

4. I fix and declare the maximum price at which ice may be sold by retail in the Melbourne Metropolitan Area to be—

5. I fix and declare the maximum price at which ice other than eighth, quarter, half, three quarter, or large blocks may be sold by retail in the Melbourne Metropolitan Area to be 3d. per block.

6. Notwithstanding anything contained in this Order, I fix and declare the maximum price at which ice may be sold in the Melbourne Metropolitan Area for use in shops, dairies, cafes, clubs or any place where perishable foodstuffs are sold to be—

Notwithstanding anything contained in the foregoing provisions of this Order, I declare the maximum price at which any size of a block of ice specified in a Notice in pursuance of this paragraph may be sold in the Melbourne Metropolitan Area by any person to whom such Notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.
