### DETERMINATION OF A WAGES BOARD ADJUSTED PURSUANT TO SECTION 21 OF THE FACTORIES AND SHOPS ACT 1934 (No. 4275).

I, Raymond Henry Beers, Secretary for Labour, in pursuance of the powers conferred by the Factories and Shops Acts, hereby make and issue the following adjusted Determination of the Wages Board referred to hereunder showing adjusted rates and prices to operate from the beginning of the first pay period to commence in February, 1951.

# SHOPS BOARD No. 7 (COUNTRY SHOP ASSISTANTS).

Apprentices.

One male apprentice to every three or fraction of three male workers receiving not less than 201s. per week of 40 hours.

One female apprentice to every three or fraction of three female workers receiving not less than 135s. per week of 40 hours.

An indenture of apprenticeship prescribed by the Board was approved on 20.12.1923.

Improvers.

One male improver to each male worker receiving not less than 201s. per week of 40 hours.

One female improver to each female worker receiving not less than 135s. per week of 40 hours.

Provided that a female improver may be employed in lieu of a male improver, or a male improver in lieu of a female improver.
