Factories and Shops Acts.

### DETERMINATION OF THE FIBROUS PLASTERERS BOARD.

Note .- (i.) This Determination applies to the whole of the State of Victoria.

(ii.) Fibrous Plastering was proclaimed on 17th February, 1937, as an Apprenticeship Trade under the Apprenticeship Act 1928 for the Metropolitan District.

Full particulars of the Apprenticeship Regulations for this trade may be obtained on application to the Secretary, Apprenticeship Commission, Melbourne. (Price 3d.)

IN accordance with the provisions of the Factories and Shops Acts the Wages Board which since the 14th April, 1937, has employed in the process, trade or business of—

- (a) manufacturing fibrous plaster, or making architectural ornaments of fibrous plaster, plaster, or cement; (b) fixing fibrous plaster on walls or ceilings of buildings;

(c) architectural modelling;
(d) preparing material for or making or fixing acoustic tiles moulded into slab form, and having an earth base;

(e) manufacturing gypsum plaster board; (f) fixing gypsum plaster board on walls or ceilings of buildings,"

has made the following Determination, namely:-

A. That as from the 15th April, 1951, clause 8 of Part 1., and clause 4 of Part II., of the Determination of this Board published in Government Gazette No. 41 of the 22nd January, 1951, shall be amended to read:—

#### PART I.

B. This Part applies to persons other than those employed inside the employer's factory or workroom manufacturing gypsum plaster board or assisting at any of the operations associated therewith.

#### SPECIAL RATES.

- 8. (a) Allowances, as per columns B of clause 1 of this Part, shall be made in addition to the wages set out in columns A of clause 1 of this Part as compensation for time lost on prescribed holidays. Such allowances shall be paid proportionately to the number of hours worked per week.
- (b) For all work done on Sundays and prescribed holidays employees shall be paid at the rate of double time; and all done on a Saturday shall be paid for at the rate of time and a half for the first two hours and double time thereafter.
- The following are the prescribed holidays, viz.:—New Year's Day, Australia Day, Good Friday, Easter Monday, Anzac Day, King's Birthday, Labour Day, Melbourne Cup Day, Christmas Day, and Boxing Day; but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays double time shall be payable only for work done on the day so substituted.
  - 8a. This clause shall apply only to the year 1951, and shall have no effect after the 31st December, 1951.
    - (i) The following days, having been proclaimed as Public Holidays for the year 1951, or any day or days substituted by proclamation therefore, shall be added to the Holidays set out in clause 8 of Part I., of this Determination. 9th May, 1951 (Federal Jubilee), 13th November, 1951 (Victorian Centenary).
    - (ii) An employee not required to work on either or both these days shall receive payment therefore at the ordinary rate of pay as for eight hours work for each day.

      Provided that an employee who fails to attend for work on the working day before or after either holiday without reasonable excuse shall not be entitled to payment for such holiday.
    - (iii) Double time shall be the rate payable for all work done on these days,

#### PART II.

C. This Part applies to persons employed inside the employer's factory or workroom manufacturing gypsum plaster board or assisting at any of the operations associated therewith.

4. An employee shall be entitled to be absent without deduction of pay on the days observed as New Year's Day, Australia Day, Good Friday, Easter Monday, Labour Day, Anaac Day, King's Birthday, 9th May, 1951, 13th November, 1951, Melbourne Cup Day (Metropolitan District only), Christmas Day, and Boxing Day; but if any other day be by Act of Parliament or Proclamation substituted for any of the above-named holidays, the special rates shall be payable only for work done on the day so substituted.
