## DETERMINATION OF A WAGES BOARD ADJUSTED PURSUANT TO SECTION 21 OF THE FACTORIES AND SHOPS ACT 1934 (No. 4275).

PROPORTION (within any factory or place).

*Apprentices.*

One male apprentice to every three or fraction of three male workers receiving at wages rates or piece-work prices not less than 20s. 6d. per week.

One female apprentice to every three or fraction of three female workers receiving at wages rates or piece-work prices not less than 14s. per week.

*Improvers.*

One male improver to every three or fraction of three male workers receiving at wages rates or piece-work prices not less than 20s. 6d. per week.

One female improver to every three or fraction of three female workers receiving not less than 14s. per week.

Clauses, other than clause 2, of the said Determination as amended on the 26th February, 1951, shall remain in force.
