**DETERMINATION OF A WAGES BOARD ADJUSTED PURSUANT TO SECTION  
21 OF THE FACTORIES AND SHOPS ACT 1934 (No. 4275).**

Such an employee shall be entitled to receive the rate prescribed herein for an employee between 21 and 60 years of age.
