RULES UNDER THE LICENSING ACTS.

At the Executive Council Chamber, Melbourne, the eighteenth day of September, 1956.

PRESENT:

His Excellency the Governor of the State of Victoria.

Mr. McArthur

Mr. Porter.

U NDER and by virtue of the powers and authorities conferred by the Licensing Acts and the Acts Interpretation Act 1928 His Excellency the Governor of the State of Victoria by and with the advice of the Executive Council thereof doth hereby rescind all Rules heretofore made under the Licensing Acts and under and by virtue of the said powers and authorities doth hereby make the following Rules (that is to say):—

- - "Licensing Area" means Licensing Area as constituted from time to time by Order of Governor in Council under the Licensing Acts.
 - "Clerk" means Clerk of the Victorian Licensing Court in respect of a Licensing Area.
 - "Court" means the Victorian Licensing Court.
 - "Registrar" means Registrar of the Victorian Licensing Court.

CLERKS OF THE COURT.

2. Each Licensing Area shall have a Clerk, but the Registrar shall act as Clerk for the Central, Northern, Eastern, Southern and Western Metropolitan Licensing Areas.

REGISTER OF THE COURT.

- 3. The Clerk of each Licensing Area shall keep a register of the minutes or memoranda of all the decisions, orders, judgments, and other proceedings of the Court in respect of such Licensing Area in such form as the Chairman requires, and shall enter and record the required particulars therein in the proper column of the register.
- The Registrar shall keep a register recording all such decisions, orders, judgments, and other proceedings of the Court.

MEMBERS OF THE COURT TO SIGN A REGISTER.

5. The members of the Court present shall sign the entries relative to the minutes, memoranda, or proceedings either in the register kept by the Clerk or that kept by the Registrar at the sitting of the Court at which the matters referred to in such entries were dealt with by the Court.

DUTIES OF THE REGISTRAR AND CLERK.

- 6. The Registrar and the Clerk shall have a seal of the Court, and shall keep his books in the forms required by the Chairman and these Rules.
- 7. The Registrar when attending any sitting of the Court at which the Clerk is not present shall furnish the Clerk with a minute of all decisions, orders, judgments, and other proceedings of the Court and the Clerk shall thereupon enter such particulars in his register with a memorandum of the time and place of the sitting, and shall sign the same.
- 8. When the Registrar is not present at any sitting of the Court, the Clerk shall furnish him with similar particulars to those set out in the foregoing provisions of this Rule, and the Registrar shall make a corresponding entry in his Register.

COLLECTION OF FEES

- 9. The Registrar or the Clerk of each Licensing Area shall demand and collect all fees payable under the Licensing Acts and these rules where such fees are not required to be paid to the Treasurer or a Receiver of Revenue, and shall cause an official acknowledgement to be given for each fee received, and shall forthwith bring the same to account, and enter the same in his regulation cash book in such manner as the Treasurer may direct.
- 10. The fees set out in the First Schedule to these Rules shall be taken.

NOTICE OF APPLICATIONS WHERE NOT OTHERWISE PROVIDED FOR.

11. Notice of all applications to the Court where not otherwise provided for in the Licensing Acts or these Rules shall be given to the Clerk and the Licensing Inspector for the Licensing Area seven days before the date of the sitting of the Court, at which the application is to be made but the Court, if it thinks fit so to do at any sitting, may receive, hear, and dispose of any such application or business notwithstanding that no previous or sufficient notice thereof has been given.

SEARCHES-COPIES OF RECORDS AND DOCUMENTS.

- 12. Any person on payment of the prescribed fee at any time when the office of the Registrar or Clerk is open for business may inspect any register-books, books, documents and papers kept and preserved by the said Registrar or Clerk, and shall be permitted to make copies thereof; and, if so required, the Registrar or Clerk, upon receipt of the prescribed additional fee, after examining and verifying such copies shall certify them to be true copies.
- 13. No person shall disclose the amount of any percentage fee, nor shall any person be entitled to inspect or make a copy of any record declaration, document or entry showing the purchases of liquor or the percentage fees arising thereon in respect of any licensed premises, including any registered club premises, except the secretary or a member of the specified club, the owner of the specified licensed victualler's premises, the licensee of the specified licensed premises, or their duly authorized representatives, or any Licensing Inspector.

APPLICATIONS FOR NEW LICENCES TRANSFERS ETC.

- 14. All notices of application, other than applications for temporary victualler's licence and renewal of licences, permits and registrations of clubs, shall be intituled in the Licensing Area in which the premises the subject matter of the application are situate and shall be returnable at Melbourne.
- 15. All such notices shall be signed by each applicant and attested by a Justice of the Peace or a Solicitor of the Supreme Court of Victoria who shall also subscribe his occupation and place of abode.
- 16. A copy of every notice so signed shall be delivered to the Clerk acting in the Licensing Area and to the Licensing Inspector and, if the application be for the grant of a new licence or for approval of

proposed additions or alterations to existing licensed premises or removal of the licence of such licensed premises or of the premises of a registered club to other premises, to the supervisor of licensed premises at Melbourne.

- 17. (a) Whenever the holder of any victualler's licence which he has not held for at least twenty-four months preceding the application desires to transfer such licence he shall deliver to the Clerk a notice of application for leave so to transfer together with a statutory declaration made by or on behalf of such applicant setting forth clearly the exceptional circumstances on which he relies and the gross amount in full of the purchase money paid by him on acquiring such licence and also that agreed to be paid to him by the proposed transferee. If the exceptional circumstances include a condition of health precluding him from carrying on such a licence, a further statutory declaration by a registered medical practitioner setting forth such condition and inability shall at the same time be delivered to the Clerk.
- (b) A copy of such notices of application and of every statutory declaration in support thereof shall be delivered to the Clerk and to the Licensing Inspector for the Licensing Area seven days at least before the day on which such application shall be heard.
- 18. (a) Every applicant for the transfer of any licence of which he is the holder shall at the time of giving the notice of such application deliver to the Clerk every such licence.
- (b) Every applicant for the transfer of any licence to him shall at the time of giving the notice of such application deliver to the Clerk a statement in writing signed by him setting out clearly the following particulars:—
 - (i) if the applicant has purchased the freehold of the licensed premises together with the licence, the price paid for the freehold and the terms of the contract of sale thereof, or
 - (ii) if the applicant has purchased a leasehold of the licensed premises, the price paid for the leasehold, the unexpired term thereof and the rent reserved and also the estimated cost of any additions and alterations to the licensed premises undertaken by him, and
 - (iii) in every case, the price paid for the licence, goodwill and furniture (if any) respectively. If the applicant has obtained a loan of money to finance such purchase, the amount of such loan, the rate of interest thereon and the mode of repayment by instalments or otherwise and also the name and address of the lender shall be included in the statement.

REPORT BY LICENSING INSPECTOR ON FITNESS OF APPLICANTS.

- 18. (c) Where testimonials of character or fitness are lodged by any applicant with the Clerk, such applicant shall forthwith forward a copy thereof to the Licensing Inspector for the Licensing Area, who shall make a thorough inquiry and report thereon so that such report shall reach the Court prior to the time set down for the hearing of the application. Where the applicant, or the husband wife or partner of the applicant, has previously held a licence, the applicant shall so inform the Licensing Inspector, who shall inquire from the Licensing Inspector of the Licensing Area in which such licence was held as to the manner in which the business was conducted and state the result in his report.
- 19. (1) Every body corporate making application for a licence or for the transfer to itself of a licence or for the renewal of a licence shall with its application in addition to any other duty imposed upon it by or under the Licensing Acts deliver to the Clerk and to the Licensing Inspector for the Licensing Area—
 - (a) a list of the names of the then directors manager and secretary of such body corporate, and
 - (b) in the case of a proprietary company, a list of the names of the members of such company and of the number of shares held by each of such members in such company.
- (2) (a) While a body corporate is the holder of a licence no appointment of any new director of such body corporate shall be made either in substitution for or in addition to any director or directors

holding office in such body corporate at the date when the licence held by the body corporate was granted transferred or renewed (as the case may be) to it unless and until—

- (i) the full name address and occupation of each person seeking election or proposed to be appointed as a director has been submitted in writing to the Registrar and to the Licensing Inspector for the Licensing Area in which the Licensed premises are situated; and
- (ii) each such person has thereafter been approved by the Licensing Court for appointment as such director which approval the Licensing Court may grant either absolutely or conditionally as it in its discretion thinks proper.
- (b) Every body corporate or person doing or attempting to do any act in contravention of this sub-rule shall be liable to a penalty of not more than Twenty pounds.

OWNERS OF LICENSED PREMISES-SECTION 247.

- 20. (a) All persons who on the date of the publication of these Rules in the *Government Gazette* are the owners of premises for which a victualler's licence or an Australian wine licence is in force and all persons who after the said date become the owners of such premises shall cause their names and addresses to be forwarded in writing to the Registrar.
- (b) In the case of persons who are owners of such premises on the said date the names and addresses shall be so forwarded within three months from the said date and in the case of persons who become owners of such premises after the said date the names and addresses shall be forwarded by the new owners within one month after they have become such owners.
- (c) Such names and addresses shall be recorded by the Registrar in a book or other form prescribed by the Chairman and to be called "Register of Owners" be kept for that purpose.
- (d) All owners so recorded shall notify the Registrar within one month in writing of any change of address.

RECORD OF NOTICE TO OWNERS OF CONVICTIONS.

- 21. Where the Registrar serves a notice of any conviction on any registered owner, he shall forthwith enter in the aforesaid register of owners particulars of such conviction and of the date and mode of the service of such notice. Where the Registrar serves such a notice on any unregistered owner he shall keep a record of such service.
- 22. The Registrar shall send by post, addressed to "The Owner" care of the licensee of the licensed premises, a copy of the notice of any conviction served in any other manner by the Registrar on any owner of such licensed premises.

PERMITS-SECTION 43 ACT 3717.

- 23. (a) Any licensed victualler, holder of an Australian wine licence or secretary of a registered club intending to apply to the Court for a permit under the provisions of the above-mentioned section shall give notice in writing of such intention to the Registrar or the Clerk and the Licensing Inspector for the Licensing Area together with a statutory declaration setting out the reasons for such application and the average daily number of persons excluding the applicant his family servants and lodgers requesting meals after six o'clock in the evening so as to reach the said Clerk and Inspector seven days at least before the date on which such application shall be heard.
- (b) Any licensed victualler, holder of an Australian wine licence or secretary of a registered club intending to apply for any extension of a permit previously granted shall give notice in writing of such intention to the Registrar or Clerk and Inspector together with a statutory declaration setting out the nature of the special occasion and the number of persons expected to be present so as to reach the said Clerk and Inspector seven days at least before the day on which such application shall be heard.

PERMITS-SECTION 44 ACT 3717, SECTION 2 ACT 5197.

24. (a) Any person intending to apply to the Court for a permit to drink liquor for a special occasion in a specified room in unlicensed premises or in a specified part of any public hall shall give notice in writing of such intention to the Registrar or the Clerk of the Licensing

Area where such unlicensed premises or public hall are or is situated and to the Licensing Inspector for such Area together with a statutory declaration setting out the circumstances of such special occasion the number of persons expected to be present and the name of the person or association bearing the cost of the liquor intended to be purchased for the occasion, so as to reach the said Registrar or Clerk and Licensing Inspector seven days at least before the day on which such application shall be heard.

(b) During the permitted period of time on the date specified in any permit granted by the said Court all doors (including the outer-door) by which access can be had to the room in unlicensed premises or the part of the public hall stated in the permit shall be kept unlocked by the occupier of the unlicensed premises or the proprietor of the

public hall.

- 25. All such notices set out in the two last preceding Rules shall be in the form prescribed by these Rules and, unless a plan of the licensed or other premises has been previously lodged and is held by the Court, shall be accompanied by a ground plan sketch or tracing of the licensed premises and licensed area, or of such other premises.
- 26. The Licensing Inspector for the Licensing Area shall forward to the Registrar so as to reach the Court at or prior to the time set down for hearing a report on every application for any permit or extended permit or consent or approval by the Court of any plan or other matter of which notice of application has been given, stating his opinion, after enquiry, whether such application is satisfactory or objectionable, and whether the permit is for a matter of public utility or convenience.

PERMIT—Non-intoxicating Beverages After 6 p.m.—Section 45—Act 3717.

27. Where any application is made under sub-section (1) (a) or (b) of the above-mentioned section the room or apartment in which it is proposed that non-intoxicating beverages shall be sold or supplied shall be shown distinctly, with all doors and passages leading thereto and also the situation of every bar-room and place where liquor is supplied with all doors giving admission thereto and all openings through which liquor may be served therefrom.

PERMIT—BILLIARD OR BAGATELLE TABLES AFTER 6 p.m.—Section 45—Act 3717.

- .28. Where any application is made under sub-section (1) (c) of the above-mentioned section the position of the room proposed to be used as a billiard or bagatelle room shall be distinctly shown, with all doors and passages leading thereto, and also the situation of every bar-room and place where liquor is kept or stored or from which liquor is supplied with all doors giving admission thereto and all openings through which liquor may be served therefrom.
- 29. Every such permit granted by the Court shall be in the form prescribed by these Rules and shall set out such conditions and restrictions as the Court may attach thereto.

LODGER'S REGISTER BOOK-SECTION 53-ACT 3717.

- , '30. The Lodger's Register Book shall be in the form prescribed by these Rules and shall contain a daily record by number of every room in the licensed premises in use or furnished for use as a bedroom. The leaves of the register book shall be fastened together by sewing, or bound in such manner as to prevent any page being removed or withdrawn from such register. Each page of the register book shall be numbered consecutively.
- 31. Such daily record shall be headed by the day of the week and date of the month and year and shall contain the following particulars in the respective columns:—
 - (a) A record, by numbers, of all rooms appropriated as bedrooms to lodgers.
 - (b) The extent of accommodation of all bedrooms in double (d) and single (s) beds.
 - (c) The name and usual place of abode of the lodger to whom each bed or room is appropriated.
 - (d) Such particulars as in the opinion of the licensee may be necessary or useful in his business.
 - (e) Each bedroom or bed occupied by the licensee or a member of his family identified by the letters L.F. and each bedroom or bed occupied by an employee of the licensee by the letter E.

- 32. The prescribed form may be either written in ink or printed in the Register and all lodgers' names and other particulars shall be filled in in ink by the lodger or by the licensee or by some person authorized by the licensee so to do.
- 33. Each and every entry of a lodger's name and usual place of abode shall be made in the Lodger's Register Book at the time the bed or beds, room or rooms is or are appropriated to such lodger, and any alteration in the Register shall be made in ink by interlineation or deletion and not by erasure. No person shall register or cause or permit himself to be registered in any Lodger's Register Book otherwise than under his proper name and for his usual place of abode. The name of every lodger to whom a bed or room is appropriated for more than one night or who has arranged to stay for a succeeding night shall be entered anew in the Register by the licensee or person appointed thereto each day of such stay before the hour of Six in the evening.
- 34. In the event of the ordinary bedroom accommodation of the licensed premises being insufficient for the demands of the lodgers all shakedowns or sleepouts shall be set out in the Register specifying the nature and location thereof and all entries in connection therewith shall be in accord with these Rules.
- 35. A licensee shall not have in use or permit any person on his behalf or in his employ to have in use more than one Lodger's Register Book, nor shall he use or permit the use of any second book or list for a similar purpose. Every Licensing Inspector or any authorized member of the police force upon an inspection of licensed premises shall inspect the Lodger's Register Book and shall sign, initial, or otherwise mark it for identification at the page showing the entries for the day of inspection. No other Lodgers' Register Book shall thereafter be brought into use for such licensed premises unless first identified and marked by a Licensing Inspector or authorized member of the police force by signature, initial or other mark. Every licensed person shall preserve and cause to be preserved every marked Lodgers' Register Book together with all or any such signature, initials or other marks of identification and no page shall be removed or withdrawn from such Register.
- 36. Whenever a licensee fails or refuses to supply accommodation to any person requesting the same he shall forthwith enter into the Lodgers' Register Book the name of every such person, the reason for such failure or refusal and the hour.

DEFINITION OF LICENSED PREMISES.

- 37. (a) Upon any application for a renewal or transfer of a licence the applicant shall if ordered by the Court so to do deposit with the Registrar a plan of the licensed premises showing the exact position and the metes and bounds of the licensed premises and of the ground floor and of all separate parts and such other particulars as are prescribed.
- (b) The Court may make the prior deposit of such a plan as aforesaid a condition of the renewal or transfer (as the case may be) of any such licence.
- (c) The Court at any sitting on application by the owner and licensee of any licensed premises or by the Licensing Inspector for the Licensing Area in which such premises are situate may define on a plan (which shall be lodged with the Court by the said owner and which shall contain all necessary particulars) the extent of the licensed area of such premises.
- (d) Notice in writing of any such application intended to be made by the owner and licensee shall be given to the said Licensing Inspector, and notice in writing of any such application intended to be made by the Licensing Inspector shall be given to the owner and licensee, at least seven days before the commencement of the hearing of such application.

CASE STATED-SECTIONS 67, 68-ACT 3717.

38. If any person who feels himself aggrieved by a determination of the Court applies in writing to the Court to state and sign a case for the opinion of the Supreme Court and at the time of making such application deposits in the hands of the Registrar the sum of Twenty pounds on a condition to prosecute such appeal without delay and to submit to the judgment of the Supreme Court and pay such costs as may be awarded by the same, the Registrar shall pay such sum so deposited into the Trust Account kept by him.

- 39. If the Court refuses to state a case and if no application is made to the Supreme Court under the provisions of Section 70, or if the appeal is prosecuted without delay and all other conditions aforesaid, including the payment of costs (if any) are fulfilled, the Registrar on the application in writing of the person who deposited the said sum shall repay it to him.
- 40. In all other circumstances the said sum shall be forfeited to the Crown and the Registrar shall pay the same to the Treasurer of Victoria.

CANTEENS-ACT 5767 SECTION 33:

- 41. Any construction authority which desires to obtain a recommendation of the Court to the Governor in Council that it be permitted to establish canteens in any area in which the works of the authority are constructed or are in course of construction shall deliver to the Registrar of the Court and to a Licensing Inspector and shall affix on a notice board in a conspicuous place in that area notice in writing signed by such authority setting forth such desire and shall publish a copy of such notice in a newspaper circulating in the locality of such area at least fourteen days before making application to the said Court for such recommendation.
- 42. All such notices shall be delivered in triplicate to the Registrar who shall as soon as possible after the receipt of such notices post or cause to be posted one of such notices inside and another of such notices outside on some conspicuous part of the Court House nearest to such area.
- 43. At the time of giving the notices the construction authority shall deliver to the Registrar and the Licensing Inspector one copy each of the plans and specifications of every building or proposed building intended to be used as a canteen and a block plan showing the position or proposed position of every such building in the area.

REGISTERED CLUBS.

Club Register.

44. The Registrar shall keep a register in such form as may be required by the Chairman of the said Court of clubs registered by the Court. He shall cause to be entered therein the name, location, and any other required particulars of all clubs registered, and shall, when necessary, strike out the name of any club the registration of which has not been renewed or has been cancelled or surrendered.

CHANGE OF SECRETARY OF A REGISTERED CLUB.

- 45. Whenever the period of office of any person as secretary of a registered club has for any reason ceased, notice in writing signed by the President or Vice-President of such club shall within one month after such cesser be delivered to the Registrar stating,
 - (a) that such person has ceased to be secretary, and
 - (b) the name in full and place of abode of the person appointed to be the new secretary.

REMOVAL OF A REGISTERED CLUB.

46. When any notice of application is received by the Licensing Inspector for a certificate of removal of a club from the registered club premises to other premises, the said Licensing Inspector shall inquire into and report in writing to the Court on any such application prior to the date set down for hearing. Where he finds that any provision of the Licensing Acts has not been complied with or that the premises are not suitable, he shall give notice of objection to the applicant pursuant to the provision of section 262 (1) of the Licensing Act 1928 and include a copy of such notice in his report to the said Court.

COSTS.

- 47. When the Court makes an order directing the payment of costs by one party to any proceedings before it to any other party or parties, the Court shall fix the amount of such costs, including the fees to be allowed for counsel and attorneys appearing for the party or parties to whom such costs are directed to be paid.
- 48. The costs of witnesses in attendance at the hearing of any cause, application, or other proceeding by the Court, although they have not been summoned, and although they have not been examined, may be allowed at any rate not exceeding that mentioned in the Second Schedule hereto.

FORMS.

49. The forms under these Rules shall be used with such variations as the circumstances of the case may require and it shall be sufficient if the form used complies substantially with the prescribed form, and where none is prescribed the forms used shall be framed in imitation of those prescribed by these Rules.

PENALTIES.

50. Any person who is guilty of any contravention of or failure to observe any of the provisions of the foregoing Rules, shall be liable to a penalty of not more than £20.

FIRST SCHEDULE.

SECOND SCHEDULE

ALLOWANCES TO WITNESSES.

Costs of Witnesses' Attendance.—The cost of witnesses in attendance at the hearing of any matter or cause by the Court (although they have not been summoned, and although they have not been examined), may be allowed at any rate not exceeding that mentioned in the scale hereunder, and such rates shall be in lieu of the rates fixed by the Order of the Governor in Council made on the 1st day of July, 1924 (that is to say):—

- 1. To every witness or interpreter the sum actually paid, but not exceeding one shilling for every mile he may reside from the Court at which he may be required to attend.
- To every witness or interpreter who may travel by public conveyance, the sum actually and properly paid for fares both in going to and returning from the Court at which he may be required to attend.
- No allowance under clause 1 will be made to any witness or interpreter residing within 4 miles of the Court which he may be required to attend.
- 4. In all cases where practicable witnesses or interpreters must travel by public conveyance, and in such part of the public conveyances, as may be suitable to their stations in life.
