TOURIST ACT 1957.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by an Act of Parliament of the State of Victoria passed in the sixth year of the reign of Her Majesty Queen Elizabeth II. intituled the *Tourist Act* 1957 (No. 6155) it is amongst other things enacted by section 1 thereof that the said Act shall come into operation on a day to be fixed by Proclamation of the Governor-in-Council published in the *Government Gazette*.

Now therefore, I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this Proclamation fix the 20th day of May, 1958, as the day upon which the said *Tourist Act* 1957 shall come into operation.

Given under my Hand and Seal of the State of Victoria aforesaid, at Melbourne, this twentieth day of May, in the year of our Lord One thousand nine hundred and fifty-eight, and in the seventh year of the reign of Her Majesty Queen Elizabeth II.
