SEVERANCE OF AREA FROM THE CITY OF BROADMEADOWS AND ANNEXATION TO THE SHIRE OF BULLA.

WHEREAS by the Local Government Acts it is enacted that the Governor in Council may, from time to time, make Orders exercising certain powers therein set forth, amongst others to sever any portion of Victoria forming part of a municipal district from such municipal district and annex same to any other municipal district with which the portion so severed forms one continuous area, and that every such Order shall be published in the *Government Gazette*, and shall take effect as from the day or days specified in the Order, or, if no day is so specified, as from the day of such publication:

And whereas the powers conferred upon the Governor in Council by the said Acts are now exercised upon a request by certain ratepayers of the City of Broadmeadows with regard to a certain area therein described, and after consideration of a report and recommendation by the Advisory Board constituted pursuant to section 45 of the *Local Government Act 1946*:

Now, therefore, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, doth by this present Order sever from the municipal district of the City of Broadmeadows the area aforementioned, and doth annex the portion so severed to the municipal district of the Shire of Bulla and doth re-describe the boundaries of the municipal districts of the City of Broadmeadows and the Shire of Bulla in the manner hereinafter set forth, such descriptions to be in lieu of those published in the *Government Gazette* of 25th May, 1955 (Shire of Broadmeadows), and 25th May, 1955 (Shire of Bulla):—

City of Broadmeadows (Reduced and Re-defined).

Commencing on the Hume Highway at the junction of Somerton-road; thence southerly by that highway to the road on the southern boundary of section 6, Parish of Wollert; thence easterly by that road to Merri Creek;

thence generally southerly by that creek to the northern boundary of section 149 Parish of Jika Jika; thence westerly by that boundary and the northern boundary of section 150, and southerly by the western boundary of the last-mentioned section to Gaffney-street; thence westerly by that street to the Moonee Ponds Creek; thence south-easterly by that creek to Woodlands-street; thence westerly by that street to the south-western angle of allotment 13, section 16, Parish of Doutta Galla; thence north-westerly by a direct line to the southern angle of allotment D, section 22 and further north-westerly by the western boundary of that allotment and a road to the west boundary of section 6, Parish of Tullamarine; thence northerly by that boundary and a line to the Moonee Ponds Creek; thence easterly by that creek to the western boundary of the Township of Broadmeadows; thence northerly and easterly by the western and northern boundaries of that township to the western boundary of the land contained in certificate of title, volume 5534, folio 765; thence northerly by that boundary to the southern boundary of Crown portion 9, Parish of Will-will-rook; thence easterly by that boundary and northerly by the eastern boundaries of the said portion and allotment F, section 3, Parish of Yuroke to Somerton-road; and thence easterly by that road to the Hume Highway, being the point of commencement.

Area of City: 17,490 acres.

CITY OF BROADMEADOWS.

Campbellfield Ward (Reduced and Re-defined).

Commencing on the southern boundary of the city where it is intersected by Derby-street; thence northerly by Derby-street to South-street; thence easterly by South-street to East-street; thence northerly by East-street to Hilton-street; thence westerly by Hilton-street to the north-eastern railway; thence northerly by that railway to Broadmeadows-road; thence westerly by Broadmeadows-road to the eastern boundary of the Township of Broadmeadows; thence northerly and westerly by the eastern and northern boundaries of that township to the city boundary; and thence northerly, easterly, southerly and westerly by the city boundary to the point of commencement.

Shire of Bulla (Enlarged and Re-defined).

Commencing on the Hume Highway where it intersects the northern boundary of the Parish of Kalkallo; thence westerly by that boundary and the northern boundary of the Parish of Mickleham to Deep Creek; thence southerly by that creek to the northern boundary of the Parish of Bollinda; thence westerly by that boundary to the Country

Roads Board road (known as the Konagaderra Developmental road); thence north-westerly, south-westerly, north-westerly and south-westerly by that road to the Melbourne-Lancefield road; thence southerly by that road to the north boundary of allotment 1, section 19, Parish of Bollinda; thence westerly by a line in continuation of that boundary to the eastern boundary of the Parish of Buttlejorrk; thence northerly by that boundary, westerly and southerly by the northern and western boundaries of that parish to the Calder Highway; thence south-easterly by that highway to the northern boundary of allotment 20, section A, Parish of Buttlejorrk; thence easterly by that boundary and a road to the north-western angle of allotment 59; thence southerly by a road to the southern boundary of the parish; thence easterly by that boundary to the northern railway; thence southerly by that railway to the Calder Highway; thence south-easterly by that highway to the north boundary of the Parish of Maribyrnong; thence easterly by that boundary to the north boundary of section 9, Parish of Tullamarine; thence easterly by that boundary and the northern boundaries of sections 8 and 7 to the Melbourne-Lancefield road; thence south-easterly by that road to the western boundary of section 6; thence northerly by that boundary and a line to the Moonee Ponds Creek; thence easterly by that creek to the western boundary of the Township of Broadmeadows; thence northerly and easterly by the western and northern boundaries of that township to the western boundary of the land contained in certificate of title, volume 5534, folio 765; thence northerly by that boundary to the southern boundary of Crown portion 9, Parish of Will-will-rook; thence easterly by that boundary and northerly by the eastern boundaries of the said portion

and allotment F, section 3, Parish of Yuroke to Somerton-road; thence easterly by that road to the Hume Highway; and thence northerly by that highway to the point of commencement.

Area of Shire: 160 square miles.

SHIRE OF BULLA.

Mickleham Riding (Enlarged and Re-defined).

Commencing on the Moonee Ponds Creek at a point in line with the western boundary of section 6, Parish of Tullamarine; thence north-westerly by that creek to the southern boundary of the Parish of Bulla Bulla; thence easterly and northerly by the southern and eastern boundaries of that parish to the south-eastern angle of allotment 18; thence westerly by a road to the south-western angle of allotment 18A, and northerly by a road to Deep Creek; thence northerly by that creek to the northern boundary of the shire at the north-eastern corner of the Parish of Bollinda; and thence northerly, easterly, southerly and westerly by the shire boundary to the point of commencement.

And the Honorable Sir Thomas Karran Maltby, Her Majesty's Commissioner of Public Works for the State of Victoria, shall give the necessary directions herein accordingly.
