#### ACTS OF PARLIAMENT.

#### PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

I, THE Governor of the State of Victoria, in the Commonwealth of Australia, do hereby declare that I have this day assented, in Her Majesty's name, to the Bills passed by the Parliament of the said State, the titles whereof are hereunder set forth, that is to say:—

No. 6664. "An Act to amend Section Five of the Dried Fruits Act 1958."

Dried Fritts Act 1958."

No. 6665. "An Act to provide, upon the Surrender to Her Majesty of certain Land in the Parish of Conewarre for the Reservation thereof as a Site for Public Purposes and Recreation, and for the Revocation of the Reservation of certain other Land in the said Parish reserved as a Site for Public Purposes and the Grant thereof to Trustees for the Members of the Barwon Heads Golf Club."

No. 6666. "An Act to provide for the Revocation of the Permanent Reservations and a Crown Grant of certain lands, and for other purposes."

VICTORIAN DRIED FRUITS BOARD ELECTION.— APPOINTMENT OF RETURNING OFFICER AND SUBSTITUTE RETURNING OFFICER.

WHEREAS by section 6, sub-section (1) of the *Dried Fruits Act* 1958 (No. 6239), the Governor in Council is empowered to appoint Returning Officers in connexion with the election of members of the Victorian Dried Fruits Board, and whereas an election is to take place closing on the 19th December, 1960: Now therefore, His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, doth hereby appoint—

HAROLD EDWIN JOH, Officer of the Department of Agriculture, to be Returning Officer, and

LESLIE JOHN THOMPSON, Officer of the Department of Agriculture, to be Substitute Returning Officer for such election.

And the Honorable Gilbert Lawrence Chandler, Her Majesty's Minister of Agriculture for the State of Victoria, shall give the necessary directions herein accordingly.

#### Dried Fruits Act 1958-1960.

GENERAL ELECTION OF MEMBERS OF THE VICTORIAN DRIED FRUITS BOARD.

HEREBY give notice that a General Election of members of the Victorian Dried Fruits Board is required to be held during the month of December, 1960, and that the following arrangements and conditions will apply to the said election, viz.:—

1. Enrolment of Growers.—Lists of growers who appear to be entitled to be enrolled and to vote at the election of members for the respective areas, as defined by the Dried Fruits Act 1958-1960, are available at all packing houses situated within those areas, and may be inspected at such places up to and including the 22nd November, 1960. Lists of growers are also available for inspection at the office of the Victorian Dried Fruits Board, 118 Queen-street, Melbourne.

Claims for and objections to enrolment may be submitted, in writing, to the Returning Officer (H. E. Job, Department of Agriculture, Treasury Gardens, Melbourne, C.2) not later than the said 22nd November, 1960.

No grower may have his name included in any roll unless—

- (a) During the current year or one of the two preceding years he has produced more than five hundredweights of dried vine fruits; or
- (b) During the current year or each of at least three of the five preceding years he has produced more than five hundredweights of dried tree fruits.
- 2. Nomination of Candidates.—Nominations of candidates for election must be made in the prescribed form and must be received by the Returning Officer, Department of Agriculture, Treasury Gardens, Melbourne, C.2, not later than 4 p.m. on Thursday, the 24th November, 1960.

 ${f Note}$ .—Nomination forms are available at all packing houses.

3. Taking of Poll.—If more than the required number of candidates is nominated for any area, the member or members to be elected for that area shall be determined by the taking of a poll, which shall close at 4 p.m., on Monday, the 19th December, 1960.
