PROCLAMATION

By His Excellency the Administrator of the Government of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

IN pursuance of the powers conferred by section 3 of the *Forests Act 1958*, I, the Administrator of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation proclaim the period commencing at midnight between the fifteenth and sixteenth days of April, 1961, and ending at midnight between the thirtieth day of April, 1961, and the first day of May, 1961, to be the prohibited period in respect to any fire protected area other than a State forest or national park in the State of Victoria situated in such municipalities as are specified in the Schedule hereto.

VARIATION OF PROCLAMATION RELATING TO THE PROHIBITED PERIOD.

PROCLAMATION

By His Excellency the Administrator of the Government of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by section 3 of the *Forests Act 1958* it is enacted that the Governor in Council may from time to time by Proclamation published in the *Government Gazette* declare any period to be a prohibited period in respect of the fire protected area (other than a State forest or national park), and, without affecting the generality of the foregoing, may from time to time by Proclamation so published declare different prohibited periods in respect of different parts of the fire protected area (other than a State forest or national park):

And whereas by the said section it is further enacted that any Proclamation so published may subsequently be revoked, amended or varied by the Governor in Council by Proclamation so published:

And whereas by Proclamations issued on the 29th November, 1960, the 13th and 21st December, 1960, and published in the *Government Gazette* on the 30th November, 1960, the 14th and 21st December, 1960, respectively, a prohibited period expiring on the 15th April, 1961, was proclaimed in respect of portion of the fire protected area (other than State forests or national parks); including the areas specified in the Schedule hereto:

Now therefore I, the Administrator of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the powers conferred by the *Forests Act*, do by this my Proclamation vary the aforesaid Proclamations by proclaiming that the prohibited period in respect of the parts of the fire protected area (other than a State forest or national park) situated in such municipalities as are specified in the Schedule hereto shall end at midnight between the twelfth day and the thirteenth day of April, 1961.

**REGULATIONS FOR THE ELECTION AND TERM OF
OFFICE OF COMMISSIONERS, AND ANY MATTER
INCIDENTAL THERETO.**

WHEREAS, in pursuance of the provisions of the *River Improvement Act 1958*, the Governor in Council is empowered to make regulations for the election and term of office of Commissioners of River Improvement Trusts and any matter incidental thereto:

Now, therefore, His Excellency the Administrator of the Government of the State of Victoria, acting by and with the advice of the Executive Council of the said State, and in pursuance of the provisions of the *River Improvement Act 1958*, doth for the purpose aforesaid make the following Regulations for and in respect of the Glenelg River Improvement Trust:—

1. *General Regulations to Apply.*—The General Regulations made in pursuance of the provisions of the Act, for the qualification, disqualification, election, appointment, removal, and term of office of Commissioners of River Improvement Trusts shall be read and construed as one with these Regulations.

2. *Period for which Elected Commissioner shall Hold Office.*—The period for which an elected Commissioner shall hold office shall be until the second Saturday in the month of May in the third year after the year of his election.

3. *Date of Ordinary Election of Commissioners.*—The ordinary election, other than the first election, of Commissioners under these Regulations shall be held on the second Saturday in the month of May in each triennial year succeeding the year 1961.

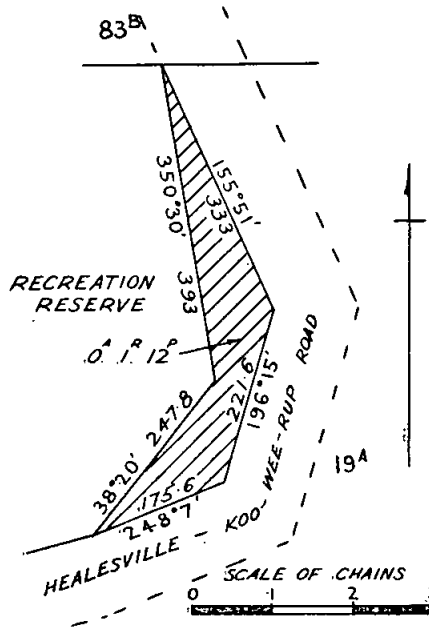

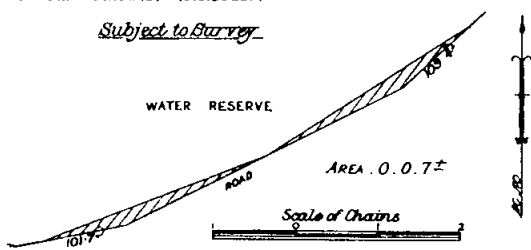
