NOTICE PURSUANT TO SECTION 23 OF THE MILK BOARD ACT 1958.

AFTER inquiry conducted in the manner prescribed by the *Milk Board Act 1958* and the regulations in force thereunder and in pursuance of the provisions of the said Act, the Milk Board does, by this notice—

- (a) Revoke as from the date of publication of this notice the definitions of areas within the Metropolitan Milk District contained in the First Schedule to the notice published in the *Government Gazette* of 3rd November, 1960, pursuant to Section 23 of the Act, under the headings of Eltham and Werribee.
- (b) Define the areas contained in the First Schedule to this notice under the headings of Eltham and Werribee as areas in the Metropolitan Milk District for the purposes of Section 23 of the Act.
- (c) Define the areas contained under the headings of Murray Valley Milk District, Goulburn Valley Milk District and North Eastern Milk District in the First Schedule to this notice as areas in those Milk Districts for the purposes of Section 23 of the Act.
- (d) Determine that, in respect of areas in the Metropolitan Milk District and the Dandenong Ranges Milk District as defined for the purposes of Section 23 of the Act by notice published in the *Government Gazette* of 3rd November, 1960, and by this notice, and in respect of areas in the Murray Valley Milk District, the Goulburn Valley Milk District and the North Eastern Milk District as defined by this notice:—
 - (i) Milk may be distributed by retail from each of the dairies described in the first column of the Second Schedule to this notice in any defined area specified opposite such dairy in the second column of such Schedule; and
 - (ii) Milk may be distributed otherwise than by retail to those classes of premises prescribed by the Governor in Council on 28th June, 1960, and published in the *Government Gazette* of 6th July, 1960 (namely licensed milk shops and all other shops within the meaning of the Labour and Industry Act used for the retail sale of milk drinks or drinks of which milk is the principal ingredient, except canteens conducted on hospital, schools, factory or defence establishment premises), from each of the dairies described in the first column of the Second Schedule to this notice in any defined area specified opposite such dairy in the third column of such Schedule.
- (e) Revoke as from the date of publication of this notice, all determinations heretofore made pursuant to Section 23 of the Act, of specified dairies from which milk may be distributed by retail or otherwise than by retail in defined areas in the Metropolitan Milk District and the Dandenong Ranges Milk District.
