COMPANIES ACT 1961.

PROCLAMATION DECLARING COMPANIES

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by sub-sections (2) and (3) of section 172 of the *Companies Act 1961* it is provided (*inter alia*) that the Governor in Council upon being satisfied that a prima facie case has been established that, for the protection of the public or the shareholders or creditors of a company it is desirable that the affairs of the company should be investigated under Division 4 of Part VI. of the said Act, may by Proclamation published in the *Government Gazette* declare that such company is a company to which the said Division applies: And whereas by section 382 of the said Act the provisions of the said Part VI. so far as applicable and with such adaptations as are necessary are extended and applied to all societies under the *Building Societies Act 1958* as if those societies were companies: Now therefore I, the Lieutenant-Governor for the State of Victoria, by and with the advice of the Executive Council thereof, being satisfied that such a prima facie case has been established that it is desirable that the affairs of the under-mentioned companies and societies under the *Building Societies Act 1958* should be investigated under the said Division, do in and by this Proclamation declare that such companies and societies are companies and societies to which this Division applies.
