

Motor Boating Act 1961 (No. 6832), APPOINTMENT OF AN AUTHORITY IN CONTROL OVER THE NAVIGATION OF VICTORIAN WATERS.

PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by Part I section 2 of the Motor Boating
Act 1961, it is amongst other things enacted that
the Governor in Council, by Proclamation published in
the Government Gazette, may from time to time appoint
an Authority in control over the Navigation of any
Victorian Waters and that such limits may in like
manner be altered, amended, or repealed and others
substituted in their stead:

Now therefore I, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation appoint:—

The Port Officer for Victoria to be the Authority in control of navigation of all Victorian Coastal Waters for a distance of three miles from the low water mark

on the shore at any point on the Victorian Coastline, other than such parts thereof as are included in the limits and boundaries of the Port of Portland and excluding all navigable rivers and streams flowing into such Coastal Waters,

Motor Boating Act 1961 (No. 6832). EXEMPTION OF CERTAIN BOATS FROM THE PROVISIONS OF PART II. OF THE MOTOR BOATING ACT 1961.

PROCLAMATION

By His Excellency the Lieutenant-Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by an Act of Parliament of the State of Victoria passed in the tenth year of the reign of Her Majesty Queen Elizabeth II., intituled the Motor Boating Act 1961 (No. 6832), it is amongst other things enacted that Part II. of the Motor Boating Act 1961 (No. 6832), shall not apply to any class or type of boat specified in any Proclamation made by the Governor of Countries and the Contract of the Country of the Countries of in Council and published in the Government Gazette as exempted for the time being from compliance with the provisions of that part which Proclamation the Governor in Council may at any time in the like manner revoke amend or vary:

amend or vary:

Now therefore I, the Lieutenant-Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this my Proclamation exempt from registration pursuant to the provisions of the said Part II. any boat which is brought into the State of Victoria from any other State of Australia for the purpose only of competing in any regatta or contest sponsored by a bona fide Power Boat Club or Association and so long only as the boat is so used only as the boat is so used.

RATING BY-LAW 1963.

THE Bairnsdale Waterworks Trust, in pursuance and exercise of the powers conferred by the Water Acts, doth hereby make a rate for the supply of water for domestic purposes of Fourteen pence in the pound of the annual municipal valuation of lands and tenements liable to be rated within the Bairnsdale Urban District.

EUROA SEWERAGE AUTHORITY.

By-law No. 2 (RATING).

THE Euroa Sewerage Authority, in pursuance and exercise of the powers conferred by the Sewerage Districts Acts, doth hereby make the following By-law:—

- 1. That, pursuant to the provisions of the Sewerage Districts Act 1958, section 87 (4), the Euroa Sewerage Authority hereby fixes the following sums which shall be the minimum amount of rate to be paid annually by the owner or occupier of any rateable sewered property on which there is a building at Seven pounds ten shillings (£7 10s.) and in respect of any rateable sewered property on which there is no building. Three pounds (£3).
- 2. Such minimum rate is made and shall be levied for the year beginning with the first day of January, 1963, and in each and every subsequent year and ending on the 31st day of December of the same year, and shall be payable at the office of the Authority, situated at 77 Railway-street, Euroa.
- 3. If any rateable property which, unsewered at the time of the making of the aforesaid rate, becomes during the said year a "sewered property", there shall be levied upon such property a proportionate part of the sewerage rate for the portion of the year after it has become a sewered property, and such property shall be deemed to have been lawfully rated accordingly.

4. Such person or persons as the Euroa Sewerage Authority may from time to time appoint for that purpose shall be and is hereby authorized to demand, receive, collect and recover the said rates.

The Resolution for passing the foregoing By-law was agreed to by the Euroa Sewerage Authority at a special meeting called for the purpose on the 2nd day of October, 1962, and was confirmed by the said Authority on the 6th day of November, 1962.

HORSHAM SEWERAGE AUTHORITY. BY-LAW NO. 11.

THE Horsham Sewerage Authority in pursuance and exercise of the powers conferred by the Sewerage Districts Acts, doth hereby make the following By-law:—

- 1. The minimum sewerage rate payable for the period commencing on the 1st October, 1962, and ending on the 30th September, 1963, in respect of any rateable sewered property on which there is a building shall be Four pounds ten shillings (£4 10s.).
- 2. The minimum sewerage rate payable for the year commencing 1st October, 1962, and ending on the 30th September, 1963, in respect of any rateable sewered property on which there is no building shall be Two pounds (£2).

INVERLOCH WATERWORKS TRUST. RATING BY-LAW FOR THE YEAR 1963.

THE Inverloch Waterworks Trust, in pursuance and exercise of its powers conferred by the Water Acts, doth hereby make a rate for the supply of water for domestic purposes of Three shillings and six pence in the pound on the net annual valuation of lands and tenements to be rated within the Inverloch Urban District.

KING RIVER IMPROVEMENT TRUST.

BY-LAW No. 14.

THE King River Improvement Trust, in pursuance and exercise of the powers conferred by the River Improvement Act 1958, doth make the By-law following:—

- 1. The following rate, to be called the King River Improvement District River Improvement Rate, is hereby made and shall be levied upon the occupiers or owners of all properties within the King River Improvement District which are rateable to any municipality, a rate of Two pence in the fl on the net annual municipal value of all those properties within the First Division of the district: Provided that the sum of One shilling shall be the minimum amount payable in respect of any property liable to be rated in the said division.

- 3. Such rates are made and shall be levied for the year beginning with the 1st day of January 1963, and ending with the 31st day of December, 1963, and shall be payable on the 10th day of April, 1963, at the office of the King River Improvement Trust, at Wangaratta.
- 4. Such person or persons as the King River Improvement Trust may from time to time appoint for that purpose shall be and is or are hereby authorized to demand, receive, collect, and recover the said rate.

KYNETON SEWERAGE AUTHORITY.

RATING BY-LAW 1962-63.

MERRIGUM WATERWORKS TRUST.

RATING BY-LAW FOR THE YEAR 1963.

THE Merrigum Waterworks Trust, in pursuance and exercise of the powers conferred by the Water Acts, doth hereby make a rate for the supply of water for domestic purposes of Two shillings in the pound on the net annual valuation of lands and tenements liable to be rated within the Merrigum Urban District.

ORBOST WATERWORKS TRUST.

RATING BY-LAW FOR THE YEAR COMMENCING 1ST JANUARY, 1963.

THE Orbost Waterworks Trust, in pursuance and exercise of the powers conferred by the Water Acts, doth hereby make a rate for the supply of water for domestic purposes of One shilling and six pence in the pound on the annual municipal valuation of all land and tenements liable to be rated within the Orbost Urban District

The charge for water supplied by measure to any property rated by the Trust in excess of such maximum quantity, computed as in the last preceding clause, is hereby fixed at Eighteen pence per 1,000 gallons.

TAMBO RIVER IMPROVEMENT TRUST.

BY-LAW No. 9.

THE Tambo River Improvement Trust, in pursuance and exercise of the powers conferred by the River Improvement Act 1958, doth hereby make the By-law

1. The following rate to be called the "Tambo River Improvement District River Improvement Rate" is hereby made and shall be levied upon the occupiers or owners of all properties within the Tambo River Improvement District which are rateable to any municipality.

A rate of Thirty-four pence in the pound on the net annual value of all those properties within the Fifth Division, as determined by the said Order in Council.

A rate of Forty-two pence in the pound on the net annual value of all those properties within the Sixth Division, as determined by the said Order in Council.

A rate of Fifty-seven pence in the pound on the net annual value of all those properties within the Seventh Division, as determined by the said Order in Council.

A rate of Sixty-nine pence in the pound on the net annual value of all those properties within the Eighth Division, as determined by the said Order in Council.




Parish of Laen, County of Borung, being the roads indicated by hachure on plan hereunder.—(L.146(*) (0591/130).
