

MOTOR CAR TRIALS OF SPEED WITHIN THE SHIRE OF TALBOT AND CLUNES.

WHEREAS it is enacted by sub-section (2) of section 83 of the Motor Car Act 1958 that, if a motor car is used on a highway for purposes of racing or of trial of speed, the driver or the person in charge thereof shall be liable to a penalty of not more than Fifty pounds, provided that the said sub-section (2) shall not apply to a motor car used as aforesaid on any highway or portion thereof specified by Order in Council published in the Government Gazette and on such days and during such hours as are specified in the Order:

And whereas the Central Victorian Car Club has requested that such an Order be made to enable motor car trials of speed to be conducted by the said Club on that portion of the road in the Shire of Talbot and Clunes hachured on the plan attached hereto on Sunday, the twelfth day of December, 1965:

Now therefore His Excellency the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, and in pursuance of the powers conferred by the Motor Car Act 1958, doth by this Order specify that portion of the road in the Shire of Talbot and Clunes hachured on the plan attached hereto as a highway in respect of which any motor car may, without being subject to the application of the said sub-section (2) of section 83 of the Motor Car Act, be used for purposes of trials of speed under the control of the said Central Victorian Car Club on Sunday, the twelfth day of December, 1965, between the hours of ten o'clock in the forenoon and five o'clock in the afternoon provided that the Officer-in-Charge of Police in attendance is satisfied that the highway is in a satisfactory condition for racing purposes and that adequate arrangements have been made for the safety of the public. Now therefore His Excellency the Governor of the State

Country Fire Authority Act 1958.

VARIATION OF SUMMER PERIOD IN RESPECT OF SPECIFIED PARTS OF THE COUNTRY AREAS OF VICTORIA.

WHEREAS by section 4 of the Country Fire Authority
Act 1958 it is enacted that the Chief Secretary of
Victoria, after consultation with the Minister of Forests,
may from time to time by declaration published in the
Government Gazette declare any period to be the summer
period in respect of the country area of Victoria, or any
specified part or parts thereof and, without affecting the
generality of the foregoing, may declare different periods
to be the summer period in respect of different parts of
the said country area:

And whereas by the said section it is further enacted that any declaration so published may be revoked, amended or varied by a subsequent declaration so published:

And whereas by declaration issued on the date stated in Schedule A annexed hereto, different summer periods expiring on the thirtieth day of April, 1966, were declared in respect of different parts of the country area of Victoria, including the parts of the said country area specified in Schedule B hereto:

And whereas the Chief Secretary and the Minister of Forests have consulted accordingly:

Now therefore I, the Chief Secretary of Victoria, do by this my declaration vary the aforesaid declaration by declaring that the summer period in respect of the parts of the country area of Victoria specified in Schedule B hereto shall end at midnight on the tenth day of December, 1965.
