MOTOR BOATING ACT 1961.

PROCLAMATION

STATE RIVERS AND WATER SUPPLY COMMISSION.

By-LAW No. 5485.—RATES—URBAN DISTRICTS.

THE State Rivers and Water Supply Commission, in pursuance and exercise of the powers conferred by the Water Act, doth hereby make the By-law following:—

1. The following Rates for the supply of water for domestic purposes are hereby made, and shall be levied upon the occupiers or owners of lands and tenements within the respective Urban Districts as set out hereunder:—

Lands or tenements in respect of which a notice has been given in accordance with the Eighth Schedule to the Water Act that a main pipe for the supply of water has been laid down—a rate of such amount in the pound of the annual municipal valuation of such lands or tenements as is set down in column 2 opposite the name of the respective Urban Districts in column 1 of the Schedule hereto: Provided that the total amount of the rate payable annually in respect of any such lands or tenements (other than land on which there is no building) shall be not less than the sum set down in column 3 opposite the name of the respective Urban Districts in column 1 of the said Schedule, and in respect of any such lands or tenements on which there is no building shall be not less than the sum set down in column 4 opposite the name of the respective Urban Districts in column 1 of the said Schedule.

2. Such rates are made and shall be levied for the period beginning with the 1st day of July, 1964, and ending with the 30th day of June, 1965, and shall be payable on the 15th day of January, 1965, at the office of the State Rivers and Water Supply Commission, at the place set down in column 5 opposite the name of the respective Urban Districts in column 1 of the said Schedule.

3. Interest will be chargeable on all Rates remaining unpaid for a period of four months from the date such Rates become payable.

4. Such person or persons as the State Rivers and Water Supply Commission may from time to time appoint for that purpose shall be and is hereby authorized to demand, receive, collect, and recover the said rates.

WARRNAMBOOL SEWERAGE AUTHORITY.

BY-LAW No. 4.

WARRNAMBOOL Sewerage Authority (declared by order of the Governor in Council published in the *Government Gazette* on the 16th day of August, One thousand nine hundred and sixty-three, page 2522, to be an authority for the purpose of the *Public Authorities Marks Act 1958*), pursuant to and in exercise of the powers and authorities conferred upon it by the said *Public Authorities Marks Act 1958*, and by the *Sewerage Districts Act 1958*, and pursuant to and in exercise and execution of any other powers and authorities in any wise enabling it in that behalf doth hereby make and prescribe the following By-law that is to say:—

1. In this By-law unless the context or subject-matter otherwise indicates—

“the said Act” means the *Public Authorities Marks Act 1958*, and all amendments and re-enactments thereof.

“the Authority” means the Warrnambool Sewerage Authority.

“Stamp or Mark” includes a stamp or mark on any article, materials or thing in question or on a seal, tag or label affixed or otherwise attached to or connected with the same or any container thereof.

“Works” means any works or operations for or in connexion with the carrying into effect of the purposes or objects of any provisions of the *Sewerage Districts Act 1958* or any amendments or re-enactments thereof or of any other Act relating to the Authority whether the same are constructed, maintained or carried out by the Authority or by any other person on behalf of or under agreement with the Authority or by permission or authority of or under the supervision, direction or control of the Authority.

2. The stamp or mark hereby prescribed and adopted by the Authority under the authority of the said Act shall be the letters “W.B.S.A.” (meaning the “Warrnambool Sewerage Authority”) for indicating that any articles, materials or things referred to in the said Act and in this By-law are duly tested, stamped, marked or authorized by the Authority.

3. The said stamp or mark shall be sealed, stamped, marked or impressed or be affixed by tag or label by the Authority alone by its officers duly authorized for the purpose upon the articles, materials or things to which the said Act applies set forth or described in the First Schedule hereto.

4. The articles, materials or things set forth or described in the First Schedule hereto shall be tested, stamped, marked or authorized by the Authority before use.

5. The use of the said stamp or mark by any other person other than a duly authorized officer of the Authority is prohibited.

6. Subject as hereinafter provided the sale or supply or the purchase or acquisition by any person to or from any other person of any of the above-mentioned articles, materials or things which—

(a) are stamped or marked otherwise than as hereby prescribed; or

(b) are not duly tested, stamped, marked or authorized as hereby prescribed; or

(c) comprises a component part not comprised in any such article, material or thing when stamped or marked—

is hereby prohibited within the Sewerage District of the Authority.

Provided always that it shall be lawful to supply and sell and to purchase and acquire and use any of the above-mentioned articles, materials and things which shall bear the prescribed stamp or mark of one of the several authorities named in the Second Schedule hereto and such other authority or authorities whose mark or marks the Authority may from time to time accept by Resolution and of which Resolution due publication shall have been made.

7. The fees for testing and for stamping or marking shall be—

(a) As to each of such articles, materials or things as are set forth in any of the Divisions 1 and 2 of the First Schedule hereto, the fee set opposite the same respectively, provided that in all cases there shall be a minimum fee of 1s. for one or more articles tested.

(b) As to any of the articles, materials or things described in Division 3 of the First Schedule, a fee calculated at the rate of 15s. per hour upon the time occupied in the testing thereof.

8. Any person guilty of any contravention of this By-law shall for every such offence be liable to a penalty not exceeding £50 in respect of any one such contravention provided however that nothing in this clause contained shall affect the liability of any such person to be prosecuted and punished under any other Act or at common law but he shall not be liable to be punished twice for the same offence.

(a) Regulating of the keeping of any animals and regulating or prohibiting of the keeping of any place which in the opinion of the Council may be offensive injurious to health or dangerous.

(b) Fixing the distance from any property boundary within which it shall be unlawful to keep any such place or animal.

(c) Regulating the keeping of animals and limiting the number of any such animals kept on any property.

IN pursuance of the powers conferred by the *Health Act 1958* and the *Local Government Act 1958*, and every other power thereunto it enabling in that behalf, the President, Councillors and Ratepayers of the Shire of Wodonga doth hereby order as follows:—

1. In this By-law unless inconsistent with the context or subject-matter:—

“Council” means the Council of the Shire of Wodonga.

“Horse” includes pony, gelding, stallion, mare, colt, foal, donkey, mule.

“Person” includes owner or occupier.

"Property" means any tenement or land in separate occupation.

"Built-up Area" means any property abutting on any street on which there is provision for lighting by means of street lamps extending to the point of the furthest such provision from the Council Chambers.

2. No person shall keep or cause or permit to be kept any horse on any property except in accordance with the following provisions:—
 - (a) The property shall have a minimum area of open space for the use of one horse of 2,000 square feet for the use of any greater number than one horse of 1,000 square feet in addition for each horse over the number one.
 - (b) A stable shall be provided to house such horse or horses that are kept on any property containing an area of one-half acre or less, by any person during the hours between sunset and sunrise and such stable shall be constructed in accordance with the Uniform Building Regulations, Victoria.
 - (c) No horse or horses shall be kept on any property within four feet of the side or rear boundaries of such property or within thirty feet of any dwelling.
 - (d) No horse or horses shall be kept on a corner allotment where rear boundary of such property is a side boundary of adjoining property.
3. The occupier of any property on which any horse is kept or housed shall cause the stable erected on such property and any yard appertaining to be thoroughly cleaned from time to time as often as may be required or necessary and shall keep or cause to be kept such stable and yard in a clean sanitary and tidy condition at all times and shall place all manure without delay in the manure bin provided in connection with every such stable.
4. No person shall keep or store or cause or permit to be kept or stored on any property where any horse is kept any food for consumption by horses unless such food is stored in vermin proof receptacles.
5. This By-law shall apply to and have operation throughout any Built-up Area within the Shire of Wodonga but shall not apply to any premises registered with the Council or Commission of Public Health as Cattle Sale Yards or Offensive Trade Premises under the provisions of the Health Act 1958, or the property occupied used or licensed by the Wodonga Show Society.

- (d) Authorizing the Council of the said Shire at the expense of the owner (the amount of which expense may be recovered by the Council in a Court of Petty Sessions as a civil debt recoverable summarily):—

1. To remove or lop trees, shrubs or hedges growing or being on private property so situate which are not removed or lopped as required by or under this By-law.
2. To reduce in height any portion of a fence which is not reduced in height as required by or under this By-law.

IN pursuance of the powers conferred by the Local Government Act 1958, and every other power it thereunto enabling, the President and Councillors and Ratepayers of the Shire of Woorayl order as follows:—

1. No person shall use any portion of any private property situated at the junction of any streets or roads which abut on or is within 10 feet from any such street or road for the growing of trees, shrubs or hedges, unless for a distance of 30 feet from such junction, each part of any such tree, shrub or hedge to be kept at a height not greater than 3 feet 6 inches.
2. The Owner of any private property situate at the junction of any streets or roads upon which property any trees, shrubs or hedges are growing abutting on or within 10 feet from such streets or roads shall, if such trees, shrubs or hedges be a greater height than 3 feet 6 inches, upon notice, in writing, under the hand of the Shire Secretary of the said Shire, and within the time therein specified, remove or lop or cause to be removed or lopped all trees, shrubs or hedges (whether planted before or after the commencement of the Local Government Act 1958) to such extent as may be necessary to bring such trees, shrubs or hedges into conformity with the requirements of the preceding clause hereof.
3. The Owner of any private property situate at the junction of any streets or roads upon which private property there is a fence within 30 feet from the junction of such streets or roads, shall, if such fence be of greater height than 3 feet 6 inches, upon notice in writing, under the hand of the Shire Secretary of the said Shire, and within the time therein specified, cause to be reduced to a height not exceeding 3 feet 6 inches any portion of such fence within 30 feet of the junction of such streets or roads.
4. Upon default being made by the Owner of private property situate at the junction of any streets or roads in complying with the terms of any notice under this By-law, the said Council may, by its Engineer or other authorized officer, enter upon such private property with a sufficient number of workmen and may remove or lop any trees, shrubs or hedges growing or being thereon which have not been removed or lopped as required by the notice, or reduce in height any portion of a fence which has not been reduced in height, as required by the notice, and the expenses incurred by the said Council in so doing shall be forthwith paid by the owner of such property to the said Council, and in default of such payment may be recovered by the said Council in a Court of Petty Sessions as a civil debt recoverable summarily.
5. This By-law shall apply to and have operation throughout the whole of the municipal district of the Shire of Woorayl.
