HAMILTON SEWERAGE AUTHORITY.

RATING BY-LAW NO. 8 FOR THE YEAR ENDING
30TH SEPTEMBER, 1965.

THE Hamilton Sewerage Authority, in pursuance and exercise of the powers conferred by the Sewerage Districts Acts, doth hereby make the following Rating By-law and numbered 8, that is to say:—

That the Hamilton Sewerage Authority doth hereby make and levy a Sewerage rate of Fourteen pence (14d.) in the pound, on the net annual value of all rateable sewered properties within its Sewerage District, but in no case shall the amount of sewerage rate payable annually be less than Seven pounds (£7) in respect of any rateable sewered property on which there is a building and Three pounds (£3) in respect of any rateable sewered property on which there is no building, and that such rate shall be made for the year ending 30th September, 1965, and shall be due and payable on 1st February, 1965.

Resolution for passing this By-law was agreed to by the said Authority at a Special Meeting on the 26th day of November, 1964, and confirmed on 17th day of December, 1964.

STRATHDOWNIE DRAINAGE TRUST.

RATING BY-LAW FOR 1965.

THE Strathdownie Drainage Trust, in pursuance and exercise of the powers conferred by the River Improvement Act 1958, doth hereby make the by-law following:—

1. The following rate, to be called the "Strathdownie Drainage Trust Drainage Rate", is hereby made and shall be levied upon the occupiers or owners of all properties within the Strathdownie Drainage District which are rateable to the Shire of Glenelg:—A rate of Six pence in the £1 on the net annual municipal value of all properties within the Strathdownie Drainage District, provided that the amount of rate payable in respect to any property shall not be less than One shilling.

2. Such rate is made and shall be levied for the period of twelve months commencing on the 1st day of January, 1965, and ending on the 31st day of December, 1965, and shall be due and payable at the office of the Trust at Casterton, on the 1st day of February, 1965.

3. Such person or persons as the Trust may from time to time appoint for that purpose shall be and are hereby authorized to demand, receive, collect and recover the said rate.

The foregoing By-law was passed by the Strathdownie Drainage Trust this 18th day of December, 1964.
