For the guidance of those attending the Levee, it will be appropriate, for those who wish to do so, to wear Honours, Decorations and Awards.

Private Entree Cards will admit recipients to the South Door of the Spring-street, Entrance at Parliament House at 9.30 a.m. All other citizens are requested to enter by the North Door of the Spring-street Entrance at 10.15 a.m.

It is particularly desired that gentlemen attending the Levee should provide themselves with a card on which should be printed or typed in capitals, or written in block letters, their styles of address for presentation, in order to facilitate announcement to His Excellency.

AREA OF LAND COMPRISED IN CERTAIN CLASSES DIMINISHED OR INCREASED.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the *Land Act 1958* it is amongst other things enacted that the Governor in Council may, by Proclamation to be published in the *Government Gazette*, at any time diminish or increase the area of land comprised in any of the classes mentioned in Part I., Division 1, Section 5, of the said *Land Act 1958*, but that the area of lands which may be sold by auction (Class 6), shall not be increased except as in certain cases in the said Act provided : Now therefore I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in accordance with the provisions of Sections 94 and 117 of the *Land Act 1958* aforesaid, do hereby diminish or increase (as the case may be) the areas of Crown lands comprised in Classes 7 and 6 of the classes mentioned in Section 5 of the *Land Act 1958* aforesaid, to the extent set forth in the subjoined Schedule (that is to say) :—

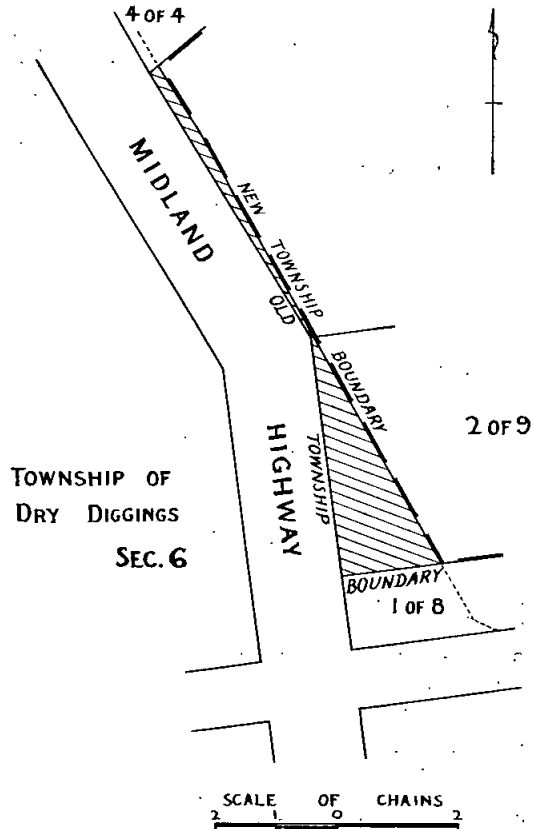

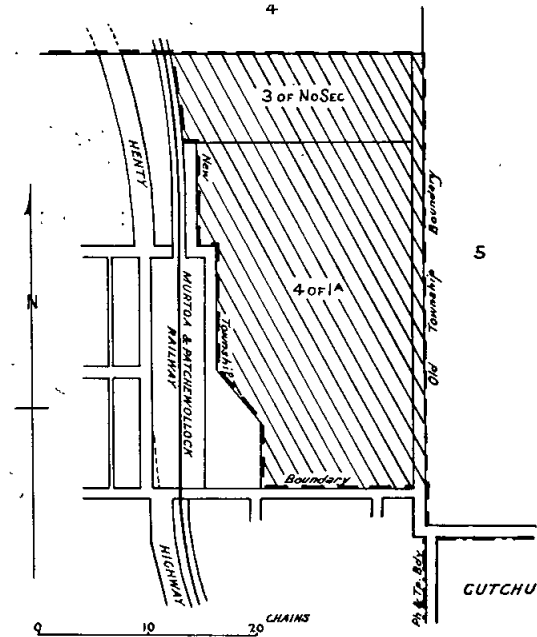

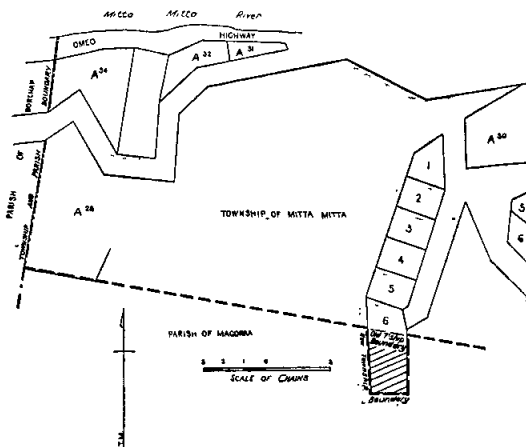

PUBLIC HIGHWAY.—CITY OF DONCASTER AND TEMPLESTOWE.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the Local Government Act 1958, as amended, Section 519 it is amongst other things enacted that it shall be lawful for the Governor in Council at any time and from time to time upon the request of the Council of any municipality by notice in the Government Gazette to proclaim any land reserved used or by purchase or exchange acquired for a street road highway thoroughfare bridge square court alley or right-of-way or any street road lane or passage made or laid out or proposed to be made or laid out on any land of which a plan of subdivision delineating that street road lane or passage has been sealed with the seal of the municipality under subdivision (3) of Division 9 of Part XIX of the Local Government Act 1958, as amended, or a corresponding previous enactment to be a public highway and that such land shall thereupon and thenceforth from the date of such proclamation become and be absolutely dedicated to the public as a public highway within the meaning of any law then or thereafter in force:

AND WHEREAS the Council of the City of Doncaster and Templestowe has requested that the land hereinafter mentioned, being a street road lane or passage made or laid out or proposed to be made or laid out on land of which a plan of subdivision delineating that street road lane or passage has been sealed with the seal of the municipality under subdivision (3) of Division 9 of Part XIX of the Local Government Act 1958, as amended, or a corresponding previous enactment, be so declared to be a public highway:

NOW THEREFORE I, the Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this Proclamation declare that Glendale Avenue coloured brown on Plan of Subdivision No. 19709 lodged in the Office of Titles, shall be a public highway within the meaning of the said Act.

DATE OF COMING INTO OPERATION OF SECTIONS 7 AND 10.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by an Act of Parliament of the State of Victoria passed in the fourteenth year of the reign of Her Majesty Queen Elizabeth II, intituled the Motor Car Act 1965, No. 7314, it is amongst other things enacted that the several provisions of the said Act shall come into operation on a day or the respective days to be fixed by Proclamation or successive Proclamations of the Governor in Council published in the Government Gazette:

AND WHEREAS by a Proclamation issued on the fourteenth day of December, One thousand nine hundred and sixty-five, Wednesday, the fifteenth day of December, One thousand nine hundred and sixty-five was fixed as the day on which Section 20 of the Motor Car Act 1965, shall come into operation:

AND WHEREAS by a Proclamation issued on the third day of May, One thousand nine hundred and sixty-six, Wednesday, the fourth day of May, One thousand nine hundred and sixty-six was fixed as the day on which Sections 1, 2, 4, 8, 9, 11, 12, 15 to 19 inclusive and 21 of the Motor Car Act 1965, shall come into operation:

AND WHEREAS by a Proclamation issued on the fifteenth day of June, One thousand nine hundred and sixty-six, Friday the first day of July, One thousand nine hundred and sixty-six was fixed as the day on which Sections 3, 5, 6, 13 and 14 of the Motor Car Act 1965 shall come into operation:

NOW THEREFORE I, the Governor of the State of Victoria, by and with the advice of the Executive Council of the said State, do by this my Proclamation fix Thursday, the eighth day of June, One thousand nine hundred and sixty-seven as the day on which Sections 7 and 10 of the Motor Car Act 1965, No. 7314, shall come into operation.

Bees Act 1966.

IMPORTATION, ETC., OF BEES, HONEY, HONEYCOMB OR APPLIANCES INTO VICTORIA.

PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by paragraph (c) of sub-section (1) of section 4 of the Bees Act 1966 it is provided, amongst other things, that the Governor in Council may by proclamation published in the *Government Gazette* prohibit either absolutely or subject to conditions the importation, introduction or bringing into the State either generally or from any other State or country or place of any bees, honey, honeycomb or other thing of any nature or kind whatsoever which in his opinion is likely to introduce any disease into the State or is likely to spread such disease:

NOW THEREFORE I, the Governor of the State of Victoria in the Commonwealth of Australia, being of the opinion that the importation, introduction or bringing into the State of Victoria of any bees, honey, honeycomb or appliances from any other State of the Commonwealth of Australia or from a Territory thereof is likely to introduce disease into the State of Victoria and by and with the advice of the Executive Council of the State of Victoria, do by this my proclamation hereby PROHIBIT, unless the conditions set out in the First Schedule hereto are complied with, the importation, introduction or bringing into the State of Victoria from any other State of the Commonwealth of Australia or from a Territory thereof any bees, honey, honeycomb or appliances.

FIRST SCHEDULE.

The conditions under which bees, honey, honeycomb or appliances may be imported, introduced or brought into the State of Victoria from any other State of the Commonwealth of Australia or from a Territory thereof are:—

The owner, agent or person in charge of bees, honey, honeycomb or appliances shall—

- (a) make a declaration, in duplicate, in the form or to the effect of the form set out in the Second Schedule hereto that to the best of his knowledge and belief—
 - (i) all the bees are healthy and have been free from disease or from contamination with disease during the three months prior to the proposed date of introduction into the State of Victoria;
 - (ii) all the honey or honeycomb is from an apiary which was free from disease at the time the honey or honeycomb was removed from the hives;
 - (iii) all the appliances are free from contamination with disease;
- (b) obtain a certificate, in duplicate, on the same forms from a Government Apiary Inspector or from a person authorized in that capacity in the State or Territory of origin that, after due enquiry, he has no reason to doubt the correctness of the declaration made; and
- (c) (i) forward the original of the declaration and certificate with the consignment;
- (ii) forward the duplicate thereof to the Apiary Inspector for the point of entry into the State of Victoria not less than twentyfour hours before the introduction of the consignment into the said State.

PROVIDED that in cases where bees, honey, honeycomb or appliances—

- (i) are all the property of a beekeeper registered in the State of Victoria in accordance with the provisions of section 12 of the said Act; and
- (ii) are taken to another State of the Commonwealth of Australia or to a Territory thereof for a period not exceeding three months and have not been within a radius of five miles of an area where American Foulbrood disease has occurred within the previous six months;

the bees, honey, honeycomb or appliances may be returned to the State of Victoria if the owner, agent or person in charge makes a declaration in accordance with paragraph (a) of this Schedule and forwards the declaration in accordance with paragraph (c) of this Schedule:

SECOND SCHEDULE.

Bees Act 1966.

DECLARATION BY OWNER, AGENT OR PERSON IN CHARGE OF BEES, HONEY, HONEYCOMB OR APPLIANCES TO BE IMPORTED, INTRODUCED OR BROUGHT INTO THE STATE OF VICTORIA FROM ANY OTHER STATE OF THE COMMONWEALTH OF AUSTRALIA OR FROM A TERRITORY THEREOF.

- (iii) all the appliances are free from contamination with disease.

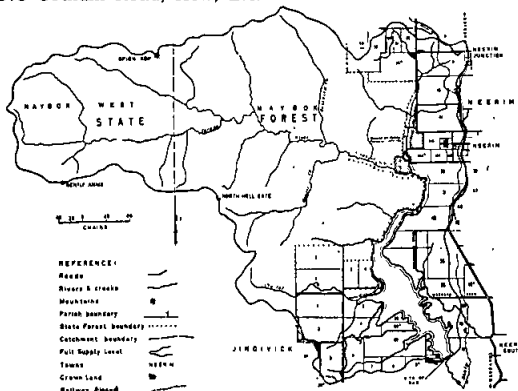

I, THE Governor of the State of Victoria in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State and in pursuance of the provisions contained in Section 22 of the *Soil Conservation and Land Utilization Act 1958* (No. 6372), do by this Proclamation define the water supply catchment area to be known as the Tarago River Water Supply Catchment.

The area to be proclaimed is that part of the Catchment of the Tarago River and its tributaries upstream of a dam to be constructed by the State Rivers and Water Supply Commission in a location defined as a line between Crown Allotment 9C, Parish of Jindivick and Crown Allotment 72, Parish of Neerim, County of Buln Buln.

The use of land within this catchment is subject to determination by the Soil Conservation Authority acting under the provisions of Section 23 (1) (a) of the *Soil Conservation and Land Utilization Act 1958* (No. 6372).

The area described is more particularly defined on plan No. 1950 hereunder, the original of which is lodged at the Head Office of the Soil Conservation Authority, 378 Cotham Road, Kew, E.4.

SWAN HILL WATERWORKS TRUST.
RATING BY-LAW FOR 1967.
