#### **PROCLAMATION**

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by Section 4 of the Motor Boating Act 1961 the Governor in Council, on the recommendation of an Authority having control over any Victorian waters may by Proclamation published in the Government Gazette set aside or prohibit or restrict the use of any specified part or parts of any waters under the control of the Authority for any specified class or classes of boating or similar activity and the Governor in Council may at any time by a Proclamation published in the Government Gazette revoke amend or vary any such Proclamation:

AND WHEREAS the State Electricity Commission of

AND WHEREAS the State Electricity Commission of Victoria was appointed on the fourteenth day of April, 1964, to be the Authority over the waters of the water storages comprised in the Kiewa Hydro-Electric Scheme:

AND WHEREAS by Proclamation made on the fourteenth day of April, 1964, certain prohibitions and rectrictions on the use of waters under the control of the said State Electricity Commission of Victoria for boating or similar activities were proclaimed:

NOW THEREFORE I, the Governor of the State of Victoria in the Commonwealth of Australia by and with the advice of the Executive Council of the said State and on the recommendation of the State Electricity Commission of Victoria do hereby amend the said Proclamation as follows:—

For sub-clauses (e) and (f) of Clause 2 there shall be substituted the following sub-clause:—

"(e) The use of the waters of the Regulating Pondages at Mount Beauty or Junction Dam is prohibited for all classes of boating at any time between the hours of sunset of one day and sunrise of the next day".

Given under my Hand and the Seal of the State of Victoria aforesaid, at Melbourne, this twenty-fourth day of December, in the year of our Lord One thousand nine hundred and sixty-eight, and in the seventeenth year of the reign of Her Majesty Queen Elizabeth II.

#### PROCLAMATION

WHEREAS by an Act of Parliament of the State of Victoria passed in the seventeenth year of the reign of Her Majesty Queen Elizabeth II., entitled the Police Assistance Compensation Act 1968, No. 7722, it is amongst other things enacted that the said Act shall come into operation on a day to be fixed by proclamation of the Governor in Council published in the Government Gazette:

NOW THEREFORE I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, do by this Proclamation fix Wednesday, the first day of January, One thousand nine hundred and sixty-nine, as the day on which the said Police Assistance Compensation Act 1968, No. 7722, shall come into operation.
