IN pursuance of the provisions of sub-section (3) of section 1 of the Weights and Measures (Amendment) Act 1968, I, the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, do, by this my Proclamation fix the 3rd day of February 1969 as the day on which all the provisions of the said Act except sections 2 and 6 shall come into operation.

PROCLAMATION EXTENDING THE OPERATION OF THE UNIFORM BUILDING REGULATIONS

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS Section 916 of the Local Government Act 1958, as amended, provides—inter alia—that the Government Gazette, at the request of the council of any municipality (not being a city or town) extend the operation of Part XLIX. of the said Act to the municipal district of such municipality or any part thereof.

AND WHEREAS by Proclamations published in the Government Gazette on the 3rd March 1947, 11th December 1957 and 25th October 1961, the operation of the said part was extended to parts of the municipal district of the Shire of Bairnsdale:

AND WHEREAS the Council of the Shire of Bairnsdale has requested that the operation of the said Part be extended to the balance of the municipal district of the Shire of Bairnsdale:

Shire of Bairnsdale:

NOW THEREFORE I, the Governor of the State of Victoria, by and with the advice of the Executive Council thereof, by this, my proclamation, do hereby extend the operation of the Regulations made under Part XLIX. of the Local Government Act 1958, as amended, to that part of the municipal district of the Shire of Bairnsdale to which they do not already apply, and order that the said Regulations shall come into operation in the above mentioned part of the municipal district of the Shire of Bairnsdale on publication of this Proclamation in the

Government Gazette, provided that Parts I. and II. of Chapter 8 thereof shall not be deemed to come into operation till the 29th April 1969, except in so far as may be necessary to enable the Council of the said municipality to make by-laws pursuant to the powers conferred by Part III. of the said Chapter and provided further that no such by-law shall come into operation before the 29th April 1969.







. STATE HIGHWAY MAROONDAH HIGHWAY SHIRE OF ALEXANDRA







Teaching Service Act 1958. TEACHING SERVICE (TEACHERS TRIBUNAL) REGULATIONS.

AMENDMENT No. 147 (T.T.1.).

THE Teachers Tribunal, in pursuance of the powers conferred by the Teaching Service Act 1958, hereby amends Regulation 4 of the Teaching Service (Teachers Tribunal) Regulations in the manner following, that is to say:-

REGULATION 4.

Rescind clause 3 and substitute therefor the following new clause:

- "3. In the Secondary Schools Division and in the Technical Schools Division an applicant shall not be transferred to a position of similar responsibility and salary range without having served the requisite periods as set out hereunder: -
 - (i) Assistant Class—three years:
 - (ii) Senior Assistant, Senior Teacher Classes-five years:

Provided that teachers may transfer to or from country areas after three years;

(iii) Principal and Special Classes-five years:

Provided that-

- (a) The Tribunal may approve the transfer of a principal of a Class C or D school located in a country area after a period of three years;
- (b) Transfer of a principal of a Class A school shall not be made by the Committee of Classifiers without the prior approval of the Tribunal.

For the purposes of this Regulation, the country area is defined as the area outside the cities of Ballarat, Bendigo and Geelong and outside the metropolitan area of Melbourne which is defined as the area bounded by a line which passes through and includes the following places:-

Laverton, Deer Park, Digger's Rest, Somerton, South Morang, Diamond Creek, Research, Warrandyte, Croydon, Fern Tree Gully, Dandenong, and Croydon, Carrum.'







A By-Law of the City of Doncaster and Templestowe made under the provisions of Sections 197 and 800 of the Local Government Act 1958 and Numbered 53 for the purpose of:—

- (i) Preserving public decency;
- (ii) Suppressing nuisances;

- (iii) Controlling and managing and preserving commons and public reserves of which the management is vested in Council;

 (iv) Imposing collecting and receiving charges or entrance fees for clubs associations or persons using or entering in or upon any land purchased or rented or otherwise provided or granted or given by any person to the Council of the Municipality of the City of Doncaster and Templestowe for the providing of pleasure grounds or places of public resort or public recreation and also for the regulation of the conduct of persons using or being upon or in such grounds or places.

(v) Preserving good order and decency in any building belonging to the municipality or under the control and management of the Council and preventing damage to such building or to the furniture or fittings thereof and regulating any meeting or gathering held therein.

PURSUANT to the powers conferred by the Local
Government Act 1958 and of any and every other
power it thereunto enabling the Mayor, Councillors and
Citizens of the City of Doncaster and Templestowe orders
as follows:—

- 1. This By-Law may be known as the Council Reserves By-Law.
- 2. In this By-Law, unless inconsistent with the context or subject matter;

 - "Management Committee" means the Honorary Committee, if any, appointed by the Council in accordance with Section 241a of the Local Government Act 1958 to manage the particular reserve.
 - "Reserve" means and includes each and all of the lands described in the FIRST SCHEDULE hereto which have been purchased rented or otherwise provided by the Council or been granted or given by some person for the providing of pleasure grounds or places of public resort or public recreation.
- 3. This By-Law shall apply to and have operation throughout the whole of the Municipal District of the City of Doncaster and Templestowe and shall come into operation and have effect immediately upon its publication in the Victoria Government Gazette.
- 4. No person other than members of the Council or of the Management Committee, Officers of the Council and employees of the Council or Management Committee on duty shall enter any reserve when a charge is made for admission thereto without first paying the fee charged unless authorised in writing by the Council or Management Committee.

All reserves shall be open to the public from sunrise to sunset on any day except on such days and at such hours as the Council or Management Committee may in the case of any reserve by resolution set aside as days upon which charges or entrance fees may be collected and received for Clubs Associations or persons using or entering in or upon such reserve.
