Metropolitan Fire Brigades Act 1958. METROPOLITAN FIRE BRIGADES BOARD— ENLARGEMENT OF FIRE DISTRICT.

#### PROCLAMATION

By His Excellency the Governor of the State of Victoria and its Dependencies in the Commonwealth of Australia, &c., &c., &c.

WHEREAS by the Metropolitan Fire Brigades Act 1958 it is amongst other things enacted that, on the request of the council of any municipal district and on receiving a certificate from the Metropolitan Fire Brigades Board that it is necessary so to do, the Governor in Council may by Proclamation published in the Government Gazette declare that that municipal district, or a specified part thereof, shall be added to and shall form part of the Metropolitan Fire District.

AND WHEREAS the council of the municipal district of the City of Doncaster and Templestowe has requested that the portions of such district enclosed within the boundaries set forth hereunder be added to and form part of the Metropolitan Fire District:

AND WHEREAS a certificate has been received from the Metropolitan Fire Brigades Board that it is desirable so

NOW THEREFORE I, the Governor of the State of Victoria, in the Commonwealth of Australia, by and with the advice of the Executive Council of the said State, and in pursuance of the provisions of Section 5 (1) of the said Act, do by this my Proclamation declare that the portion of the municipal district of the City of Doncaster and Templestowe enclosed within the boundaries set forth hereunder shall from the first day of February, 1969, be added to and form part of the Metropolitan Fire District, viz.:—

Area 1.

Commencing at the intersection of the 10 mile radius from the G.P.O. at the corner of Elizabeth and Bourke Streets in Melbourne with the River Yarra, thence: upstream by that river to Fitzsimons Lane, southerly by that lane to Porter Street, easterly by that street to Church Road, southerly by that road to Serpells Road, generally easterly by that road to Tuckers Road, southerly by that road to King Street, easterly by that street to Blackburn Road, southery by that road to Canopus Drive, easterly and north-easterly by that drive to Polaris Drive,

easterly and north-easterly by that drive to Polaris Drive,
southerly by that drive and Woorarra Avenue to
Bellevue Avenue,
generally westerly and north-westerly by the existing
boundary of the Metropolitan Fire District to
the point of commencement.

Area 2.

Commencing on the existing boundary of the Metropolitan Fire District at the easterly corner of Banool Quadrant and Woodhouse Road, easterly by Woodhouse Road to Old Warrandyte

easterly by Road,

north-easterly by that road to Springvale Road, southerly by that road to the existing boundary of the Metropolitan Fire District being the rear of allotments facing Pine Ridge on the north side, generally westerly and northerly by such existing boundary to the point of commencement.
